CHAPTER 645  
HOUSE BILL 974

1 AN ACT TO PROVIDE PENALTIES FOR FAILURE OF INTERSTATE COMMON  
2 CARRIERS TO REGISTER INTERSTATE OPERATING AUTHORITY FOR  
3 OPERATION ON THE HIGHWAYS OF NORTH CAROLINA.

5 The General Assembly of North Carolina do enact:

7 **Section 1.** G.S. 62-266 is hereby amended by adding new subsections (c) and(d) at  
8 the end thereof to read as follows:

9 "(c) Any person operating a common carrier motor vehicle in interstate commerce over  
10 the highways of this State without filing with the Utilities Commission a copy of its respective  
11 interstate authority and registering each vehicle operated in the State with the Utilities  
12 Commission in accordance with rules and regulations of the Utilities Commission shall be  
13 subject to a penalty of twenty-five (\$25.00) dollars, which shall be added to the registration  
14 fees provided in G.S. 62-300(18) and G.S. 62-300(13). and said penalty shall be collected with  
15 said registration fee from any carrier operating on the highways of North Carolina without  
16 registering his interstate authority by inspectors and investigators of the Utilities Commission  
17 in accordance with rules and regulations duly adopted by the Utilities Commission before said  
18 vehicle shall be permitted to operate further upon the highways of North Carolina."

19 "(d) No motor carrier shall operate or cause to be operated in interstate commerce in this  
20 State any vehicle until he has filed evidence of required insurance with the Utilities  
21 Commission and has been issued an identification stamp for such vehicle, which stamp must be  
22 attached to the approved Uniform Cab Card and carried in the vehicle at all times. The  
23 identification stamp herein provided for shall be issued on an annual basis as of January 1st  
24 each year and shall be valid through February 1st the next succeeding year. When any person is  
25 discovered in this State, operating a vehicle in violation of this Section, it shall be unlawful for  
26 anyone thereafter to operate said vehicle on the streets or highways of this State, except to  
27 remove it from the street or highway for purposes of parking or storing said vehicle until he  
28 shall pay to the Utilities Commission a penalty of twenty-five (\$25.00) dollars. Any person  
29 denying his liability for such penalty may pay the same under protest. He may apply to the  
30 Utilities Commission for a hearing, and said hearing will be granted before a member of the  
31 Commission or a Hearing Examiner within thirty (30) days after receipt of the request of such a  
32 hearing. If after said hearing the Commission determines that the person was not liable for the  
33 penalty, the amount collected shall be refunded to him. If after said hearing the Commission  
34 determines that the person was liable for said penalty, the person paying the penalty may bring  
35 an action in the Superior Court of Wake County against the Utilities Commission for refund of  
36 the penalty. No restraining order or injunction shall issue from any Court of the State to restrain  
37 or enjoin the collection of the penalty or to permit the operation of said vehicle without  
38 payment of the penalty prescribed herein."

39 **Sec. 2.** All laws and clauses of laws in conflict with the provisions of this Act are  
40 hereby repealed.

41 **Sec. 3.** This Act shall be in full force and effect from and after its ratification.
