18 19 Section 1. There is appropriated from the General Fund to United Tri-County Senior Citizens, Incorporated, \$5,000 for the 1989-90 fiscal year to supplement local funding of program activities.

- Sec. 2. There is appropriated from the General Fund to Harvey Gardens of Kinston, Inc., \$1,000 for the 1989-90 fiscal year for the continued improvement of a public park.
- Sec. 3. There is appropriated from the General Fund to the Pamlico County Board of County Commissioners \$2,500 for the 1989-90 fiscal year for the Pamlico County Boosters Club for athletic development.
- Sec. 4. There is appropriated from the General Fund to the Craven County Board of County Commissioners \$20,000 for the 1989-90 fiscal year to support various public projects.
- Sec. 5. There is appropriated from the General Fund to Big Brothers/Big Sisters of the Lower Neuse \$1,000 for the 1989-90 fiscal year to expand services of the program.
- Sec. 6. There is appropriated from the General Fund to Safe in Lenoir County, Inc., \$1,000 for the 1989-90 fiscal year to provide assistance to victims of domestic violence.

- Sec. 7. There is appropriated from the General Fund to the Lenoir County Historical Association, Inc., \$1,000 for the 1989-90 fiscal year for restoration of the Archbell House as a museum.
- Sec. 8. There is appropriated from the General Fund to the Eastern Minority Economic Development Corporation \$1,000 for the 1989-90 fiscal year for economic workshops for the development of small businesses.
- Sec. 9. There is appropriated from the General Fund to the Pelican Players \$2,000 for the 1989-90 fiscal year to help renovate an old theater for their Arts Program.
- Sec. 10. There is appropriated from the General Fund to the Vanceboro Community Organization, Incorporated, \$2,000 for operations of their public aid programs.
  - Sec. 11. There is appropriated from the General Fund to the Pamlico County Fireman's Association, Incorporated, \$2,000 for the 1989-90 fiscal year to purchase pagers for firemen.
- Sec. 12. There is appropriated from the General Fund to the New Bern -Craven County YMCA, Inc., \$5,000 for the 1989-90 fiscal year for capital improvements.
- 18 Sec. 13. There is appropriated from the General Fund to the Pamlico County 19 Board of County Commissioners \$10,000 for the 1989-90 fiscal year for assistance in 20 purchasing a van for the Senior Citizens Services Division of the county Recreation Department.
- 22 Sec. 14. There is appropriated from the General Fund to the Havelock 23 Communities Improvement Association \$2,000 to renovate the community building in 24 Harlowe Community.
