A BILL TO BE ENTITLED

2 AN ACT TO AMEND THE CHARTER OF THE CITY OF CHARLOTTE 3 PERTAINING TO FAIR HOUSING.

4 The General Assembly of North Carolina enacts:

5 Section 1. Section 6.151 of the Charter of the City of Charlotte, being 6 Chapter 713, Session Laws of 1965, as added by Chapter 390, Session Laws of 1979, 7 reads as rewritten:

8 "Sec. 6.151. Equal Housing. (a) The City Council shall have the power to adopt ordinances prohibiting discrimination on the basis of race, color, sex, religion, 9 handicap, familial status, or national origin in real estate transactions. Such ordinances 10 may regulate or prohibit any act, practice, activity or procedure related, directly or 11 indirectly, to the sale or rental of public or private housing, which affects or may tend to 12 affect the availability or desirability of housing on an equal basis to all persons; may 13 provide that violations constitute a criminal offense; may subject the offender to civil 14 penalties; and may provide that the City may enforce the ordinances by application to 15 the Superior Court Division of the General Court of Justice for appropriate legal and 16 equitable remedies, including but not limited to, mandatory and prohibitory injunctions 17 and orders of abatement, attorney's fees and punitive damages, and the court shall have 18 19 jurisdiction to grant such remedies. 20 The City Council also shall have the power to amend any ordinance adopted (b)

21 <u>pursuant to the provisions contained in subsection (a) of this section to ensure that such</u> 22 ordinance remains substantially equivalent to the federal Fair Housing Act (41 USCS §§

1	3601, et seq.). Any ordinance enacted pursuant to Section 6.151(a) prohibiting
2	discrimination on the basis of familial status shall not apply to housing for older
3	persons, as defined in the federal Fair Housing Act (41 USCS §§ 3601, et seq.)."
4	Sec. 2. Section 6.155 of the Charter of the City of Charlotte, being Chapter
5	713, Session Laws of 1965 as added by Chapter 390, Session Laws of 1979, reads as
6	rewritten:
7	"Sec. 6.155. Committee meetings. The City Council may provide that the statutory
8	provisions relating to meetings of governmental bodies, presently embodied in Article
9	<u>33B-33C</u> of Chapter 143 of the General Statutes, shall not apply to the activity of any
10	committee authorized to enforce the ordinance, to the extent that said committee is
11	receiving a complaint or conducting an investigation, discovery, or conciliation
12	pertaining to a complaint filed pursuant to the ordinance."
13	Sec. 3. This act is effective upon ratification.
