1 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE  
2 1989 GENERAL ASSEMBLY TO MEET IN 1990, AND LIMITING THE  
3 SUBJECTS THAT MAY BE CONSIDERED IN THAT SESSION.

4 Be it resolved by the House of Representatives, the Senate concurring:

5 Section 1. At 5:00 p.m. on Saturday, July 15, 1989, the Senate and the House  
6 of Representatives shall adjourn to reconvene at noon on Thursday, June 7, 1990.  
7 During that session only the following matters may be considered:

8 (1) Bills directly affecting the State budget for fiscal year 1990-91,  
9 provided that no appropriations bill may be filed for introduction in  
10 the Senate or introduced in the House after June 21, 1990, provided  
11 further that no member may introduce more than five appropriations  
12 bills under the provisions of this subdivision.

13 (2) Bills introduced in 1989 and favorably acted upon in the house in  
14 which introduced during calendar year 1989, and not disposed of in the  
15 other house during calendar year 1989 by tabling, unfavorable  
16 committee report, indefinite postponement, or failure to pass any  
17 reading, whether or not the rules of either house would have prevented  
18 them from being considered because they passed in the first house  
19 after May 11, 1989.

20 (3) Bills implementing the recommendations of study commissions  
21 authorized or directed to report to the 1990 Session, except that no  
22 constitutional amendment so recommended shall be considered;  
23 provided that any bills authorized by this subdivision must be filed for

1 introduction in the Senate or introduced in the House no later than 5:00  
2 p.m. on Wednesday, June 13, 1990.

3 (4) Any local bill filed for introduction in the Senate or introduced in the  
4 House by 5:00 p.m., on Thursday, June 14, 1990, and accompanied by  
5 a certificate signed by the principal sponsor stating that no public  
6 hearing will be required or asked for by a member on the bill, the bill  
7 is noncontroversial, and the bill is approved for introduction by each  
8 member of the Senate and House whose district includes the local area  
9 to which the bill applies.

10 (5) Selection or confirmation of members of State boards and  
11 commissions as required by law, including the filling of vacancies of  
12 positions for which the appointees were elected by the General  
13 Assembly upon recommendation of the President of the Senate,  
14 President Pro Tempore of the Senate, or Speaker of the House.

15 (6) Any matter authorized by joint resolution passed during the 1990  
16 Session by two-thirds majority of the members of the House of  
17 Representatives present and voting and by two-thirds majority of the  
18 members of the Senate present and voting. Provided that no  
19 memorializing, celebration, commendation or commemoration  
20 resolutions may be authorized. A bill or resolution filed in either  
21 house under the provisions of this subsection shall have a copy of the  
22 ratified enabling resolution attached to the jacket.

23 (7) Any bills affecting any State or local pension or retirement system.

24 (8) Joint resolutions, House resolutions, and Senate resolutions pertaining  
25 to Section 5(10) of Article III of the Constitution of North Carolina.

26 Sec. 2. The President of the Senate and the Speaker of the House may jointly  
27 authorize appropriate committees or subcommittees of their respective houses to meet  
28 during the interim between sessions to review matters related to the State budget or any  
29 other matter as they deem appropriate for the 1990-91 biennium and to prepare reports,  
30 including revised budgets, for consideration at the 1990 Session.

31 Sec. 3. This resolution is effective upon ratification.
