2	AN ACT TO AUTHORIZE THE BOARD OF NURSING TO ESTABLISH A
3	NURSES AIDES REGISTRY.
4	The General Assembly of North Carolina enacts:
5	Section 1. Chapter 90 of the General Statutes is amended by adding a new
6	Article to read:
7	"ARTICLE 9C.
8	<u>''NURSES AIDES REGISTRY ACT.</u>
9	" <u>§ 90-171.55. Nurses Aides Registry.</u>
10	The Board of Nursing, established pursuant to G.S. 90-171.21, shall establish a
11	Nurses Aides Registry for persons functioning as nurses aides regardless of title. The
12	Board shall consider those Level I nurses aides employed in State licensed or
13	Medicare/Medicaid certified nursing facilities who meet applicable State and federal
14	registry requirements as adopted by the North Carolina Medical Care Commission as
15	having fulfilled the training and registry requirements of the Board, except for the fee
16	requirements prescribed by this subdivision. The Board may charge a fee of five dollars
17	(\$5.00) for each registry applicant. The Board shall adopt rules to ensure that whenever

- 1 possible, the fee is collected through the employer or prospective employer of the
- 2 registry applicant. Fees collected may be used by the Board in administering the
- 3 registry. The Board's authority granted by this Article shall not conflict with the
- 4 <u>authority of the Medical Care Commission.</u>"
- 5 Sec. 2. This act shall become effective July 1, 1989.
