2	AN ACT TO INCORPORATE CAROLINA SHORES VILLAGE, SUBJECT TO A
3	REFERENDUM.
4	The General Assembly of North Carolina enacts:
5	Section 1. A Charter for Carolina Shores Village is enacted to read:
6	"CHARTER
7	"CAROLINA SHORES VILLAGE
8	"CHAPTER I.
9	"INCORPORATION.
10	"Sec. 1.1. Incorporation and corporate powers. The inhabitants of Carolina Shores
11	Village are a body corporate and politic under the name Carolina Shores Village. Under
12	that name they shall have all the powers, duties, rights, privileges and immunities
13	conferred and imposed upon cities by the general law of North Carolina.
14	By such name they may purchase and hold, for the purpose of its governmental
15	welfare and improvement, all such estate, real and personal, as may be deemed
16	necessary therefore; or may from time to time sell, dispose of and invest the same, as
17	may be deemed advisable by the village as provided by law.
18	"CHAPTER II.
19	"BOUNDARIES.
20 21	"Sec. 2.1. Boundaries. Until modified in accordance with law, the boundaries of Carolina Shores Village are the following area of Brunswick County:

# "CHAPTER III. "GOVERNING BODY.

- "Sec. 3.1. Village Council. The governing body of Carolina Shores Village is the Village Council, which has seven members including the Mayor.
- "Sec. 3.2. Election. The qualified voters of the entire Village elect the members of the Council.
- "Sec. 3.3. Terms of office. In 1989, seven members of the Council shall be elected. The four persons receiving the highest numbers of votes shall be elected to four-year terms, and the three persons receiving the next highest numbers of votes shall be elected to two-year terms. In 1991 and quadrennially thereafter, three persons shall be elected to four-year terms. In 1993 and quadrennially thereafter, four persons shall be elected for four-year terms.
- "Sec. 3.4. Mayor. At its organizational meeting after each election, the Council shall elect from its membership a Mayor to serve a two-year term.

## "CHAPTER IV.

### "FORM OF ELECTION.

"Sec. 4.1. The Council shall be elected on the nonpartisan plurality basis provided by G.S. 163-292.

# "CHAPTER V. "ADMINISTRATION.

"Sec. 5.1. The Village shall operate under the Council-Manager Plan as provided by Part 2 of Article 7 of Chapter 160A of the General Statutes.

# "CHAPTER VI. "MISCELLANEOUS.

"Sec. 6.1. Zoning. Any zoning ordinance adopted by the Village shall have restrictions equal to or greater than those contained in deeds for homesites, acreage estates, and patio homes in Carolina Shores on the date this Charter was ratified by the General Assembly. This Charter does not change the validity of any declarations of restrictions on homesites, acreage estates, and patio home lots."

Sec. 2. From the date of approval of this Charter until the organizational meeting after the 1989 municipal election, the Village Council shall consist of the seven persons serving on the Carolina Shores Property Owners Association Board on the date of ratification of this Charter. After taking their oath of office, they shall elect from among themselves a Mayor. Any vacancies on the Council prior to the organizational meeting after the 1989 municipal election shall be filled by the Council.

Sec. 3. Interim budget. The Village Council may adopt a budget ordinance for the 1988-89 and 1989-90 fiscal years, following their qualification for office,

- without having to comply with the budget preparation and adoption timetable set out in the Local Government Budget and Fiscal Control Act, but may not levy property taxes for the 1988-89 fiscal year. For the budget adopted for fiscal year 1989-90, property taxes may be paid at par within 90 days of adoption of the budget ordinance, and thereafter according to the schedule in G.S. 105-360 as if the taxes had been due on September 1, 1989.
  - Sec. 4. (a) The Brunswick County Board of Elections shall conduct an election within 30 days after the effective date of this section for the purpose of submission to the qualified voters of the area described in Section 2.1 of the Charter of Carolina Shores Village, the question of whether or not such area shall be incorporated as Carolina Shores Village. Registration for the election shall be conducted in accordance with G.S. 163-288.2.
    - (b) In the election, the question on the ballot shall be:
      - "[] FOR Incorporation of Carolina Shores Village
      - [] AGAINST Incorporation of Carolina Shores Village".
  - Sec. 5. In such election, if a majority of the votes cast are not cast "FOR Incorporation of Carolina Shores Village", then Sections 1 through 3 of this act shall have no force and effect.
  - Sec. 6. In such election, if a majority of the votes cast shall be cast "FOR Incorporation of Carolina Shores Village" then Sections 1 through 3 of this act shall become effective on the date that the Brunswick County Board of Elections determines the result of the election.
  - Sec. 7. Section 4 of this act is effective upon ratification. The remaining sections of this act are effective as provided in Sections 5 and 6.
