A BILL TO BE ENTITLED

1 AN ACT TO DELAY THE EFFECTIVE DATE OF THE MERGER OF THE
2 SALISBURY CITY AND ROWAN COUNTY SCHOOL ADMINISTRATIVE
3 UNITS SO AS TO ALLOW A NEWLY ELECTED BOARD TO MAKE
4 DECISIONS ON THE OPERATION OF THE SCHOOLS AFTER MERGER.

6 The General Assembly of North Carolina enacts:

7 Section 1. A PLAN FOR MERGER OF THE ROWAN COUNTY
8 SCHOOLS AND THE SALISBURY CITY SCHOOLS, as approved by the State Board
9 of Education on December 3, 1987, and filed with the Secretary of State in accordance
10 with G.S. 115C-67 on December 21, 1987, and as amended by Chapter 890, Session
11 Laws of 1987, is amended as provided in Section 2 of this act.

12 Sec. 2. A PLAN FOR MERGER OF THE ROWAN COUNTY SCHOOLS
13 AND THE SALISBURY CITY SCHOOLS is amended by delaying the effective date
14 of the merger of the Salisbury City School Administrative Unit and the Rowan County
15 School Administrative Unit from July 1, 1989, to July 1, 1991. Article I.B. is amended
16 by deleting "July 1, 1989", and substituting "July 1, 1991". Article IV.D. is amended by
17 changing "July 1, 1989", to "July 1, 1991".

18 Sec. 3. Nothing in the Plan of Merger prevents the Rowan-Salisbury Board of
19 Education after it takes office on the first Monday in December of 1990 from
20 establishing and altering attendance zones as is provided by general law.

21 Sec. 4. From July 1, 1989, through the first Monday in December of 1990, the
22 Interim Board of Education shall be ex officio the Board of Education of the Salisbury
23 City School Administrative Unit and the Rowan County School Administrative Unit.
24 From the first Monday in December of 1990 through June 30, 1991, the Rowan-

1 Salisbury Board of Education elected under A PLAN FOR MERGER OF THE
2 ROWAN COUNTY SCHOOLS AND THE SALISBURY CITY SCHOOLS shall be ex
3 officio the Board of Education of the Salisbury City School Administrative Unit and the
4 Rowan County School Administrative Unit.

5 Sec. 5. This act is effective upon ratification.
