A BILL TO BE ENTITLED
AN ACT TO CLARIFY THE AUTHORITY OF LAW ENFORCEMENT OFFICERS
TO ARREST WITHOUT A WARRANT FOR CERTAIN MISDEMEANORS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 15A-401(b) reads as rewritten:

"(b) Arrest by Officer Without a Warrant. –

(1) Offense in Presence of Officer. – An officer may arrest without a warrant any person who the officer has probable cause to believe has committed a criminal offense in the officer's presence.

(2) Offense Out of Presence of Officer. – An officer may arrest without a warrant any person who the officer has probable cause to believe:

a. Has committed a felony; or

b. Has committed a misdemeanor, and:

1. Will not be apprehended unless immediately arrested, or

2. May cause physical injury to himself or others, or damage to property unless immediately arrested; or

c. Has committed a misdemeanor under G.S. ~~14-72.1~~ 14-72.1, 14-33(b)(2), or 14-134.3.

~~(3) Subdivision (1) and (2) shall apply to arrest for assault, for communicating a threat, or for domestic criminal trespass, already committed or being committed by a person who is the spouse or~~

1 ~~former spouse of the alleged victim or by a person with whom the~~
2 ~~alleged victim is living or has lived as if married."~~
3 Sec. 2. This act shall become effective October 1, 1989.
