2	AN ACT TO PROVIDE FOR THE ASSIGNMENT TO THE STATE OF THE RIGHT		
3	TO THIRD PARTY BENEFITS IN DEPARTMENT OF HUMAN RESOURCES		
4	MEDICAL PAYMENT PROGRAMS.		
5	The General Assembly of North Carolina enacts:		
6	Section 1. G.S. Article 1 of Chapter 130A of the General Statutes is amended		
7	by adding a new section to read:		
8	"§ 130A-13. Application for eligibility for Department medical payment program		
9	<u>constitutes assignment to the State of right to third party benefits.</u>		
10	(a) Notwithstanding any other provisions of law, by applying for financial		
11	eligibility for any Department medical payment program administered under this		
12	Chapter, the recipient patient or responsible party for the recipient patient shall be		
13	deemed to have made an assignment to the State of the right to third party benefits,		
14	contractual or otherwise, to which he may be entitled to the extent of the amount of the		
15	Department's payment on behalf of the recipient patient. Any attorney retained by the		
16	recipient patient shall be compensated for his services in accordance with the following		
17	schedule and in the following order of priority from any amount of such third party		
18	benefits obtained on behalf of the recipient by settlement, with judgment against, or		
19	otherwise from a third party:		
20	(1) First to the payment of any court costs taxed by the judgment;		
21	(2) Second to the payment of the fee of the attorney representing the		
22	beneficiary making the settlement or obtaining the judgment, but this

1		fee shall not exceed one-third of the amount obtained or recovered to	
2		which the right of subrogation applies;	
3	<u>(3)</u>	Third to the payment of the amount of assistance received by the	
4		beneficiary as prorated with other claims against the amount obtained	
5		or received from the third party to which the right of subrogation	
6		applies, but the amount shall not exceed one-third of the amount	
7		obtained or recovered to which the right of subrogation applies; and	
8	<u>(4)</u>	Fourth to the payment of any amount remaining to the beneficiary or	
9		his personal representative.	
10	The United States and the State of North Carolina shall be entitled to shares in each		
11	net recovery under this section. Their shares shall be promptly paid under this section		
12	and their propo	rtionate parts of such sum shall be determined in accordance with the	
13	matching formu	alas in use during the period for which assistance was paid to the	
14	recipient.		
15	<u>(b)</u> The I	Department shall establish a third party resources collection unit that is	
16	adequate to ensu	re collection of third party resources.	
17	(c) The C	Commission may adopt rules necessary to implement this section."
