A BILL TO BE ENTITLED

AN ACT TO MAKE A TECHNICAL CORRECTION IN A LIST OF POSITION CLASSIFICATIONS OF THE OFFICE OF ADMINISTRATIVE HEARINGS.

The General Assembly of North Carolina enacts:

Section 1. Section 13 of Chapter 1111, Session Laws of 1987, reads as rewritten:

"Sec. 13. Subsections (a) and (b) of Section 68 of Chapter 830 of the 1987 Session Laws are reenacted, except that the following changes are made in the number, classifications, and grades of employees of the Office of Administrative Hearings:
