HOUSE BILL 11

Short Title: Pay Scrap Tire Tax on All New Tires.

1 A BILL TO BE ENTITLED
2 AN ACT TO APPLY THE TIRE TAX, USED TO PAY FOR THE DISPOSAL OF
3 SCRAP TIRES, TO NEW TIRES FOR ROAD CONSTRUCTION EQUIPMENT
4 AND OTHER NEW VEHICLE TIRES.

5 The General Assembly of North Carolina enacts:

6 Section 1. Chapter 105 of the General Statutes is amended by adding a new
7 Article to read:

8 **"ARTICLE 5B.**

9 **"SCRAP TIRE DISPOSAL TAX.**

10 **"§ 105-187.15. Definitions.**

11 The definitions in G.S. 105-164.3 apply to this Article, except that the term 'sale'
12 does not include lease or rental, and the following definitions apply to this Article:

13 (1) Scrap tire. A tire that is no longer suitable for its original, intended
14 purpose because of wear, damage, or defect.

15 (2) Tire. A continuous solid or pneumatic rubber covering encircling a
16 wheel.

17 **"§ 105-187.16. Tax imposed.**

18 A privilege tax is imposed on a tire retailer at the rate of one percent (1%) of the
19 sales price of each new tire sold at retail by the retailer. A privilege tax is imposed on a
20 tire retailer and on a tire wholesale merchant at the rate of one percent (1%) of the sales
21 price of each new tire sold by the retailer or wholesale merchant to a wholesale
22 merchant or retailer for placement on a vehicle offered for sale, lease, or rental by the
23 retailer or wholesale merchant. An excise tax is imposed on a new tire purchased for
24 storage, use, or consumption in this State or for placement in this State on a vehicle

1 offered for sale, lease, or rental at the rate of one percent (1%) of the cost price of the
2 tire. These taxes are in addition to all other taxes.

3 **"§ 105-187.17. Administration.**

4 The privilege tax this Article imposes on a tire retailer who sells new tires at retail is
5 an additional State sales tax and the excise tax this Article imposes on the storage, use,
6 or consumption of a new tire in this State is an additional State use tax. Except as
7 otherwise provided in this Article, these taxes shall be collected and administered in the
8 same manner as the State sales and use taxes imposed by Article 5 of this Chapter. As
9 under Article 5 of this Chapter, the additional State sales tax paid when a new tire is
10 sold is a credit against the additional State use tax imposed on the storage, use, or
11 consumption of the same tire.

12 The privilege tax this Article imposes on a tire retailer and on a tire wholesale
13 merchant who sell new tires for placement in this State on a vehicle offered for sale,
14 lease, or rental is a tax on the wholesale sale of the tires. This tax and the excise tax this
15 Article imposes on a new tire purchased for placement in this State on a vehicle offered
16 for sale, lease, or rental shall, to the extent practical, be collected and administered as if
17 they were additional State sales and use taxes. The privilege tax paid when a new tire is
18 sold for placement on a vehicle offered for sale, lease, or rental is a credit against the
19 use tax imposed on the purchase of the same tire for placement in this State on a vehicle
20 offered for sale, lease, or rental.

21 **"§ 105-187.18. Exemptions.**

22 The taxes imposed by this Article do not apply to:

- 23 (1) Aircraft tires.
- 24 (2) Bicycle tires and other tires for vehicles propelled by human power.
- 25 (3) Recapped tires.

26 The exemptions in G.S. 105-164.13 and the refunds allowed in G.S. 105-164.14 do not
27 apply to the taxes imposed by this Article.

28 **"§ 105-187.19. Use of tax proceeds.**

29 The Secretary shall distribute the taxes collected under this Article, less the cost of
30 collecting the taxes, in accordance with this section. The Secretary shall retain the cost
31 of collection as reimbursement to the Department of Revenue.

32 Each quarter, the Secretary shall credit ten percent (10%) of the net tax proceeds to
33 the Solid Waste Management Trust Fund and shall distribute ninety percent (90%) of
34 the net tax proceeds among the counties on a per capita basis according to the most
35 recent annual population estimates certified to the Secretary by the Office of State
36 Budget and Management. A county may use funds distributed to it under this section
37 only as provided in G.S. 130A-309.54."

38 Sec. 2. G.S. 130A-309.53(7) reads as rewritten:

39 "(7) 'Tire' means a continuous solid or pneumatic rubber covering encircling
40 that encircles the wheel of a motor vehicle as defined in G.S. 20-4.01(23).
41 and is subject to the tax imposed by Article 5B of Chapter 105."

42 Sec. 3. G.S. 130A-309.54 reads as rewritten:

43 **"§ 130A-309.54. Scrap tire disposal fee-Use of scrap tire tax proceeds.**

1 (a) A fee is imposed on the privilege of selling or using new motor vehicle tires
2 in this State. This fee is in addition to all other taxes and fees imposed.

3 (b) The definitions in G.S. 105-164.3 apply to G.S. 130A-309.55 and G.S. 130A-
4 309.56, except the term "sale" does not include a lease or rental.

5 (c) The fees imposed by G.S. 130A-55 and G.S. 130A-56 shall be used by each Article
6 5B of Chapter 105 imposes a tax on new tires to provide funds for the disposal of scrap
7 tires. A county may use proceeds of the tax distributed to it under that Article only for
8 the disposal of scrap tires pursuant to the provisions of this Part or for the abatement of
9 a nuisance pursuant to G.S. 130A-309.60.

10 (d) The fees imposed by G.S. 130A-55 and G.S. 130A-56 shall be administered
11 in the same manner as the tax imposed by Article 5 of Chapter 105 of the General
12 Statutes. All other provisions of Article 5 and Article 9 of Chapter 105 of the General
13 Statutes shall apply to this Part to the extent they are not inconsistent with the
14 provisions of this Part. However, the exemptions and exclusions under G.S. 105-164.13
15 and G.S. 105-164.3(19) and the lower rates of tax imposed have no effect on the scrap
16 tire disposal fee. The refund provisions under G.S. 105-164.14(a), (b), and (c) do not
17 apply. The Secretary of Revenue may administer, enforce, collect and distribute the
18 scrap tire disposal fee. The administrative interpretation made by the Secretary of
19 Revenue with respect to the North Carolina Sales and Use Tax Act applies to the scrap
20 tire disposal fee to the extent they are not inconsistent."

21 Sec. 4. G.S. 130A-309.55 and G.S. 130A-309.56 are repealed.

22 Sec. 5. G.S. 130A-309.58(e) reads as rewritten:

23 "(e) A county shall provide, directly or by contract with another unit of local
24 government or private entity, at least one site for scrap tire disposal for that county. The
25 unit of local government or contracting party may charge a disposal fee for the disposal
26 of in-county scrap tires and such disposal fees shall be assessed only to the extent that the
27 cost per tire of disposal exceeds the scrap tire disposal fees amount received by the county
28 under G.S. 105-187.19 during the preceding 12-month period, divided by the number of
29 tires disposed of within the county according to the tire disposal procedures during that
30 period. The unit of local government or contracting party may charge a disposal fee for
31 the disposal of scrap tires ~~from tire manufacturers, retreaders not engaged in the retail sale of~~
32 ~~new tires, and any others subject to the scrap tire disposal fee, regardless of where such scrap~~
33 ~~tires originated, and such regardless of whether a tax has been paid on the tire under~~
34 Article 5B of Chapter 105 and regardless of the tire's place of origin. The disposal fees
35 shall may not exceed the cost of disposal for such tires. disposal. The unit of local
36 government or contracting party also may charge a disposal fee for the disposal of out-
37 of-county and out-of-State scrap tires at the county's site."

38 Sec. 6. This act becomes effective July 1, 1991.
