A BILL TO BE ENTITLED

AN ACT TO MAKE VARIOUS TECHNICAL AMENDMENTS TO THE GENERAL
STATUTES AS RECOMMENDED BY THE GENERAL STATUTES
COMMISSION.

The General Assembly of North Carolina enacts:

Section 1. G.S. 1-54.1 reads as rewritten:

"§ 1-54.1. Nine months.

Within nine months an action contesting the validity of any zoning ordinance or amendment thereto adopted by a county under Part 3 of Article 18 of Chapter 153A of the General Statutes or other applicable law or adopted by a city under ~~Article~~ Chapter 160A of the General Statutes or other applicable law."

Sec. 2. G.S. 7A-450.1 reads as rewritten:

"§ 7A-450.1. Responsibility for payment by certain fiduciaries.

It is the intent of the General Assembly that, whenever possible, if an attorney or guardian ad litem is appointed pursuant to G.S. 7A-451 for a person who is less than 18 years old or who is at least 18 years old but remains dependent on and domiciled with a parent or guardian, the parent, guardian, or any trustee in possession of funds or property for the benefit of the person, shall reimburse the State for the attorney or guardian ad litem fees, pursuant to the procedures established in G.S. 7A-450.2 and G.S. 7A-450.3. This section shall not apply in any case in which the person for whom an attorney or guardian ad litem is appointed prevails."

Sec. 3. G.S. 7A-517(6) reads as rewritten:

"(6) Chief Court Counselor. – The person responsible for administration and supervision of juvenile intake, probation, and aftercare in each

1 ~~judicial~~ judicial district, operating under the supervision of the
2 Administrator for Juvenile Services."

3 Sec. 4. G.S. 7A-649(7) reads as rewritten:

4 "(7) Impose confinement on an intermittent basis in an approved detention
5 facility. Confinement shall be limited to not more than five 24-hour
6 periods, the timing of which is determined by the court in its
7 discretion.

10 Confinement in ~~either~~ such a case shall be completed within a period of
11 90 days from the date of disposition;".

12 Sec. 5. G.S. 14-234(d1) reads as rewritten:

13 "(d1) The first sentence of subsection (a) shall not apply to (i) any elected official
14 or person appointed to fill an elective office of a village, town, or city having a
15 population of no more than 7,500 according to the most recent official federal census,
16 (ii) any elected official or person appointed to fill an elective office of a county within
17 which there is located no village, town, or city with a population of more than 7,500
18 according to the most recent official federal census, (iii) any elected official or person
19 appointed to fill an elective office on a city board of education in a city having a
20 population of no more than 7,500 according to the most recent official federal census,
21 (iv) any elected official or person appointed to fill an elective office as a member of a
22 county board of education in a county within which there is located no village, town or
23 city with a population of more than 7,500 according to the most recent official federal
24 census, (v) any physician, pharmacist, dentist, optometrist, veterinarian, or nurse
25 appointed to a county social services board, local health board, or ~~area mental health~~
26 ~~board~~ area mental health, developmental disabilities, and substance abuse board serving
27 one or more counties within which there is located no village, town, or city with a
28 population of more than 7,500 according to the most recent official federal census, and
29 (vi) any member of the board of directors of a public hospital if:

- 30 (1) The undertaking or contract or series of undertakings or contracts
31 between the village, town, city, county, county social services board,
32 county or city board of education, local health board or area mental
33 health, ~~mental retardation,~~ developmental disabilities, and substance
34 abuse board, or public hospital and one of its officials is approved by
35 specific resolution of the governing body adopted in an open and
36 public meeting, and recorded in its minutes and the amount does not
37 exceed ten thousand dollars (\$10,000) for medically related services
38 and fifteen thousand dollars (\$15,000) for other goods or services
39 within a 12-month period; and
40 (2) The official entering into the contract or undertaking with the unit or
41 agency does not in his official capacity participate in any way or vote;
42 and

- 1 (3) The total annual amount of undertakings or contracts with each
2 official, shall be specifically noted in the audited annual financial
3 statement of the village, town, city, or county; and
- 4 (4) The governing board of any village, town, city, county, county social
5 services board, county or city board of education, local health board,
6 area mental health, ~~mental retardation,~~ developmental disabilities, and
7 substance abuse board, or public hospital which undertakes or
8 contracts with any of the officials of their governmental unit shall post
9 in a conspicuous place in its village, town, or city hall, or courthouse,
10 as the case may be, a list of all such officials with whom such
11 undertakings or contracts have been made, briefly describing the
12 subject matter of the undertakings or contracts and showing their total
13 amounts; this list shall cover the preceding 12 months and shall be
14 brought up-to-date at least quarterly."

15 Sec. 6. G.S. 14-250 reads as rewritten:

16 **"§ 14-250. Publicly owned vehicle to be marked.**

17 It shall be the duty of the executive head of every department of the State
18 government, and of any county, or of any institution or agency of the State, to have
19 painted on every motor vehicle owned by the State, or by any county, or by any
20 institution or agency of the State, a statement that such car belongs to the State or to
21 some county, or institution or agency of the State. Provided, however, that no
22 automobile used by any county officer or county official for the purpose of transporting,
23 apprehending or arresting persons charged with violations of the laws of the State of
24 North Carolina, shall be required to be lettered. Provided, further, that in lieu of the
25 above method of marking motor vehicles owned by any agency or department of the
26 State government, it shall be deemed a compliance with the law if such vehicles have
27 imprinted on the license tags thereof, above the license number, the words 'State Owned'
28 and that such vehicles have affixed to the front thereof a plate with the statement 'State
29 Owned'. Provided, further, that in lieu of the above method of marking vehicles owned
30 by any county, it shall be deemed a compliance with the law if such vehicles have
31 painted or affixed on the side thereof a circle not less than eight inches in diameter
32 showing a replica of the seal of such county. Provided, further, that no county-owned
33 motor vehicle used for transporting day or residential facility clients of area mental
34 health, ~~mental retardation,~~ developmental disabilities, and substance abuse authorities
35 established under Article 4 of Chapter 122C of the General Statutes shall be required to
36 be lettered; provided, further, notwithstanding this sentence, each vehicle shall bear the
37 distinctive permanent registration plate pursuant to G.S. 20-84. Provided, further, that
38 in lieu of the above method of marking vehicles owned by the State and permanently
39 assigned to members of the Council of State, it shall be deemed a compliance with the
40 law if such vehicles have imprinted on the license tags thereof the license number
41 assigned to the appropriate member of the Council of State pursuant to G.S. 20-81(4); a
42 member of the Council of State shall not be assessed any registration fee if he elects to
43 have a State-owned motor vehicle assigned to him designated by his official plate
44 number.

1 The General Assembly may authorize exemptions from the provisions of this section
2 for each fiscal year. Each agency shall submit requests for private tags to the Division of
3 Motor Fleet Management of the Department of Administration. The Division shall
4 report the requests to the Appropriations Committees of the General Assembly by June
5 1."

6 Sec. 7. G.S. 14-277(e) reads as rewritten:

7 "(e) It shall be unlawful for any person other than duly authorized employees of a
8 county, a municipality or the State of North Carolina, including but not limited to, the
9 Department of Social Services, Health, Area Mental Health, ~~Mental Retardation,~~
10 Developmental Disabilities, and Substance Abuse Authority or Building Inspector to
11 represent to any person that they are duly authorized employees of a county, a
12 municipality or the State of North Carolina or one of the above-enumerated departments
13 and acting upon such representation to perform any act, make any investigation, seek
14 access to otherwise confidential information, perform any duty of said office, gain
15 access to any place not otherwise open to the public, or seek to be afforded any
16 privilege which would otherwise not be afforded to such person except for such false
17 representation or make any attempt to do any of said enumerated acts. Any person,
18 corporation, or business association violating the provisions of this section shall be
19 guilty of a misdemeanor and upon conviction may be fined or imprisoned at the
20 discretion of the court."

21 Sec. 8. G.S. 15A-406(a) reads as rewritten:

22 "(a) For purposes of this section, 'federal law enforcement officer' means any of
23 the following persons who are employed as full-time law enforcement officers by the
24 federal government and who are authorized to carry firearms in the performance of their
25 duties:

- 26 (1) United States Secret Service special agents;
- 27 (2) Federal Bureau of Investigation special agents;
- 28 (3) Bureau of Alcohol, Tobacco and Firearms special agents;
- 29 (4) United States Naval Investigative Service special agents;
- 30 (5) Drug Enforcement Administration special agents;
- 31 (6) United States Customs Service officers;
- 32 (7) United States Postal Service inspectors;
- 33 (8) Internal Revenue Service special agents;
- 34 (9) United States Marshals Service marshals and deputies;
- 35 (10) United States Forest Service officers;
- 36 (11) National Park Service officers; and
- 37 (12) ~~U.S. United States Fish and Wildlife Service Service officers.~~"

38 Sec. 9. G.S. 17E-10(b) reads as rewritten:

39 "(b) The Commission may authorize grants pursuant to this section and consistent
40 with the powers conferred upon the Commission under ~~Section 6 of this Chapter. G.S.~~
41 17E-6."

42 Sec. 10. G.S. 20-7(n) reads as rewritten:

43 "(n) Every drivers license issued by the Division shall bear thereon the
44 distinguishing number assigned to the licensee and color photograph of the licensee of a

1 size approved by the Commissioner and shall contain the name, age, residence address
2 and a brief description of the licensee, who, for the purpose of identification and as a
3 condition precedent to the validity of the license, immediately upon receipt thereof,
4 shall endorse his or her regular signature in ink upon the same in the space provided for
5 that purpose unless a facsimile of his or her signature appears thereon; provided the
6 requirement that a color photograph of the licensee appear on the license may be waived
7 by the Commissioner upon satisfactory proof that the taking of such photograph violates
8 the religious convictions of the licensee. ~~Drivers'~~ Drivers licenses shall be issued with
9 differing color photographic backgrounds according to the licensee's age at time of
10 issuance for the following age groups:

11 (1) Persons who have not attained the age of 21 years.

12 (2) Persons who have attained the age of 21 years.

13 The Division of ~~Motor Vehicles~~ shall determine the different colors to be used. Such
14 license shall be carried by the licensee at all times while engaged in the operation of a
15 motor vehicle."

16 Sec. 11. G.S. 20-84 reads as rewritten:

17 "**§ 20-84. Vehicles owned by State, municipalities or orphanages, etc.; certain**
18 **vehicles operated by the local chapters of American National Red Cross.**

19 The Division upon proper proof being filed with it that any motor vehicle for which
20 registration is herein required is owned by the State or any department thereof, or by
21 any county, township, city or town, or by any board of education, or by any orphanage
22 or civil air patrol, or incorporated emergency rescue squad, or incorporated REACT
23 ('Radio Emergency Association of Citizen Teams') Team, or for any motor vehicle
24 involved exclusively in the support of a disaster relief effort, shall collect six dollars
25 (\$6.00) for the registration of such motor vehicles, but shall not collect any fee for
26 application for certificate of title in the name of the State or any department thereof, or
27 by any county, township, city or town, or by any board of education or orphanage:
28 Provided, that the term 'owned' shall be construed to mean that such motor vehicle is the
29 actual property of the State or some department thereof or of the county, township, city
30 or town, or of the board of education, and no motor vehicle which is the property of any
31 officer or employee of any department named herein shall be construed as being 'owned'
32 by such department. Provided, that the above exemptions from registration fees shall
33 also apply to any church-owned bus used exclusively for transporting children and
34 parents to Sunday school and church services and for no other purpose.

35 In lieu of the annual six dollars (\$6.00) registration provided for in this section, the
36 Division may for the license year 1950 and thereafter provide for a permanent
37 registration of the vehicles described in this section and issue permanent registration
38 plates for such vehicles. The permanent registration plates issued pursuant to this
39 paragraph shall be of a distinctive color and shall bear thereon the word 'permanent.'
40 Such plates may be transferred as provided in G.S. 20-78 to a replacement vehicle of the
41 same classification. For the permanent registration and issuance of permanent
42 registration plates provided for in this paragraph, the Division shall collect a fee of six
43 dollars (\$6.00) for each vehicle so registered and licensed.

1 The provisions of this section are hereby made applicable to vehicles owned by a
2 rural fire department, agency or association.

3 The Division of Motor Vehicles shall issue to the North Carolina Tuberculosis
4 Association, Incorporated, or any local chapter or association of said corporation, for a
5 fee of six dollars (\$6.00) for each plate a permanent registration plate which need not be
6 thereafter renewed for each motor vehicle in the form of a mobile X-ray unit which is
7 owned by said North Carolina Tuberculosis Association, Incorporated, or any local
8 chapter or local association thereof and operated exclusively in this State for the
9 purpose of diagnosis, treatment and discovery of tuberculosis. The initial six dollars
10 (\$6.00) fee required by this section and for this purpose shall be in full payment of the
11 permanent registration plates issued for such vehicle operated as a mobile X-ray unit,
12 and such plates need not thereafter be renewed, and such plates may be transferred as
13 provided in G.S. 20-78 to replacement vehicles to be used for the purposes above
14 described and for which the plates were originally issued.

15 The Division of Motor Vehicles shall issue to the American National Red Cross,
16 upon application of any local chapter thereof and payment of a fee of six dollars (\$6.00)
17 for each plate, a permanent registration plate, which need not be thereafter renewed, for
18 all disaster vans, bloodmobiles, handivans, and such sedans and station wagons as are
19 used for emergency or disaster work, and operated by a local chapter in this State in the
20 business of the American National Red Cross. Such plates may be transferred as
21 provided in G.S. 20-78 to a replacement vehicle to be used for the purposes above
22 described and for which the plates were originally issued. In the event of transfer of
23 ownership to any other person, firm or corporation, or transfer or reassignment of any
24 vehicle bearing such registration plate to any chapter or association of the American
25 National Red Cross in any other state, territory or country, the registration plate
26 assigned to such vehicle shall be surrendered to the Division of Motor Vehicles.

27 In lieu of all other registration requirements, the Commissioner shall each year
28 assign to the State Highway Patrol, upon payment of six dollars (\$6.00) per registration
29 plate, a sufficient number of regular registration plates of the same letter prefix and in
30 numerical sequence beginning with number 100 to meet the requirements of the State
31 Highway Patrol for use on Division vehicles assigned to the State Highway Patrol. The
32 commander of the Patrol shall, when such plates are assigned, issue to each member of
33 the State Highway Patrol a registration plate for use upon the Division vehicle assigned
34 to him pursuant to G.S. 20-190 and assign a registration plate to each Division service
35 vehicle operated by the Patrol. An index of such assignments of registration plates shall
36 be kept at each State Highway Patrol radio station and a copy thereof shall be furnished
37 to the registration division of the Division. Information as to the individual assignments
38 of such registration plates shall be made available to the public upon request to the same
39 extent and in the same manner as regular registration information. The commander,
40 when necessary, may reassign registration plates provided that such reassignment shall
41 be made to appear upon the index required herein within 20 days after such
42 reassignment.

43 The Division of Motor Vehicles shall, upon appropriate certification of financial
44 responsibility, issue to sheltered workshops recognized or approved by the Division of

1 Vocational Rehabilitation Services and to public and nonprofit agencies or
2 organizations which provide transportation for or operate programs subject to and
3 approved in accordance with standards adopted by the Commission ~~on~~ for Mental
4 Health, ~~Mental Retardation~~ Developmental Disabilities, and Substance Abuse Services of
5 the Department of Human Resources upon application and payment of a fee of six
6 dollars (\$6.00) for each plate, a permanent registration plate for vehicles registered to
7 and operated by such agencies. The initial six dollars (\$6.00) fee required by this section
8 and for this purpose shall be in full payment of the permanent registration plate issued
9 for such vehicle operated by a sheltered workshop and such plates need not thereafter be
10 renewed, and such plates may be transferred as provided in G.S. 20-78 to a replacement
11 vehicle to be used by the sheltered workshop designated on the registration card.

12 On and after January 1, 1972, permanent registration plates used on all vehicles
13 owned by the State of North Carolina or a department thereof shall be of a distinctive
14 color and design which shall be readily distinguishable from all other permanent
15 registration plates issued pursuant to this section or G.S. 20-84.1. For the purpose of
16 carrying out the intent of this paragraph, all vehicles owned by the State of North
17 Carolina or a department thereof in operation as of October 1, 1971, and bearing a
18 permanent registration shall be reregistered during the months of October, November
19 and December, 1971, and upon reregistration, registration plates issued for such
20 vehicles shall be of a distinctive color and design as provided for hereinabove."

21 Sec. 12. G.S. 20-179.2 reads as rewritten:

22 **"§ 20-179.2. Alcohol and drug education traffic school programs; guidelines and**
23 **implementation by Commission for Mental Health, ~~Mental Retardation~~**
24 **Developmental Disabilities, and Substance Abuse Services; approval of**
25 **Department of Human Resources; fees.**

26 (a) The Commission for Mental Health, ~~Mental Retardation~~ Developmental
27 Disabilities, and Substance Abuse Services shall establish standards and guidelines for
28 the curriculum and operation of local alcohol and drug education traffic school
29 programs. The Department shall oversee the development of a statewide system of
30 schools and shall insure that schools are available in all localities of the State as soon as
31 is practicable.

32 (1) to (4) Recodified as subsections (c) to (f) of this section by Session
33 Laws 1983, c. 435, s. 30.

34 (b) Repealed by Session Laws 1983, c. 435, s. 30.

35 (c) A fee of one hundred dollars (\$100.00) shall be paid by all persons enrolling
36 in an alcohol and drug education traffic school program established pursuant to this
37 section. That fee must be paid to an official designated for that purpose and at a time
38 and place specified by the Area Mental Health, ~~Mental Retardation~~ Developmental
39 Disabilities, and Substance Abuse Authority providing the course of instruction in
40 which the person is enrolled, except that if the clerk of court in the county in which the
41 person is convicted agrees to collect the fees, the clerk shall collect all fees for persons
42 convicted in that county. The clerk shall pay the fees collected to the Area Mental
43 Health, ~~Mental Retardation~~ Developmental Disabilities, and Substance Abuse Authority
44 for the catchment area where the clerk is located regardless of the location where the

1 defendant attends the alcohol and drug education traffic school and that authority shall
2 distribute the funds in accordance with the rules and regulations of the Department. The
3 fee must be paid in full within two weeks from the date school attendance is ordered as
4 a condition of probation, unless the court, upon a showing of hardship by the person,
5 allows the person additional time to pay the fee. If the person enrolling in the school
6 demonstrates to the satisfaction of the court that ordered him to enroll in the school that
7 he is unable to pay and his inability to pay is not willful, the court may excuse him from
8 paying the fee.

9 (d) The Department of Human Resources shall have the authority to approve
10 programs to be implemented by Area Mental Health, ~~Mental Retardation~~ Developmental
11 Disabilities, and Substance Abuse Authorities. Area Mental Health, ~~Mental Retardation~~
12 Developmental Disabilities, and Substance Abuse Authorities may subcontract for the
13 delivery of alcohol and drug education traffic school program services. The Department
14 shall have the authority to approve budgets and contracts with public and private
15 governmental and nongovernmental bodies for the operation of such schools.

16 (d1) The Department of Human Resources may approve programs offered in
17 another state if they are substantially similar to programs approved in this State, and if
18 that state recognizes North Carolina programs for similar purposes. The defendant shall
19 be responsible for the fees at the approved program.

20 (e) Fees collected under this section and retained by Area Mental Health, ~~Mental~~
21 ~~Retardation~~, Developmental Disabilities, and Substance Abuse Authorities shall be
22 placed in a nonreverting fund. That fund must be used, as necessary, for the operation,
23 evaluation and administration of alcohol and drug education traffic school programs;
24 excess funds may only be used to fund other drug or alcohol programs. Area authorities
25 shall remit five percent (5%) of each fee collected to the Department of Human
26 Resources on a monthly basis. Fees received by the Department as required by this
27 section may only be used in supporting, evaluating, and administering alcohol and drug
28 education traffic schools, and any excess funds will revert to the General Fund.

29 (f) All fees collected by the Area Mental Health, ~~Mental Retardation~~,
30 Developmental Disabilities, and Substance Abuse Authorities under the authority of this
31 section may not be used in any manner to match other State funds or to be included in
32 any computation for State formula-funded allocations."

33 Sec. 13. G.S. 25-8-317 reads as rewritten:

34 "**§ 25-8-317. Creditors' rights.**

35 (1) Subject to the exceptions in subsections (3) and (4) of this section, no
36 attachment or levy upon a certificated security or any share or other interest represented
37 thereby which is outstanding is valid until the security is actually seized by the officer
38 making the attachment or levy, but a certificated security which has been surrendered to
39 the issuer may be reached by a creditor by legal process at the issuer's chief executive
40 office in the United States.

41 (2) An ~~uncertificated~~ ~~[uncertificated]~~ uncertificated security registered in the name of
42 the debtor may not be reached by a creditor except by legal process at the issuer's chief
43 executive office in the United States.

1 (3) The interest of a debtor in a certificated security that is in the possession of a
2 secured party not a financial intermediary or in an uncertificated security registered in
3 the name of a secured party not a financial intermediary (or in the name of a nominee of
4 the secured party) may be reached by a creditor by legal process upon the secured party.

5 (4) The interest of a debtor in a certificated security that is in the possession of or
6 registered in the name of a financial intermediary or in an uncertificated security
7 registered in the name of a financial intermediary may be reached by a creditor by legal
8 process upon the financial intermediary on whose books the interest of the debtor
9 appears.

10 (5) Unless otherwise provided by law, a creditor's lien upon the interest of a
11 debtor in a security obtained pursuant to subsection (3) or (4) of this section is not a
12 restraint on the transfer of the security, free of the lien, to a third party for new value;
13 but in the event of a transfer, the lien applies to the proceeds of the transfer in the hands
14 of the secured party or financial intermediary, subject to any claims having priority.

15 (6) A creditor whose debtor is the owner of a security is entitled to aid from
16 courts of appropriate jurisdiction, by injunction or otherwise, in reaching the security or
17 in satisfying the claim by means allowed at law or in equity in regard to property that
18 cannot readily be reached by ordinary legal process."

19 Sec. 14. G.S. 47-41.02(a) reads as rewritten:

20 "(a) The following forms of probate for deeds and other conveyances executed by
21 a corporation shall also be deemed sufficient but shall not exclude other forms of
22 probate ~~with [which]~~ which would be deemed sufficient in law."

23 Sec. 15. G.S. 49-12.1(d) reads as rewritten:

24 "(d) The effect of legitimation under this section shall be ~~[the]~~ the same as
25 provided by G.S. 49-11."

26 Sec. 16. G.S. 63A-9(l) reads as rewritten:

27 "(l) Bonds and notes and their transfer, including any profit made on ~~the~~ their
28 sale, are exempt from all State, county, and municipal taxation or assessment, direct or
29 indirect, general or special, whether imposed for the purpose of general revenue or
30 otherwise, excluding inheritance and gift taxes. The interest on bonds and notes is not
31 subject to taxation as income, and the bonds and notes are not subject to taxation when
32 constituting a part of the surplus of any bank, trust company, or other corporation."

33 Sec. 17. G.S. 66-64 reads as rewritten:

34 "**§ 66-64. Violation a misdemeanor.**

35 Any person violating the provisions of this Article, including the ~~make~~ making of
36 any false statement in the affidavit required under G.S. 66-62, shall be guilty of a
37 misdemeanor and, upon conviction, be fined or imprisoned, or both, in the discretion of
38 the court."

39 Sec. 18. G.S. 66-68(b) reads as rewritten:

40 "(b) If the owner is an individual or a partnership, the certificate must be signed
41 and duly acknowledged by the individual owner, or by each general partner. If the
42 owner is a corporation, it must be signed in the name of the corporation and duly
43 acknowledged as provided by ~~G.S. 47-41.~~ G.S. 47-41.01 or G.S. 47-41.02."

44 Sec. 19. G.S. 66-224(b) reads as rewritten:

1 "(b) The contract shall be accompanied by a completed form in duplicate,
2 captioned 'NOTICE OF CANCELLATION', which shall be attached to the contract and
3 easily detachable, and which shall contain in ~~an~~^{at} at least 10-point boldface type the
4 following statement:

5 **'NOTICE OF CANCELLATION**

6
7 YOU MAY CANCEL THIS CONTRACT, WITHOUT ANY
8 PENALTY OR OBLIGATION, AT ANY TIME PRIOR TO MIDNIGHT
9 OF THE THIRD BUSINESS DAY AFTER THE DATE THE

22 (f) Emergency Acquisition Where Funds Not Immediately Available. – If funds
23 or contributions for the acquisition of needed historic property are not available, the
24 Governor and Council of State may, upon the recommendation of the Secretary of
25 Cultural Resources and approval of the North Carolina Historical Commission, allocate
26 from the Contingency and Emergency Fund an amount sufficient to acquire an option
27 on the property or properties, which option shall continue until 90 days after the
28 adjournment sine die of the next General Assembly. Upon recommendation of the
29 Secretary and approval of the Historical Commission, the Governor and Council of
30 State may allocate funds from the Contingency and Emergency Fund for the immediate
31 acquisition, preservation, restoration, or operation of historically, archaeologically,
32 architecturally, or culturally important properties. All funds hereinafter appropriated to
33 purchase, restore, maintain, develop, or operate historic or archaeological or other
34 important property shall be administered subject to the provisions of Article 1 of
35 Chapter 143 of the General Statutes unless the statute making the appropriation shall in
36 specific and express terms provide otherwise.

37 (g) Power to Acquire Property by Condemnation. – In the event that a property
38 which has been found by the Department of Cultural Resources to be important for
39 public ownership or assistance is in danger of being sold, used, or neglected to such an
40 extent that its historical or cultural importance will be destroyed or seriously impaired,
41 or that the property is otherwise in danger of destruction or serious impairment, the
42 Department of Cultural Resources, after receiving the approval of the North Carolina
43 Historical Commission and of the Governor and Council of State, may acquire the
44 historic property or any interest therein by condemnation under the ~~provision of Article 2~~

1 ~~of Chapter 40 of the General Statutes of North Carolina.~~ provisions of Chapter 40A of the
2 General Statutes. The Department of Cultural Resources, upon finding that destruction
3 or serious impairment of the value of the property is imminent, shall file with the
4 Governor and Council of State a report on the importance of the property and the
5 desirability of ownership of the property, or the ownership of an interest therein, by the
6 State of North Carolina. Upon giving their approval, the Governor and Council of State
7 shall cause to have filed such approval with the clerk of the superior court in the county
8 or counties where the property is situated. Until the approval is filed, the power of
9 condemnation may not be exercised. All condemnation proceedings shall be instituted
10 and prosecuted in the name of the State of North Carolina.

11 (h) Preservation and Custodial Care of State Capitol. – The rotunda, corridors,
12 and stairways of the first floor of the State Capitol and all portions of the second, third,
13 and loft floors of the said building shall be placed in the custody of the Department of
14 Cultural Resources; and the Department shall, subject to the availability of funds for the
15 purpose, care for and administer these areas for the edification of present and future
16 generations. The aforesaid areas shall be preserved as historic shrines and shall be
17 maintained insofar as practicable as they shall appear following the restoration of the
18 Capitol. The Department of Cultural Resources is authorized to deny the use of the
19 legislative chambers for meetings in order that they, with their historic furnishings, may
20 be better preserved for posterity; provided, however, that the General Assembly may
21 hold therein such sessions as it may by resolution deem proper.

22 The Department of Cultural Resources is hereby entrusted with the responsibilities
23 herein specified as being the agency with the experience best qualified to preserve and
24 administer historic properties in a suitable manner. However, for the purposes of
25 carrying out the provisions of this section, it is hereby directed that such cooperation
26 and assistance shall be made available to the said Department of Cultural Resources and
27 such labor supplied, as may be feasible, by the Department of Administration.

28 The offices and working areas of the first floor as well as all washrooms and the
29 exterior of the Capitol shall remain under the jurisdiction of the Department of
30 Administration: Provided, however, that the Department of Administration shall seek
31 the advice of the Department of Cultural Resources in matters relating to any alteration,
32 renovation, and furnishing of said offices and areas."
