A BILL TO BE ENTITLED  AN ACT TO CONTINUE THE LEGISLATIVE COMMISSION ON NURSING.  The General Assembly of North Carolina enacts:  Section 1. (a) The Legislative Commission on Nursing established for the 1989-91 fiscal biennium by Section 15 of Chapter 560 of the 1989 Session Laws, is continued for the 1991-93 fiscal biennium. The membership of the Commission shall be as follows:	
(1) Four members of the Senate appointed by the President Pro Tempore of the Senate;	
(2) Four members of the House of Representatives appointed by the Speaker of the House of Representatives; and	
(3) Six members of the general public: three appointed by the President Pro Tempore of the Senate and three appointed by the Speaker of the House of Representatives.	
(b) The Speaker of the House of Representatives and the President Pro Tempore of the Senate shall each appoint one member as cochairperson of the Commission.

11	Legislative Commission on Nursing shall be furnished by the General Assembly. The

13	services, if necessary, after obtaining authorizations from the Legislative Services
