A BILL TO BE ENTITLED

1 AN ACT TO PROVIDE FOR APPOINTMENT OF APPELLATE JUDGES BY THE  
2 GOVERNOR SUBJECT TO THE ADVICE AND CONSENT OF THE GENERAL  
3 ASSEMBLY, TO PROVIDE FOR THE RECONFIRMATION OF SITTING  
4 JUDGES BY THE GENERAL ASSEMBLY, AND TO PROVIDE FOR  
5 TRANSITIONAL AND OTHER PROVISIONS NECESSARY TO MOVE FROM  
6 AN ELECTIVE TO AN APPOINTIVE SYSTEM.  
7

8 The General Assembly of North Carolina enacts:

9 Section 1. Chapter 7A of the General Statutes is amended by adding a new  
10 Article to read:

11 **"ARTICLE 1A.**

12 **"APPOINTMENT, CONFIRMATION, AND RECONFIRMATION**  
13 **OF JUSTICES AND JUDGES.**

14 **"§ 7A-4.1. Appointment of Justices and Judges by Governor and confirmation by**  
15 **General Assembly.**

16 (a) When a new judgeship on the Supreme Court or Court of Appeals is created,  
17 the Governor shall within 120 days after the act creating the judgeship becomes law  
18 nominate a person from the list of nominees provided pursuant to G.S. 7A-4.2 to serve  
19 in the judgeship. Unless otherwise provided, the nominee shall be subject to  
20 confirmation by the Senate and the House of Representatives in the first regular session  
21 held in an odd-numbered year convening after the judgeship is created.

1       (b) When a vacancy occurs in the office of Chief Justice of the Supreme Court,  
2 Associate Justice of the Supreme Court, or Judge of the Court of Appeals, the Governor  
3 shall nominate a person to fill the vacancy from the list of nominees provided pursuant  
4 to G.S. 7A-4.2. If the vacancy occurs because the holder of the office indicates that he  
5 will not seek reconfirmation at the end of his term, the Governor shall submit his  
6 nomination to the General Assembly by March 1 of the year after that intention is made  
7 known. If the vacancy occurs for any other reason, the Governor shall submit his  
8 nomination to the General Assembly no later than 120 days after the vacancy is created.

9       (c) Nominees nominated pursuant to subsections (a) or (b) of this section are  
10 subject to confirmation as provided in this subsection. If the nomination is for a vacancy  
11 to be created at the end of a term and the nomination is the first such nomination for that  
12 office, the nomination shall be considered during the regular session held in the odd-  
13 numbered year in which the term of office of the judge vacating the office expires. All  
14 other nominations may be considered for confirmation at any regular or extra session of  
15 the General Assembly, but the nomination shall be considered no later than the first  
16 regular session conducted in an odd-numbered year after the nomination is submitted,  
17 unless it is submitted after April 1 during such a session. Nominations submitted during  
18 such a session and after April 1 may be considered by the General Assembly for  
19 confirmation in that session or any regular or extra session conducted thereafter, but the  
20 nomination shall be considered for confirmation no later than the first regular session in  
21 an odd-numbered year convening after the nomination is submitted. To be confirmed, a  
22 nominee shall receive a majority vote in the Senate and House of Representatives  
23 during the session in which the nomination is considered. Failure to receive a majority  
24 vote in both houses in a session in which a nomination is considered constitutes a failure  
25 to confirm and creates a vacancy in the office to be filled as provided by this section. A  
26 nominee confirmed by both the Senate and the House of Representatives shall be  
27 appointed by the Governor for a four-year term to begin on the next September 1 in an  
28 odd-numbered year. A person confirmed may begin service immediately upon being  
29 appointed, even though his term of office has not begun. For purposes of this  
30 subsection, a nomination is 'considered' if either house of the General Assembly votes  
31 on the nomination. For purposes of this subsection, a session ends when it adjourns or  
32 recesses for more than 30 days, or adjourns **sine die**, whichever comes first.

33       (d) In addition to any other lawful requirement for service as a Justice or Judge, a  
34 nominee, to be eligible to be nominated for Chief Justice, Associate Justice of the  
35 Supreme Court, or Judge of the Court of Appeals, shall be a registered voter in this  
36 State.

37       (e) The Governor, in making nominations, shall make reasonable efforts to  
38 ensure that his nominees are broadly representative of the people of this State.

39 **"§ 7A-4.2. Nomination procedure.**

40       (a) The Governor, in making a nomination to the office of Chief Justice, shall  
41 make the nomination from among a list of nominees as follows:

- 42           (1) All active trial judges in the General Court of Justice;
- 43           (2) All active Associate Justices and Court of Appeals Judges in the  
44           General Court of Justice;

1           (3) Not more than three nominees from each district bar, as defined by  
2 G.S. 84-19, who are residents of the district and who are members of  
3 that district bar; and

4           (4) Former justices and judges in the General Court of Justice, except  
5 those who (i) have been impeached, (ii) have been removed from  
6 office, (iii) have failed to be confirmed or reconfirmed pursuant to  
7 Article 1A of Chapter 7A of the General Statutes, or (iv) are serving as  
8 emergency or recalled justices or judges pursuant to Article 6 of  
9 Chapter 7A of the General Statutes.

10       (b) The Governor, in making a nomination to the office of Associate Justice,  
11 shall make the nomination from among a list of nominees as follows:

12           (1) All active trial judges in the General Court of Justice;

13           (2) All active Court of Appeals Judges in the General Court of Justice;

14           (3) Not more than three nominees from each district bar, as defined by  
15 G.S. 84-19, who are residents of the district and who are members of  
16 that district bar; and

17           (4) Former justices and judges in the General Court of Justice, except  
18 those who (i) have been impeached, (ii) have been removed from  
19 office, (iii) have failed to be confirmed or reconfirmed pursuant to  
20 Article 1A of Chapter 7A of the General Statutes, or (iv) are serving as  
21 emergency or recalled justices or judges pursuant to Article 6 of  
22 Chapter 7A of the General Statutes.

23       (c) The Governor, in making a nomination to the office of Judge of the Court of  
24 Appeals, shall make the nomination from among a list of nominees as follows:

25           (1) All active trial judges in the General Court of Justice;

26           (2) Not more than three nominees from each district bar, as defined by  
27 G.S. 84-19, who are residents of the district and who are members of  
28 that district bar; and

29           (3) Former justices and judges in the General Court of Justice, except  
30 those who (i) have been impeached, (ii) have been removed from  
31 office, (iii) have failed to be confirmed or reconfirmed pursuant to  
32 Article 1A of Chapter 7A of the General Statutes, or (iv) are serving as  
33 emergency or recalled justices or judges pursuant to Article 6 of  
34 Chapter 7A of the General Statutes.

35       (d) The nominees of the district bars shall be submitted within 30 days of the date  
36 the bar is notified of the occurrence of the vacancy. If any district bar fails to submit a  
37 nomination within the 30-day period, the Governor shall make the nomination and  
38 appointment from among the nominations received before the expiration of the 30-day  
39 period. The Governor shall notify each district bar in writing of the occurrence of a  
40 vacancy in the office of Chief Justice, Associate Justice, or Court of Appeals Judge. If  
41 the Governor is informed of the creation of a vacancy to become effective on a future  
42 date certain, he may notify the district bars before the effective date of the vacancy, and  
43 the 30-day period shall begin to run from the date of the notice.

1 **"§ 7A-4.3. Screening of potential nominees by Judicial Selection and Retention**  
2 **Commission.**

3 (a) Before submitting a nomination to the General Assembly to fill a new  
4 judgeship or a vacancy in an existing judgeship, the Governor shall first submit to the  
5 Judicial Selection and Retention Commission the names of at least three but not more  
6 than five people he is considering for the nomination. The Commission shall  
7 investigate the candidates' fitness for nomination, and shall report its findings to the  
8 Governor before the Governor may submit a nomination. If after receiving the findings  
9 of the Commission, the Governor decides not to nominate any of the candidates  
10 submitted, he must submit the name of any additional person or persons he proposes to  
11 nominate to the Commission and receive the Commission's evaluation of those persons,  
12 including the person to be nominated, before submitting a nomination to the General  
13 Assembly. The Commission shall personally meet with each candidate and provide the  
14 candidate with an opportunity to address any concerns that the Commission's  
15 investigation has revealed. The Commission shall indicate in its report that it finds the  
16 candidate 'Not Qualified,' 'Qualified,' or 'Well Qualified' to assume the judgeship for  
17 which he or she is a candidate. The finding of the Commission shall be by majority  
18 vote of those present and voting, and the number of commissioners voting in favor of  
19 and against the ultimate finding shall be included when the finding is submitted to the  
20 Governor. The Governor shall include the Commission's finding when submitting any  
21 nomination to the General Assembly.

22 (b) As used in subsection (a):

- 23 (1) 'Well Qualified' means the Commission believes the person is one of  
24 the best persons available to serve in the judgeship from the standpoint  
25 of integrity, competency, and temperament.  
26 (2) 'Qualified' means that the Commission believes that the person would  
27 perform satisfactorily in the judgeship from the standpoint of integrity,  
28 competency, and temperament.  
29 (3) 'Not Qualified' means that the Commission believes that the person  
30 would not perform satisfactorily in the judgeship from the standpoint  
31 of integrity, competency, or temperament.

32 (c) The Commission shall report its finding to the Governor within 30 days of the  
33 receipt of the candidate's names from the Governor. If the Commission fails to report to  
34 the Governor within 30 days, the Governor may submit a nomination without the  
35 evaluation, and no evaluation of the Commission shall be disseminated by the  
36 Commission with respect to the person nominated.

37 (d) Information received in the course of the investigation is confidential and  
38 shall not be disclosed unless specifically required by law or the candidate consents in  
39 writing to the disclosure. Except for the report of the Commission's ultimate finding  
40 with respect to a person nominated and the number of Commissioners voting for and  
41 against the finding, documents prepared or received by the Commission in the course of  
42 its investigation are confidential and not open to public inspection without the consent  
43 of the candidate, notwithstanding the provisions of Chapter 132 of the General Statutes.

44 **"§ 7A-4.4. Reconfirmation procedure.**

1       (a) Any Chief Justice, Associate Justice, or Judge of the Court of Appeals, to be  
2 eligible to be reconfirmed, shall by November 1 in the year immediately preceding the  
3 year in which his term expires, file a written declaration of his intent to seek  
4 reconfirmation. The declaration shall be filed with the Governor. The Governor shall  
5 promptly notify the General Assembly and the Judicial Selection and Retention  
6 Commission of his receipt of the declaration. Failure to file the declaration in a timely  
7 manner results in the creation of a vacancy in the office at the expiration of the term. A  
8 Justice or Judge may indicate in writing to the Governor that he does not intend to seek  
9 reconfirmation, and the filing of that intention creates a vacancy in the office at the  
10 expiration of the term, unless the Justice or Judge leaves office at an earlier date.

11       (b) The Judicial Selection and Retention Commission, upon receipt of a Justice's  
12 or Judge's written declaration of his intent to seek reconfirmation, shall investigate the  
13 Judge's performance as a Justice or Judge to determine if it should recommend that he  
14 be reconfirmed. The Commission shall conduct a public hearing to allow comment  
15 from interested persons on the Justice's or Judge's fitness to continue in office.  
16 Information received in the course of the investigation is confidential and shall not be  
17 disclosed unless specifically required by law or unless the Justice or Judge consents to  
18 the disclosure. Documents prepared or received by the Commission in the course of its  
19 investigation are confidential and not subject to public inspection without the consent of  
20 the Justice or Judge, notwithstanding the provisions of Chapter 132 of the General  
21 Statutes. The investigation shall include an evaluation of the Justice's or Judge's ethical  
22 conduct, his knowledge of and application of the law, his management of the courts  
23 over which he has presided, his work habits, his health, his judicial demeanor, and any  
24 other matter that the Commission determines to be relevant to its inquiry. The Judge  
25 shall be given an opportunity to present to the Commission any information he  
26 determines to be appropriate. The Commission's recommendation shall be by majority  
27 vote of those present and voting.

28       (c) No later than 30 days after the convening of the General Assembly in the year  
29 following the filing of a Justice's or Judge's intent to seek reconfirmation, the  
30 Commission shall report to the General Assembly as to whether it recommends that the  
31 Justice or Judge be reconfirmed. A vote of sixty percent (60%) of both the Senate and  
32 the House of Representatives shall be necessary to reject the recommendation of the  
33 Commission. If either house fails to vote on the report of the Commission during the  
34 session in which it is submitted, the recommendation of the Commission shall be  
35 deemed to have been approved by the General Assembly. For the purpose of this  
36 subsection, a session ends when it adjourns or recesses for more than 30 days, or  
37 adjourns **sine die**, whichever comes first.

38       (d) A Justice or Judge reconfirmed by the General Assembly serves an eight-year  
39 term, to begin at the expiration of the term he is serving at the time of reconfirmation. If  
40 the General Assembly does not reconfirm a Justice or Judge, either by a negative vote or  
41 by failing to vote on a negative recommendation of the Commission, a vacancy in that  
42 office is created at the expiration of the term. The provisions of Article VI, Section 10  
43 of the North Carolina Constitution are not applicable to Justices or Judges who are not  
44 reconfirmed by the General Assembly.

1 **§ 7A-4.5. Judicial Selection and Retention Commission.**

2 (a) The Judicial Selection and Retention Commission consists of:

- 3 (1) Four members appointed by the Governor, none of whom may be  
4 licensed attorneys, with one member from each judicial division as  
5 those divisions were constituted on January 1, 1991;  
6 (2) Four members appointed by the President of the State Bar from its  
7 membership with one member from each judicial division as those  
8 divisions were constituted on January 1, 1991;  
9 (3) One member appointed by the General Assembly on recommendation  
10 of the Speaker of the House of Representatives, as provided by G.S.  
11 120-121;  
12 (4) One member appointed by the General Assembly on recommendation  
13 of the President Pro Tempore of the Senate, as provided by G.S. 120-  
14 121;  
15 (5) One member appointed by the President of the North Carolina Bar  
16 Association from its membership;  
17 (6) One member appointed by the President of the North Carolina  
18 Association of Women Attorneys from its membership;  
19 (7) One member appointed by the President of the North Carolina  
20 Academy of Trial Lawyers from its membership;  
21 (8) One member appointed by the President of the North Carolina  
22 Association of Black Lawyers from its membership; and  
23 (9) One member appointed by the President of the North Carolina  
24 Association of Defense Attorneys from its membership.

25 No member of the Commission shall be an active judge or justice of the General Court  
26 of Justice or an active member of the General Assembly.

27 (b) The Director of the Administrative Office of the Courts shall convene the  
28 initial meeting of the Commission as soon as feasible after the initial appointments are  
29 made. At that meeting the Commission shall select a chairman from among its  
30 members.

31 (c) All the members appointed by the Governor and by the President of the State  
32 Bar shall serve four-year terms of office, except that two of the initial appointees of the  
33 Governor and two of the initial appointees of the State Bar President shall serve terms  
34 expiring June 30, 1995, and the remaining two appointees of the Governor and the State  
35 Bar President shall serve initial terms expiring June 30, 1997. The members appointed  
36 by the Presidents of the Bar Association, the Association of Women Attorneys, and the  
37 Academy of Trial Lawyers shall serve four-year terms, except that the term of office for  
38 the initial appointees from those organizations shall expire June 30, 1995. The  
39 members appointed by the Presidents of the Association of Black Lawyers and the  
40 Association of Defense Attorneys shall serve four-year terms, except that the term of  
41 office for these initial appointees shall expire June 30, 1997. The appointees of the  
42 General Assembly shall serve two-year terms. Members who have served a full term  
43 may be reappointed to one additional full term. The members shall be appointed within  
44 30 days of the date this act becomes effective.

1       (d) The Commission shall, upon request, be allowed to inspect the files of the  
2 Judicial Standards Commission, notwithstanding the provisions of G.S. 7A-377.  
3 Meetings of the Commission shall not be subject to the provisions of Article 33C of  
4 Chapter 143 of the General Statutes. Testimony and other evidence presented to the  
5 Commission is privileged in any action for defamation.

6       (e) The Commission may employ an executive secretary to assist it in performing  
7 its duties.

8 **"§ 7A-4.6. Governor to issue commissions to Justices and Judges.**

9       Every person duly appointed by the Governor as Chief Justice, Associate Justice, or  
10 Judge of the Court of Appeals, and every Justice or Judge duly reconfirmed by the  
11 General Assembly shall procure from the Governor a commission attesting that fact,  
12 which the Governor shall issue upon receipt of a certification by the principal clerks of  
13 the Senate and House of Representatives that the person has been confirmed or  
14 reconfirmed by the house in which the clerk serves. The principal clerk of the Senate  
15 and the principal clerk of the House of Representatives shall promptly certify the results  
16 to the Governor of any judicial confirmation and reconfirmation votes taken in their  
17 respective houses. The Secretary of State shall inform the Governor whenever the  
18 General Assembly adjourns or recesses for more than 30 days, or adjourns *sine die*.

19 **"§ 7A-4.7. Transitional provisions for judges in office on effective date of Article.**

20       (a) Any Chief Justice, Associate Justice, or Judge of the Court of Appeals  
21 holding a judgeship on January 15, 1993, that on January 14, 1993, is required by law to  
22 be filled by election shall be subject to the reconfirmation procedures in G.S. 7A-4.5  
23 and to the provisions of subsections (b) and (c) of this section to retain his office.

24       (b) A Justice or Judge covered by the provisions of subsection (a) who, at the end  
25 of his term of office has at least four years of service in the office he is holding on  
26 January 15, 1993, shall be subject to the reconfirmation process during the first regular  
27 session convening in an odd-numbered year after the term expires. Terms of such  
28 Justices and Judges are extended until August 31 of the year following the year in which  
29 the term would have normally expired.

30       (c) A Justice or Judge covered by the provisions of subsection (a) who, at the end  
31 of his term of office has less than four years in the office he is holding on January 15,  
32 1993, shall be subject to the reconfirmation process in the first regular session  
33 convening in an odd-numbered year after he would have four years in service in that  
34 office, if continued in office past the expiration of his term. Terms of office of such  
35 Justices and Judges shall be extended until August 31 of the year in which a  
36 reconfirmation decision is made by the General Assembly."

37       Sec. 2. G.S. 7A-10(a) reads as rewritten:

38       "(a) The Supreme Court shall consist of a Chief Justice and six associate justices,  
39 ~~elected by the qualified voters of the State for terms of eight years~~selected as provided by  
40 Article 1A of this Chapter. Before entering upon the duties of his office, each justice  
41 shall take an oath of office. Four justices shall constitute a quorum for the transaction of  
42 the business of the court. Sessions of the court shall be held in the city of Raleigh, and  
43 scheduled by rule of court so as to discharge expeditiously the court's business."

44       Sec. 3. G.S. 7A-16 reads as rewritten:

1 **"§ 7A-16. Creation and organization.**

2 ~~The Court of Appeals is created effective January 1, 1967. It shall consist initially of~~  
3 ~~six judges, elected by the qualified voters of the State for terms of eight years. The~~  
4 ~~Chief Justice of the Supreme Court shall designate one of the judges as Chief Judge, to~~  
5 ~~serve in such capacity at the pleasure of the Chief Justice. Before entering upon the~~  
6 ~~duties of his office, a judge of the Court of Appeals shall take the oath of office~~  
7 ~~prescribed for a judge of the General Court of Justice.~~

8 ~~The Governor on or after July 1, 1967, shall make temporary appointments to the six~~  
9 ~~initial judgeships. The appointees shall serve until January 1, 1969. Their successors~~  
10 ~~shall be elected at the general election for members of the General Assembly in~~  
11 ~~November, 1968, and shall take office on January 1, 1969, to serve for the remainder of~~  
12 ~~the unexpired term which began on January 1, 1967.~~

13 ~~Upon the appointment of at least five judges, and the designation of a Chief Judge,~~  
14 ~~the court is authorized to convene, organize, and promulgate, subject to the approval of~~  
15 ~~the Supreme Court, such supplementary rules as it deems necessary and appropriate for~~  
16 ~~the discharge of the judicial business lawfully assigned to it.~~

17 ~~Effective January 1, 1969, the number of judges is increased to nine, and the~~  
18 ~~Governor, on or after March 1, 1969, shall make temporary appointments to the~~  
19 ~~additional judgeships thus created. The appointees shall serve until January 1, 1971.~~  
20 ~~Their successors shall be elected at the general election for members of the General~~  
21 ~~Assembly in November, 1970, and shall take office on January 1, 1971, to serve for the~~  
22 ~~remainder of the unexpired term which began on January 1, 1969.~~

23 ~~Effective January 1, 1977, the number of judges is increased to 12; and the~~  
24 ~~Governor, on or after July 1, 1977, shall make temporary appointments to the additional~~  
25 ~~judgeships thus created. The appointees shall serve until January 1, 1979. Their~~  
26 ~~successors shall be elected at the general election for members of the General Assembly~~  
27 ~~in November, 1978, and shall take office on January 1, 1979, to serve the remainder of~~  
28 ~~the unexpired term which began on January 1, 1977.~~

29 The Court of Appeals shall consist of 12 judges, selected as provided in Article 1A  
30 of this Chapter. The Chief Justice of the Supreme Court shall designate one of the  
31 judges as Chief Judge, to serve in such capacity at the pleasure of the Chief Justice.  
32 Before entering upon the duties of his office, a judge of the Court of Appeals shall take  
33 the oath of office prescribed for a judge of the General Court of Justice.

34 The Court of Appeals shall sit in panels of three judges each. The Chief Judge  
35 insofar as practicable shall assign the members to panels in such fashion that each  
36 member sits a substantially equal number of times with each other member. He shall  
37 preside over the panel of which he is a member, and shall designate the presiding judge  
38 of the other panel or panels.

39 Three judges shall constitute a quorum for the transaction of the business of the  
40 court, except as may be provided in G.S. 7A-32.

41 In the event the Chief Judge is unable, on account of absence or temporary  
42 incapacity, to perform the duties placed upon him as Chief Judge, the Chief Justice shall  
43 appoint an acting Chief Judge from the other judges of the Court, to temporarily  
44 discharge the duties of Chief Judge."



1 Sec. 3.1. G.S. 120-123 is amended by adding a new subdivision to read:

2 "(3b) The Judicial Selection and Retention Commission as established by  
3 G.S. 7A-4.5."

4 Sec. 4. G.S. 163-106 reads as rewritten:

5 "**§ 163-106. Notices of candidacy; pledge; with whom filed; date for filing;**  
6 **withdrawal.**

7 (a) Notice and Pledge. – No one shall be voted for in a primary election unless he  
8 shall have filed a notice of candidacy with the appropriate board of elections, State or  
9 county, as required by this section. To this end every candidate for selection as the  
10 nominee of a political party shall file with and place in the possession of the board of  
11 elections specified in subsection (c) of this section, a notice and pledge in the following  
12 form:

13 'Date

14 I hereby file notice as a candidate for nomination as ..... in the ..... party  
15 primary election to be held on ....., 19..... I affiliate with the ..... party, (and I certify  
16 that I am now registered on the registration records of the precinct in which I reside as  
17 an affiliate of the ..... party.)

18 I pledge that if I am defeated in the primary, I will not run for any office as a write-  
19 in candidate in the next general election.

20 Signed

21 Name of candidate

22 Witness:

23 .....  
24 .....

25 (Title of witness)'

26 Each candidate shall sign his notice of candidacy in the presence of the chairman or  
27 secretary of the board of elections, State or county, with which he files. In the  
28 alternative, a candidate may have his signature on the notice of candidacy  
29 acknowledged and certified to by an officer authorized to take acknowledgments and  
30 administer oaths, in which case the candidate may mail his notice of candidacy to the  
31 appropriate board of elections.

32 In signing his notice of candidacy the candidate shall use only his legal name and, in  
33 his discretion, any nickname by which he is commonly known. A candidate may also, in  
34 lieu of his legal first name and legal middle initial or middle name (if any) sign his  
35 nickname, provided that he appends to the notice of candidacy an affidavit that he has  
36 been commonly known by that nickname for at least five years prior to the date of  
37 making the affidavit. The candidate shall also include with the affidavit the way his  
38 name (as permitted by law) should be listed on the ballot if another candidate with the  
39 same last name files a notice of candidacy for that office.

40 A notice of candidacy signed by an agent or any person other than the candidate

33 All county offices.

34 (d) Notice of Candidacy for Certain Offices to Indicate Vacancy. – In any  
35 primary in which there are ~~two or more vacancies for Chief Justice and associate~~  
36 ~~justices of the Supreme Court, two or more vacancies for judge of the Court of Appeals,~~  
37 ~~or two vacancies for United States Senator from North Carolina or two or more~~

This subsection implements Article IV Section 9(1) of the North Carolina Constitution which requires regular Superior Court Judges to reside in the district for which elected."
