- 4 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 147-45 reads as rewritten:

6 "§ 147-45. Distribution of copies of State publications.

7 The Secretary of State shall, at the State's expense, as soon as possible after 8 publication, provide such number of copies of the Session Laws and Senate and House 9 Journals to federal, State, and local governmental officials, departments and agencies, 10 and to educational institutions of instruction and exchange use, as is set out in the table 11 below:
