A BILL TO BE ENTITLED

- 2 AN ACT TO EXPAND THE PENDER COUNTY BOARD OF COMMISSIONERS, 3 TO PROVIDE THAT EACH COMMISSIONER SHALL BE NOMINATED AND
- 3 TO PROVIDE THAT EACH COMMISSIONER SHALL BE NOMINATED AND 4 ELECTED FROM A SEPARATE DISTRICT, AND TO DEFINE THE
- 5 DISTRICTS.

6 The General Assembly of North Carolina enacts:

7 Section 1. (a) Effective on the first Monday in December 1994, the Board of 8 Commissioners of Pender County consists of seven members. The members shall be 9 elected on a partisan basis at the time of the regular county primary and general 10 elections. One shall be elected from each of seven single-member districts established 11 under subsection (e) of this section.

12 (b) In 1994 and every four years thereafter, members for Districts 4, 5, 6, and 7 13 shall be elected for four-year terms. In 1994 members for Districts 1, 2, and 3 shall be 14 elected for two-year terms, and in 1996 and every four years thereafter, successors shall 15 be elected for four-year terms.

16 (c) The districts set out in subsection (e) of this section are devised and 17 constituted to meet the requirements of the Voting Rights Act of 1965, as amended, and 18 other applicable statutory and constitutional provisions.

19 (d) The qualified voters of each district shall elect the member of the board for 20 that district. Only the qualified voters of that district may vote for a member of the 21 board for that district in primary and general elections. Candidates must reside in the 22 district for which they seek to be elected.

19 (g) All local acts and board resolutions pertaining to the establishment of 20 districts for the election of county commissioners in Pender County are repealed to the 21 extent of conflict with this act, provided that any incumbent member elected under 22 existing local acts or resolutions shall continue to serve the term to which elected until 23 the first Monday in December 1994.
