1 A BILL TO BE ENTITLED
2 AN ACT TO CLARIFY THE PROCEDURE FOR FORECLOSURE UNDER POWER
3 OF SALE AND TO ESTABLISH A NEW UPSET BID PROCEDURE.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 45-21.1 reads as rewritten:

6 "**§ 45-21.1. Definition-Definitions; construction.**

7 (a) ~~As used in this Article,~~ The following definitions apply in this Article:

8 (1) 'Resale' means a resale of real property or a resale of any leasehold
9 interest created by a lease of real property held pursuant to G.S. 45-
10 21.30.

11 (2) ~~'sale'~~ 'Sale' means a sale of real property or a sale of any leasehold
12 interest created by a lease of real property pursuant to (i) an express
13 power of sale contained in a mortgage, deed of trust, leasehold
14 mortgage, or leasehold deed of trust-trust or (ii) a 'power of sale',
15 under this Article, authorized by other statutory provisions.

16 (b) The following constructions apply in this Article:

17 (1) The terms 'mortgage' or 'deed of trust' include leasehold mortgages or
18 leasehold deeds of trust.

19 (2) The terms 'mortgagee' or 'trustee' include any person or entity
20 exercising a power of sale pursuant to this Article.

21 (3) The terms 'real property' or 'property' include any leasehold interest
22 created by a lease of real property."

23 Sec. 2. G.S. 45-21.3 is repealed.

24 Sec. 3. G.S. 45-21.7(a) reads as rewritten:

1 "(a) When the property to be sold consists of separate tracts of real property
2 situated in different counties, there shall be a separate advertisement, sale and report of
3 sale of the property in each county. The report of sale for the property in any one county
4 shall be filed with the clerk of the superior court of the county in which such property is
5 situated. ~~The sale, and each subsequent resale, sale of each such tract shall be subject to a~~
6 ~~separate upset bid.~~ bids. The clerk of the superior court of the county where the
7 property is situated has jurisdiction with respect to ~~resale~~ upset bids of property situated
8 within his county. To the extent the clerk deems necessary, the sale of each separate
9 tract within his county, with respect to which an upset bid is received, shall be treated as
10 a separate sale for the purpose of determining the procedure applicable thereto."

11 Sec. 4. G.S. 45-21.8 is amended by adding a new subsection to read:

12 "(b1) When real property is sold in parts, the sale of any such part is subject to a
13 separate upset bid; and, to the extent the clerk of superior court having jurisdiction
14 deems advisable, the sale of each such part shall thereafter be treated as a separate sale
15 for the purpose of determining the procedure applicable thereto."

16 Sec. 5. G.S. 45-21.9A reads as rewritten:

17 **"§ 45-21.9A. Simultaneous foreclosure of two or more instruments.**

18 ~~When the same property secures two or more mortgages or deeds of trust held by the~~
19 ~~same person,~~ person are secured in whole or in part by the same property, and there are
20 no intervening liens, except for ad valorem taxes, between such mortgages or deeds of
21 trust, the obligations secured by such mortgages or deeds of trust may be combined and
22 the property sold once to satisfy the combined obligations if (i) powers of sale are
23 provided in all such instruments; (ii) there is no provision in any such instrument which
24 would not permit such a procedure; (iii) all the terms of all such instruments requiring
25 compliance by the lender in connection with foreclosure sales are complied with; and
26 (iv) all requirements of this Chapter governing power of sale foreclosures are met with
27 respect to all such instruments. The proceeds of any sale shall be applied as provided in
28 this Chapter. As between the combined obligations being foreclosed, proceeds shall be
29 applied in the order of priority of the instruments securing them, and any deficiencies
30 shall be determined accordingly."

31 Sec. 6. G.S. 45-21.10(b) reads as rewritten:

32 "(b) If the instrument contains no provision with respect to a cash deposit at the
33 sale, the mortgagee or trustee ~~holding the sale of real property~~ may require the highest
34 bidder immediately to make a cash deposit not to exceed ~~ten percent (10%) of the amount~~
35 ~~of the bid up to and including one thousand dollars (\$1,000), plus five percent (5%) of any~~
36 ~~excess over one thousand dollars (\$1,000).~~ the greater of five percent (5%) of the amount
37 of the bid or seven hundred fifty dollars (\$750.00)."

38 Sec. 7. G.S. 45-21.15(b) reads as rewritten:

39 "(b) When no sale has actually been held, compensation for a trustee's services is
40 determined as follows:

- 41 (1) If no compensation for the trustee's services in holding a sale is
42 provided for in the instrument, the trustee is not entitled to any
43 compensation;

- 1 (2) If compensation is specifically provided for the trustee's services when
 2 no sale is actually held, the trustee is entitled to such compensation;
- 3 (3) If the instrument provides for compensation for the trustee's services in
 4 actually holding a sale, but does not provide compensation for the
 5 trustee's services when no sale is actually held, the trustee is entitled to
 6 such compensation as the parties agree upon; follows: (i) one-fourth of
 7 the completed sale compensation before the trustee files the notice of
 8 hearing; (ii) one-half after the filing of the notice of hearing; and (iii)
 9 three-fourths after the hearing.
- 10 (4) ~~If the instrument provides for compensation for the trustee's services in~~
 11 ~~actually holding a sale, but does not provide compensation for the~~
 12 ~~trustee's services when no sale is actually held, and the parties are not~~
 13 ~~able to agree as to the trustee's compensation, then five percent (5%)~~
 14 ~~of the amount of the obligation secured by the instrument, not~~
 15 ~~exceeding the amount stipulated in the instrument as compensation for~~
 16 ~~the trustee's services in actually holding a sale, shall be deposited with~~
 17 ~~the clerk of the superior court. Such sum shall be held by the clerk~~
 18 ~~until the trustee's compensation is fixed by the clerk, upon petition by~~
 19 ~~the trustee, after notice to the person who deposited such sum."~~

20 Sec. 8. G.S. 45-21.16 reads as rewritten:

21 "**§ 45-21.16. Notice and hearing.**

22 (a) The mortgagee or trustee granted a power of sale under a mortgage or deed of
 23 trust who seeks to exercise such power of sale shall ~~serve upon each party entitled to notice~~
 24 ~~under this section a notice of hearing. file with the clerk of court a notice of hearing in~~
 25 accordance with the terms of this section. The notice shall specify a time and place for a
 26 hearing before the clerk of court and shall be served not less than 10 days prior to the date of
 27 such hearing. After the notice of hearing is filed, the notice of hearing shall be served
 28 upon each party entitled to notice under this section. The notice shall be served in any
 29 manner provided by the Rules of Civil Procedure for the service of summons, or may be served
 30 by actual delivery by registered or certified mail, return receipt requested; provided, that in
 31 those instances in which service by publication would be authorized, service may be made by
 32 posting a notice in a conspicuous place and manner upon the property for a period of not less
 33 than 20 days before the date of the hearing; provided further, if service upon a party cannot be
 34 effected after a reasonable and diligent effort in a manner authorized above, notice to such
 35 party may be given by posting a notice in a conspicuous place and manner upon the property
 36 for a period of not less than 20 days before the date of hearing, which 20 day period may run
 37 concurrently with any other effort to effect service. The notice shall specify a time and place
 38 for the hearing before the clerk of court and shall be served not less than 10 days prior
 39 to the date of such hearing. The notice shall be served and proof of service shall be
 40 made in any manner provided by the Rules of Civil Procedure for service of summons,
 41 including service by registered mail or certified mail, return receipt requested.
 42 However, in those instances that publication would be authorized, service may be made
 43 by posting a notice in a conspicuous place and manner upon the property not less than
 44 20 days prior to the date of the hearing, and if service upon a party cannot be effected
 45 after a reasonable and diligent effort in a manner authorized above, notice to such party

1 may be given by posting the notice in a conspicuous place and manner upon the
2 property not less than 20 days prior to the date of hearing. Service by posting may run
3 concurrently with any other effort to effect service. The notice may be posted upon the
4 property by either the mortgagee, trustee, an authorized agent of the mortgagee or
5 trustee, or any other person authorized to serve process by the Rules of Civil Procedure.
6 In the event that the service is obtained by posting, an affidavit shall be filed with the
7 clerk of court showing the circumstances warranting the use of service by posting. If
8 the notice is posted by any person other than the sheriff of the county in which the
9 property is located, an affidavit of such person shall be filed with the clerk of court
10 stating: (i) the date and the time of posting; (ii) that the notice was posted on the
11 property in a conspicuous place and manner; and (iii) the affiant's authority to post and
12 the fact that the affiant is not less than 18 years of age and is not under a legal disability.

13 ~~If all parties are not served in time to hold the hearing on the date stated in the notice~~
14 ~~of hearing, the clerk shall order it continued. If any party is not served or is not timely~~
15 ~~served prior to the date of the hearing, the clerk shall order the hearing continued to a~~
16 ~~date and time certain, not less than 10 days from the date scheduled for the original~~
17 ~~hearing. All notices already timely served remain effective; when the mortgagee or~~
18 ~~trustee has satisfied the notice requirements of this section, the clerk shall notify all~~
19 ~~parties of the date to which the hearing has been continued. effective. The mortgagee or~~
20 ~~trustee shall satisfy the notice requirement of this section with respect to those parties~~
21 ~~not served or not timely served with respect to the original hearing. The clerk shall~~
22 ~~notify any party who has not received actual notice of the date to which the hearing has~~
23 ~~been continued by sending the notice by first class mail to his last known address. Any~~
24 ~~party timely served, who has not received actual notice of the date to which the hearing~~
25 ~~has been continued, shall be sent the order of continuance by first-class mail at his last~~
26 ~~known address.~~

27 (b) Notice of hearing shall be given in a manner authorized in subsection (a) ~~to~~
28 ~~upon:~~

- 29 (1) Any person to whom the security interest instrument itself directs
30 notice to be sent in case of default.
- 31 (2) Any person obligated to repay the indebtedness against whom the
32 holder thereof intends to assert liability therefor, and any such person
33 not notified shall not be liable for any deficiency remaining after the
34 sale.
- 35 (3) Every record owner of the real estate whose interest is of record in the
36 county where the real property is located at the time ~~of giving notice.~~
37 the notice of hearing is filed in that county. The term 'record owner'
38 means any person owning a present or future interest ~~of record~~ in the
39 real property property, which interest is of record at the time that the
40 notice of hearing is filed and would be affected by the foreclosure
41 proceeding, but does not mean or include the trustee in a deed of trust
42 or the owner or holder of a mortgage, deed of trust, judgment,
43 mechanic's or materialman's lien, or other lien or security interest in

1 the real property. Tenants in possession under unrecorded leases or
2 rental agreements shall not be considered record owners.

3 (c) Notice shall be in writing and shall state in a manner reasonably calculated to
4 make the party entitled to notice aware of the following:

5 (1) The particular real estate security interest being foreclosed, with such a
6 description as is necessary to identify the real property, including the
7 date, original amount, original holder, and book and page of the
8 security instrument.

9 (2) The name and address of the holder of the security ~~instrument, and if~~
10 ~~different from the original holder, his name and address.~~ instrument at the
11 time that the notice of hearing is filed.

12 (3) The nature of the default claimed.

13 (4) The fact, if such be the case, that the secured creditor has accelerated
14 the maturity of the debt.

15 (5) Any right of the debtor to pay the indebtedness or cure the default if
16 such is permitted.

17 (6) Repealed by Session Laws 1977, c. 359, s. 7.

18 (7) The right of the debtor (or other party served) to appear before the
19 clerk of court at a time and on a date specified, at which appearance he
20 shall be afforded the opportunity to show cause as to why the
21 foreclosure should not be allowed to be held. The notice shall contain a
22 statement that if the debtor does not intend to contest the creditor's
23 allegations of default, the debtor does not have to appear at the
24 hearing and that his failure to attend the hearing will not affect his
25 right to pay the indebtedness and thereby prevent the proposed sale, or
26 to attend the actual sale, should he elect to do so.

27 (8) That if the foreclosure sale is consummated, the purchaser will be
28 entitled to possession of the real estate as of the date of delivery of his
29 deed, and that the debtor, if still in possession, can then be evicted.

30 (8a) The name, address, and telephone number of the trustee or mortgagee.

31 (9) That the debtor should keep the trustee or mortgagee notified in
32 writing of his address so that he can be mailed copies of the notice of
33 foreclosure setting forth the terms under which the sale will be held,
34 and notice of any postponements or resales.

35 (10) If the notice of hearing is intended to serve also as a notice of sale,
36 such additional information as is set forth in G.S. 45-21.16A.

37 (11) That the hearing may be held on a date later than that stated in the
38 notice and that the party will be notified of any change in the hearing
39 date.

40 (d) The hearing provided by this section shall be held before the clerk of court in
41 the county where the land, or any portion thereof, is situated. In the event that the
42 property to be sold consists of separate tracts situated in different counties or a single
43 tract in more than one county, only one hearing shall be necessary. However, prior to
44 that hearing, the mortgagee or trustee shall file the notice of hearing in any other county

1 where any portion of the property to be sold is located. Upon such hearing, the clerk
2 shall consider the evidence of the parties and may consider, in addition to other forms
3 of evidence required or permitted by law, affidavits and certified copies of documents.
4 If the clerk finds the existence of (i) valid debt of which the party seeking to foreclose is
5 the holder, (ii) default, (iii) right to foreclose under the instrument, and (iv) notice to
6 those entitled to such under subsection (b), then the clerk shall authorize the mortgagee
7 or trustee to proceed under the instrument, and the mortgagee or trustee can give notice
8 of and conduct a sale pursuant to the provisions of this Article. A certified copy of any
9 authorization or order by the clerk shall be filed in any other county where any portion
10 of the property to be sold is located before the mortgagee or trustee may proceed to
11 advertise and sell any property located in that county. In the event that sales are to be
12 held in more than one county, the provisions of G.S. 45-21.7 apply.

13 (d1) The act of the clerk in so finding or refusing to so find is a judicial act and
14 may be appealed to the judge of the district or superior court having jurisdiction at any
15 time within 10 days after said act. Appeals from said act of the clerk shall be heard de
16 novo. If an appeal is taken from the clerk's findings, the appealing party shall post a
17 bond with sufficient surety as the clerk deems adequate to protect the opposing party
18 from any probable loss by reason of appeal; and upon posting of the bond the clerk shall
19 stay the foreclosure pending appeal.

20 (e) In the event of an appeal, either party may demand that the matter be heard at
21 the next succeeding term of the court to which the appeal is taken which convenes 10 or
22 more days after the hearing before the clerk, and such hearing shall take precedence
23 over the trial of other cases except cases of exceptions to homesteads and appeals in
24 summary ejection actions, provided the presiding judge may in his discretion postpone
25 such hearing if the rights of the parties or the public in any other pending case require
26 that such case be heard first. In those counties where no session of court is scheduled
27 within 30 days from the date of hearing before the clerk, either party may petition any
28 regular or special superior court judge resident in a district or assigned to hold courts in
29 a district where any part of the real estate is located, or the chief district judge of a
30 district where any part of the real estate is located, who shall be authorized to hear the
31 appeal. A certified copy of any order entered as a result of the appeal shall be filed in
32 all counties where the notice of hearing has been filed.

33 (f) Waiver of the right to notice and hearing provided herein shall not be
34 permitted except as set forth herein. In any case in which the original principal amount
35 of indebtedness secured was one hundred thousand dollars (\$100,000), or more, any
36 person entitled to notice and hearing may waive ~~after default~~ the right to notice and
37 hearing by written instrument signed and duly acknowledged by such party. In all other
38 cases, at any time subsequent to service of the notice of hearing provided above, the
39 clerk, upon the request of the mortgagee or trustee, shall mail to all other parties entitled
40 to notice of such hearing a form by which such parties may waive their rights to the
41 hearing. Upon the return of the forms to the clerk bearing the signatures of each such
42 party and that of a witness to each such party's signature (which witness shall not be an
43 agent or employee of the mortgagee or trustee), the clerk in his discretion may dispense

1 with the necessity of a hearing and proceed to issue the order authorizing sale as set
2 forth above.

3 (g) Any notice, order, or other papers required by this Article to be filed in the
4 office of the clerk of superior court shall be filed in the same manner as a special
5 proceeding."

6 Sec. 9. G.S. 45-21.16A reads as rewritten:

7 **"§ 45-21.16A. Contents of notice of sale.**

8 The notice of sale shall –

- 9 (1) Describe the instrument pursuant to which the sale is held, by
10 identifying the original mortgagors and recording ~~data, and if data.~~ If
11 the record owner is different from the original mortgagors-mortgagors,
12 the notice shall also list the record owner of the property, as reflected
13 on the records of the register of deeds not more than 10 days prior to
14 posting the ~~notice, who may be identified as present owners, and may~~
15 notice. The notice may also reflect the owner not reflected on the
16 records if known;
- 17 (2) Designate the date, hour and place of sale consistent with the
18 provisions of the instrument and this Article;
- 19 (3) Describe the real property to be sold in such a manner as is reasonably
20 calculated to inform the public as to what is being sold, which
21 description may be in general terms and may incorporate the
22 description as used in the instrument containing the power of sale by
23 reference thereto. Any property described in the instrument containing
24 the power of sale which is not being offered for sale should also be
25 described in such a manner as to enable prospective purchasers to
26 determine what is and what is not being offered for sale;
- 27 (4) Repealed by Session Laws 1967, c. 562, s. 2.
- 28 (5) State the terms of the sale provided for by the instrument pursuant to
29 which the sale is held, including the amount of the cash deposit, if any,
30 to be made by the highest bidder at the sale;
- 31 (6) Include any other provisions required by the instrument to be included
32 therein; ~~and~~
- 33 (7) State that the property will be sold subject to taxes and special
34 assessments if it is to be so ~~sold.~~ and
- 35 (8) State whether the property is being sold subject to or together with any
36 subordinate rights or interests provided those rights and interests are
37 sufficiently identified."

38 Sec. 10. G.S. 45-21.17 reads as rewritten:

39 **"§ 45-21.17. Posting and publishing notice of sale of real property.**

40 In addition to complying with such provisions with respect to posting or publishing
41 notice of sale as are contained in the security instrument,

- 42 (1) Notice of sale of real property shall
- 43 a. Be posted, ~~at the courthouse door in the area designated by the~~
44 clerk of superior court for posting public notices in the county

- 1 in which the property is situated, ~~for~~ at least ~~15~~ 20 days
2 immediately preceding the sale.
- 3 b. And in addition thereto,
- 4 1. ~~If a newspaper qualified for legal advertising is~~
5 ~~published in the county, the notice shall be published in~~
6 ~~such a newspaper once a week for at least two successive~~
7 ~~weeks; but~~ The notice shall be published once a week for
8 at least two successive weeks in a newspaper qualified
9 for legal advertising in the county in which the property
10 is situated or in a newspaper having a general circulation
11 in said county;
- 12 ~~2. If no such newspaper is published in the county, then~~
13 ~~notice shall be published once a week for at least two~~
14 ~~successive weeks in a newspaper having a general~~
15 ~~circulation in the county.~~
- 16 3. In addition to the required newspaper advertisement under
17 ~~1 or 2 above, advertisement,~~ the clerk may in his
18 discretion, on application of any interested party,
19 authorize such additional advertisement as in the opinion
20 of the clerk will serve the interest of the parties, and
21 permit the charges for such further advertisement to be
22 taxed as a part of the costs of the foreclosure.
- 23 (2) When the notice of sale is published in a newspaper,
- 24 a. The period from the date of the first publication to the date of
25 the last publication, both dates inclusive, shall not be less than
26 seven days, including Sundays, and
- 27 b. The date of the last publication shall be not more than 10 days
28 preceding the date of the sale.
- 29 (3) When the real property to be sold is situated in more than one county,
30 the provisions of subdivisions (1) and (2) shall be complied with in
31 each county in which any part of the property is situated.
- 32 (4) The notice of sale shall be mailed by first-class mail at least 20 days
33 prior to the date of sale to each party entitled to notice of the hearing
34 provided by G.S. 45-21.16 whose address is known to the trustee or
35 mortgagee and in addition shall also be mailed by first-class mail to
36 any party desiring a copy of the notice of sale who has complied with
37 ~~subdivision (5) below.~~ G.S. 45-21.17A. Notice of the hearing required
38 by G.S. 45-21.16 shall be sufficient to satisfy the requirement of
39 notice under this section provided such notice contains the information
40 required by G.S. 45-21.16A.
- 41 ~~(5) a. Requests for Copies of Notice.—Any person desiring a copy of any~~
42 ~~notice of default and sale under any security instrument with power of~~
43 ~~sale upon real property may, at any time subsequent to the recordation~~
44 ~~of the security instrument and prior to the giving of notice of hearing~~

1 provided for in G.S. 45-21.16, cause to be filed for record in the office
2 of the register of deeds of the county where all or any part of the real
3 property is situated, a duly acknowledged request for a copy of such
4 notice of sale. This request shall be signed and acknowledged by the
5 party making the request, shall specify the name and address of the
6 party to whom the notice is to be mailed, shall identify the deed of
7 trust or mortgage by stating the names of the parties thereto, the date
8 of recordation, and the book and page where the same is recorded, and
9 shall be in substantially the following form:

10 "In accordance with the provisions of G.S. 45-21.17(5)
11 request is hereby made that a copy of any notice of sale under
12 the deed of trust (mortgage) recorded on, 19...., in
13 Book, page, records of County, North
14 Carolina, executed by as trustor (mortgagor), in which
15 is named as beneficiary (mortgagee), and as
16 trustee, be mailed to
17 at the following address:.....

18 Signature:

- 19 b. Register of Deeds' Duties. — Upon the filing for record of such
20 request, the register of deeds shall index in the general index of
21 grantors the names of the trustors (mortgagors) recited therein,
22 and the names of the persons requesting copies, with a marginal
23 entry in the index of the book and page of the recorded security
24 instrument to which the request refers; or upon the filing for
25 record of such request, the register of deeds may instead of
26 indexing such request on the general index of grantors stamp
27 upon the face of the security instrument referred to in the
28 request the book and page of each request for notice thereunder.
- 29 e. Mailing Notice. — The mortgagee, trustee, or other person
30 authorized to conduct the sale shall at least 20 days prior to the
31 date of the sale cause to be deposited in the United States mail
32 an envelope with postage prepaid containing a copy of the
33 notice of sale, addressed to each person whose name and
34 address are set forth in a duly recorded request therefor as
35 specified in [paragraph] a above, directed to the address
36 designated in such request.
- 37 d. Effect of Request on Title. — No request for a copy of any
38 notice filed pursuant to this section nor any statement or
39 allegation in any such request nor any record thereof shall affect
40 the title to real property, or be deemed notice to any person that
41 the person requesting copies of notice has any claim or any
42 right, title or interest in, or lien or charge upon, the property
43 described in the deed of trust or mortgage referred to therein.

- 1 e. ~~Evidence of Compliance.—The affidavit of the mortgagee,~~
2 ~~trustee, or other person authorized to conduct the sale that~~
3 ~~copies of the notice of sale have been mailed to all parties filing~~
4 ~~requests for the same hereunder shall be deemed prima facie~~
5 ~~true. If on hearing it is proven that a party seeking to have the~~
6 ~~foreclosure sale set aside or seeking damages resulting from the~~
7 ~~foreclosure sale was mailed notice in accordance with this~~
8 ~~section or had actual notice of the sale before it was held (or if a~~
9 ~~resale was involved, prior to the date of the last resale), then he~~
10 ~~shall not prevail. Costs, expenses, and reasonable attorneys' fees~~
11 ~~incurred by the prevailing party in any action to set aside the~~
12 ~~foreclosure sale or for damages resulting from the foreclosure~~
13 ~~sale shall be allowed as of course to the prevailing party.~~
- 14 f. ~~Action to Set Foreclosure Sale Aside for Failure to Comply.—~~
15 ~~A person entitled to notice of sale by virtue of G.S. 45-~~
16 ~~21.17(5)a shall not bring any action to set the sale aside on~~
17 ~~grounds that he was not mailed the notice of sale unless such~~
18 ~~action is brought prior to the filing of the final report and~~
19 ~~account as provided in G.S. 45-21.33, if the property is~~
20 ~~purchased by someone other than the secured party; or if~~
21 ~~brought by the secured party, unless the action is brought within~~
22 ~~six months of the date of such filing and prior to the time the~~
23 ~~secured party sells the property to a bona fide purchaser for~~
24 ~~value; nor unless the party bringing such action also tenders an~~
25 ~~amount exceeding the reported sale price or the amount of the~~
26 ~~secured party's interest in the property, including all expenses~~

10 Provided further, that in other respects the procedure shall be as is now prescribed by
11 law in cases of injunction and receivership, with the right of appeal to the appellate

14 "**§ 45-21.35. Ordering ~~resales before confirmation; resales; receivers for property;~~**

16 The court or judge granting such order or injunction, or before whom the same is
17 returnable, shall have the right before, but not after, ~~any sale is confirmed~~ the rights of the
18 parties to the sale or resale becoming fixed pursuant to G.S. 45-21.29A to order a resale
19 by the mortgagee, trustee, commissioner, or other person authorized to make the same
20 in such manner and upon such terms as may be just and equitable: Provided, the rights
21 of all parties in interest, or who may be affected thereby, shall be preserved and
22 protected by bond or indemnity in such form and amount as the court may require, and
23 the court or judge may also appoint a receiver of the property or the rents and proceeds
24 thereof, pending any sale or resale, and may make such order for the payment of taxes
25 or other prior lien as may be necessary, subject to the right of appeal to the appellate
26 division in all cases."

27 Sec. 24. G.S. 45-38 reads as rewritten:

28 "**§ 45-38. Recording of foreclosure.**

29 In case of foreclosure of any deed of trust, or mortgage, the ~~trustee or mortgagee~~
30 trustee, mortgagee, or the trustee's or mortgagee's attorney shall record a notice of
31 foreclosure and, whenever it is practical to do so, may also enter upon the margin of the
32 record of the deed of trust or mortgage of the fact that such foreclosure and the date
33 when, and the person to whom, a conveyance was made by reason of the foreclosure. In
34 the event the entire obligation secured by a mortgage or deed of trust is satisfied by a
35 sale of only a part of the property embraced within the terms of the mortgage or deed of
36 trust, the ~~trustee or mortgagee~~ trustee, mortgagee, or the trustee's or mortgagee's attorney
37 shall indicate in the notice of foreclosure which property was sold and which was not
38 sold, and may make an additional notation indicating the same, whenever practical.

39 A notice of foreclosure shall consist of a separate instrument, or that part of the
40 original deed of trust or mortgage rerecorded, reciting the information required
41 hereinabove, the names of all parties to the original instrument, the amount of the
42 obligation secured, a reference by book and page number to the record of the instrument
43 foreclosed, and the date of recording the notice of foreclosure."

1 Sec. 25. This act becomes effective October 1, 1993, and applies to
2 instruments recorded on or after that date, except that this act applies to leasehold
3 mortgages and leasehold deeds of trust recorded prior to, on, or after that date.
