Section 1. G.S. 14-401.6(a) reads as rewritten:

It is unlawful for any person, firm, corporation or association to possess, use, 6 "(a) store, sell, or transport within the State of North Carolina, any form of that type of gas 7 generally known as 'tear gas,' or any container or device for holding or releasing that 8 gas; except this section does not apply to the possession, use, storage, sale or 9 transportation of that gas or any container or device for holding or releasing that gas: 10
