1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE A PERSON WHO MURDERS A SWORN LAW
3	ENFORCEMENT OFFICER TO BE SENTENCED TO DEATH.
4	The General Assembly of North Carolina enacts:
5	Section 1. Article 6 of Chapter 14 of the General Statutes is amended by
6	adding a new section to read:
7	"§ 14-17.2. Murder of a sworn law enforcement officer.
8	A person who commits first or second degree murder, as defined in G.S. 14-17, is
9	guilty of murder of a law enforcement officer if the murder victim was a sworn law
10	enforcement officer who either was performing an official duty when the murder
11	occurred or was murdered because of the prior exercise of an official duty. Murder of a
12	law enforcement officer is a Class A felony punishable by death. Upon conviction or
13	adjudication of guilt of a defendant for murder of a law enforcement officer, the court
14	shall sentence the defendant to death. A law enforcement officer includes a federal,
15	State, or local law enforcement officer."
16	Sec. 2. G.S. 15A-2000(e)(8) reads as rewritten:
17	"(8) The capital felony was committed against a law-enforcement officer, an
18	employee of the Department of Correction, or a jailer, fireman, judge
19	or justice, former judge or justice, prosecutor or former prosecutor,
20	juror or former juror, or witness or former witness against the
21	defendant, while engaged in the performance of his official duties or
22	because of the exercise of his official duty."
23	Sec. 3. This act becomes effective July 1, 1994, and applies to offenses
24	committed on or after that date.
