1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE PARENTAL OR JUDICIAL CONSENT FOR AN
3	UNEMANCIPATED MINOR'S ABORTION.
4	The General Assembly of North Carolina enacts:
5	Section 1. Article 1A of Chapter 90 of the General Statutes is amended by
6	designating all the existing language as "Part 1.", and by adding a new Part to read:
7	"PART 2. PARENTAL OR JUDICIAL CONSENT FOR ABORTION.
8	" <u>§ 90-21.6. Definitions.</u>
9	For the purposes of Part 2 only of this Article, unless the context clearly requires
10	otherwise:
11	(1) <u>'Unemancipated minor' or 'minor' means any person under the age of 18</u>
12	who has not been married or has not been emancipated pursuant to
13	Article 56 of Chapter 7A of the General Statutes.
14	(2) <u>'Abortion' means the use or prescription of any instrument, medicine,</u>
15	drug, or any other substance or device with intent to terminate the
16	pregnancy of a woman known to be pregnant, for reasons other than to

1	save the life or preserve the health of an unborn child, to remove a dead
2	unborn child, or to deliver an unborn child prematurely, by accepted
3	medical procedures in order to preserve the health of both the mother
4	and the unborn child.
5	"§ 90-21.7. Parental consent required.
6	(a) No physician licensed to practice medicine in North Carolina shall perform an
7	abortion upon an unemancipated minor unless the physician or agent thereof or another
8	physician or agent thereof first obtains the written consent of the minor and of:
9	(1) <u>A parent with custody of the minor; or</u>
10	(2) The legal guardian or legal custodian of the minor; or
11	(3) <u>A parent with whom the minor is living; or</u>
12	(4) A grandparent with whom the minor has been living for at least six
13	months immediately preceding the date of the minor's written consent.
14	(b) The pregnant minor may petition, on her own behalf or by guardian ad litem,
15	the district court judge assigned to the juvenile proceedings in the district court where the
16	minor resides or where she is physically present for a waiver of the parental consent
17	requirement if:
18	(1) None of the persons from whom consent must be obtained pursuant to
19	this section is available to the physician performing the abortion or the
20	physician's agent or the referring physician or the agent thereof within a
21	reasonable time or manner; or
22	(2) All of the persons from whom consent must be obtained pursuant to this
23	section refuse to consent to the performance of an abortion; or
24	(3) The minor elects not to seek consent of the person from whom consent
25	is required.
26	" <u>§ 90-21.8. Procedure for waiver of parental consent.</u>
27	(a) The requirements and procedures under Part 2 of this Article are available and
28	apply to unemancipated minors seeking treatment in this State.
29	(b) The court shall ensure that the minor or her guardian ad litem is given
30	assistance in preparing and filing the petition and shall ensure that the minor's identity is
31	kept confidential.
32	(c) The minor may participate in proceedings in the court on her own behalf or through a guardian ad liter. The court shall advise her that she has a right to court
33	through a guardian ad litem. The court shall advise her that she has a right to court
34 35	appointed counsel and shall provide her with counsel upon her request.
35 36	(d) <u>Court proceedings under this section shall be confidential and shall be given</u>
30 37	precedence over other pending matters necessary to ensure that the court may reach a decision promptly. In no case shall the court fail to rule within seven days of the time of
38	filing the application. This time limitation may be extended at the request of the minor.
39	At the hearing, the court shall hear evidence relating to the emotional development,
40	maturity, intellect, and understanding of the minor; the nature, possible consequences,
41	and alternatives to the abortion; and any other evidence that the court may find useful in
42	determining whether the parental consent requirement shall be waived.

3	proceeding involving consent for an abortion on an unemancipated minor under Article
4	1A, Part 2 of Chapter 90 of the General Statutes is not a matter of public record, shall be
5	maintained separately from any juvenile record, shall be withheld from public inspection,
6	and may be examined only by order of the court, by the unemancipated minor, or by the
7	unemancipated minor's attorney or guardian ad litem."
8	Sec. 5. Notwithstanding any other State or local law to the contrary, no State
9	or local government agency or entity shall deny eligibility for financial assistance under
10	Aid to Families with Dependent Children to any infant or child on the basis that the
11	mother of the infant or child was an unemancipated minor when the infant or child was
12	born.
13	Sec. 6. This act becomes effective October 1, 1995.
