4	The General Assembly of North Carolina enacts:
5	FOX TRAPPING SEASON
6	Section 1. (a) Notwithstanding any other provision of law relating to trapping of
7	foxes, there will be open season for taking foxes with traps of the leghold type no larger
8	than one and one-half, with coil spring and with trap chain and at least three swivels set
9	on dry land with solid anchor. No trap larger than number one and one-half coil spring
10	may be used. This season shall be from December 1 to February 15 of each year.
11	(b) No person shall place traps on the land of another without first obtaining
12	written permission from the landowner or lessee.
13	(c) There shall be no bag limit for foxes taken during the trapping season
14	established in this section.
15	(d) The Wildlife Resources Commission shall provide for the sale of foxes taken
16	lawfully pursuant to this section.
17	(e) This section applies only to Chatham County.

1	"§ 153A-22.1. Redefining residency district boundaries.
2	(a) 'Residency district' means a district in which the candidates reside and
3	represent the district, but the candidates are voted on in the primaries and general
4	elections by the qualified voters of the entire county. It includes districts established
5	either by local act or under G.S. 153A-58(3)d.
6	(b) If a county is divided into residency districts, the board of commissioners may
7	find as a fact whether there is substantial inequality of population among the districts. If
8	the board finds that there is substantial inequality of population among the districts, it
9	may by resolution redefine the residency districts to make them more nearly equal. The
10	test for compliance with this section is a reduction in the relative overall range of
11	deviation.
12	(c) No change in the boundaries of a residency district may affect the unexpired
13	term of office of a commissioner residing in the district and serving on the board on the
14	effective date of the resolution. If the terms of office of members of the board do not all
15	expire at the same time, the resolution shall state which seats are to be filled at the initial
16	election held under the resolution.
17	(d) A resolution adopted pursuant to this section shall be the basis of electing
18	persons to the board of commissioners at the first general election for members of the
19	board of commissioners occurring after the resolution's effective date, and thereafter.
20	Before any resolution may be adopted pursuant to this section, the board of
21	commissioners shall hold a public hearing on it. A notice of the public hearing shall be
22	given once a week for two successive weeks in a newspaper having general circulation in
23	the county. The notice shall be published for the first time not less than 10 days nor more
24	than 20 days before the date fixed for hearing. In computing the period of time, the day
25	of publication shall not be included but the day of the hearing shall be included. A
26	resolution becomes effective upon its adoption, unless it is adopted during the period
27	beginning 150 days before the day of a primary and ending on the day of the next
28	succeeding general election for membership on the board of commissioners, in which
29	case it becomes effective on the first day after the end of the period.
30	(e) Not later than 10 days after the day on which a resolution becomes effective,
31	the clerk shall file in the Secretary of State's office, in the office of the register of deeds
32	of the county, and with the chairman of the county board of elections, a certified copy of
33	the resolution.
