Sec. 2. G.S. 130A-335(f) reads as rewritten:

"(f) The rules of the Commission and the rules of the local board of health shall 11 12 classify systems of wastewater collection, treatment and disposal according to size, type of treatment and any other appropriate factors. The rules shall provide construction 13 14 requirements, including pretreatment and system control requirements, standards for 15 operation, maintenance, monitoring, reporting, and ownership requirements for each classification of systems of wastewater collection, treatment and disposal in order to 16 17 prevent, as far as reasonably possible, any contamination of the land, groundwater and 18 surface waters. The Department and local health departments may impose conditions on the issuance of permits and may revoke the permits for failure of the system to satisfy the 19 20 conditions, the rules or this Article. The permits-Permits other than improvement permits 21 shall be valid for a period prescribed by the rules, except that improvement-rule. Improvement permits shall be valid without expiration-upon a showing satisfactory to the 22 23 Department or the local health department that the site and soil conditions are unaltered. 24 that the facility, design wastewater flow, and wastewater characteristics are not increased, and that a wastewater system can be installed that meets the permitting requirements in 25 effect on the date the improvement permit was issued. Improvement permits for which a 26 27 plat is provided shall be valid without expiration. Improvement permits for which a site plan is provided shall be valid for five years. A statement shall be displayed prominently 28 29 on both the application form for the permit and the permit that states that the permit is subject to revocation if site plans or the intended use change." 30

'Wastewater' means any sewage or industrial process wastewater

discharged, transmitted, or collected from a residence, place of business,

'Wastewater system' means a system of wastewater collection,

treatment, and disposal in single or multiple components, including a

privy, septic tank system, public or community wastewater system,

wastewater reuse or recycle system, mechanical or biological wastewater treatment system, any other similar system, and any

place of public assembly, or other places into a wastewater system.

Sec. 3. G.S. 130A-336(a) reads as rewritten:

32 Any proposed site for a residence, place of business, or place of public "(a) 33 assembly in an area not served by an approved wastewater system shall be evaluated by the local health department in accordance with rules adopted pursuant to this Article. An 34 35 improvement permit shall be issued in compliance with the rules adopted pursuant to this Article-Article. An improvement permit shall include: a description of the facility the 36 proposed site is to serve; the proposed wastewater system; the design wastewater flow and 37 characteristics; a plat of the property showing the specific location of the facility, the site for the 38 39 proposed wastewater system, property lines, water supplies, surface waters; the conditions for 40 any site modifications; and any other information required by the rules of the Commission. 4 5 The improvement permit shall not be affected by change in ownership of the site for the 6 wastewater system provided both the site for the wastewater system and the facility the 7 system serves are unchanged and remain under the ownership or control of the person 8 owning the facility. No person shall commence or assist in the construction, location, or 9 relocation of a residence, place of business, or place of public assembly in an area not 10 served by an approved wastewater system unless an improvement permit and an authorization for wastewater system construction are obtained from the local health 11 12 department. This requirement shall not apply to a manufactured residence exhibited for sale or stored for later sale and intended to be located at another site after sale." 13

14 Sec. 4. This act is effective upon ratification and applies to all applications 15 filed on or after that date.
