2 AN ACT TO REDEFINE THE BOUNDARIES OF THE WEST END FIRE
3 PROTECTION DISTRICT IN MOORE COUNTY.
4 The General Assembly of North Carolina enacts:
5 Section 1. Notwithstanding G.S. 69-25.11, the boundaries of the West End
6 Fire Protection District are as follows:
7 Beginning at a point at the dead end of SR 1121 (CHICKEN PLANT RD) at North
8 Carolina Grid Coordinates: NORTHING = 1841084 and EASTING = 528340 thence

37 Sec. 2. From and after the effective date of this act, the Board of
38 Commissioners of Moore County and the taxpayers and residents of the West End Fire
39 Protection District shall have the same rights and privileges as though the territory
40 contained within the boundaries set out in Section 1 of this act had originally been
41 included in the fire protection district under Article 3A of Chapter 69 of the General
42 Statutes.

1 Sec. 3. Any area contained within the description of the West End Fire
2 Protection District set out in Section 1 of this act which had been within the boundaries of
3 the Seven Lakes Service District is removed from that service district by operation of
4 G.S. 153A-304.2.

5 Sec. 4. This act becomes effective July 1, 1995.
