9	Section 1. The appropriations made in this act are for maximum amounts
10	necessary to provide the services and accomplish the purposes described in the budget.
11	Savings shall be effected where the total amounts appropriated are not required to
12	perform these services and accomplish these purposes and, except as allowed by the
13	Executive Budget Act, or this act, the savings shall revert to the appropriate fund at the
14	end of each fiscal year.

16	TITLE OF ACT
17	Sec. 2. This act shall be known as the Current Operations Appropriations Act
18	of 1996.

20 27	Sec. 4. Of the funds appropriated to State Aid to Local School Administrative Units, the State Board of Education may use up to twenty-four million five hundred
27	thousand dollars (\$24,500,000) for the 1996-97 fiscal year to provide incentive funding
28 29	for schools with higher than projected levels of improvement in student performance, in
30	accordance with the ABC's of Public Education Program, if enacted by the General
31	Assembly. The State Board of Education may allocate up to twenty-one million dollars
32	(\$21,000,000) of these funds on a per-teacher basis for each eligible school and up to
33	three million five hundred thousand dollars (\$3,500,000) on a per-teacher assistant basis
34	for each eligible school.
