1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE CERTAIN COVERAGE FOR DIABETES IN HEALTH AND
3	ACCIDENT INSURANCE POLICIES, IN HOSPITAL OR MEDICAL SERVICES
4	PLANS, AND IN HMO PLANS.
5	The General Assembly of North Carolina enacts:
6	Section 1. Article 51 of Chapter 58 of the General Statutes is amended by
7	adding the following new section to read:
8	"§ 58-51-59A. Coverage for certain treatment for diabetes.
9	(a) Every policy or contract of accident or health insurance, and every preferred
10	provider contract, policy, or plan as defined and regulated under G.S. 58-50-50 and G.S.
11	58-50-55, that is issued, renewed, or amended on or after October 1, 1997, shall provide
12	coverage for medically appropriate and necessary equipment, supplies, and diabetes
13	outpatient self-management training and educational services used to treat diabetes, if the
14	patient's treating physician or a physician who specializes in the treatment of diabetes
15	certifies that such services are medically necessary. Diabetes outpatient self-management
16	training and educational services must be provided under the direct supervision of a
17	certified diabetes educator or a board-certified endocrinologist. Nutrition counseling
18	must be provided by a licensed dietician. The same deductibles, coinsurance, and other

1	limitations as apply to similar services covered under the policy, contract, or plan shall
2	apply to the diabetes coverage required under this section.
3	(b) The North Carolina Medical Care Commission shall adopt rules establishing
4	standards for diabetes outpatient self-management training and educational services that
5	have been accepted by the American Diabetes Association."
6	Section 2. Article 65 of Chapter 58 of the General Statutes is amended by
7	adding the following new section to read:
8	"§ 58-65-94A. Coverage for certain treatment of diabetes.
9	(a) Every insurance certificate or subscriber contract under any hospital service
10	plan or medical service plan governed by this Article and Article 66 of this Chapter, and
11	every preferred provider contract, policy, or plan as defined and regulated under G.S. 58-
12	50-50 and G.S. 58-50-55, that is issued, renewed, or amended on or after October 1,
13	1997, shall provide coverage for medically appropriate and necessary equipment,
14	supplies, and diabetes outpatient self-management training and educational services used
15	to treat diabetes, if the patient's treating physician or a physician who specializes in the
16	treatment of diabetes certifies that such services are medically necessary. Diabetes
17	outpatient self-management training and educational services must be provided under the
18	direct supervision of a certified diabetes educator or a board-certified endocrinologist.
19	Nutrition counseling must be provided by a licensed dietician. The same deductibles,
20	coinsurance, and other limitations as apply to similar services covered under the policy,
21	contract, or plan shall apply to the diabetes coverage required under this section.
22	(b) The North Carolina Medical Care Commission shall adopt rules establishing
23	standards for diabetes outpatient self-management training and educational services that
24	have been accepted by the American Diabetes Association."
25	Section 3. Article 67 of Chapter 58 of the General Statutes reads as rewritten:
26	" <u>§ 58-67-78A. Coverage for certain treatment of diabetes.</u>
27	(a) Every health care plan written by a health maintenance organization and in
28	force, issued, renewed, or amended on or after October 1, 1997, that is subject to this
29	Article, shall provide coverage for medically appropriate and necessary equipment,
30 31	supplies, and diabetes outpatient self-management training and educational services used to treat diabetes, if the patient's treating physician or a physician who specializes in the
32	treatment of diabetes certifies that such services are medically necessary. Diabetes
33	outpatient self-management training and educational services must be provided under the
33 34	direct supervision of a certified diabetes educator or a board-certified endocrinologist.
35	Nutrition counseling must be provided by a licensed dietician. The same deductibles,
36	coinsurance, and other limitations as apply to similar services covered under the policy,
37	<u>contract</u> , or plan shall apply to the diabetes coverage required under this section.
38	(b) The North Carolina Medical Care Commission shall adopt rules establishing
39	standards for diabetes outpatient self-management training and educational services that
40	have been accepted by the American Diabetes Association."
41	Section 4. Nothing in this act shall apply to specified accident, specified
42	disease, hospital indemnity, or long-term care health insurance policies.
43	Section 5. This act is effective when it becomes law.
