4	TEACHERS' AND STATE EMPLOYEES' COMPREHENSIVE MAJOR MEDICAL
5	PLAN, TO PROVIDE COVERAGE FOR RECONSTRUCTIVE BREAST
6	SURGERY RESULTING FROM MASTECTOMY.
7	The General Assembly of North Carolina enacts:
8	Section 1. Article 51 of Chapter 58 of the General Statutes is amended by
9	adding the following new section to read:

12	Section 2. Article 65 of Chapter 58 of the General Statutes is amended by
13	adding the following new section to read:
14	"§ 58-65-96. Coverage for reconstructive breast surgery following mastectomy.
15	(a) Every insurance certificate or subscriber contract under any hospital service
16	plan or medical service plan governed by this Article and Article 66 of this Chapter, and
17	every preferred provider contract, policy, or plan as defined and regulated under G.S. 58-
18	50-50 and G.S. 58-50-55, that is issued, renewed, or amended on or after January 1, 1998,
19	that provides coverage for mastectomy shall provide coverage for reconstructive breast
20	surgery resulting from a mastectomy. The coverage shall include coverage for all stages
21	and revisions of reconstructive breast surgery performed on a nondiseased breast to
22	establish symmetry when reconstructive surgery on a diseased breast is performed. The
23	same deductibles, coinsurance, and other limitations as apply to similar services covered
24	under the policy, contract, or plan shall apply to coverage for reconstructive breast
25	surgery.
26	(b) As used in this section, the following terms have the meanings indicated:
27	(1) 'Mastectomy' means the surgical removal of all or part of a breast as a
28	result of breast cancer or breast disease.
29	(2) <u>'Reconstructive breast surgery' means surgery performed as a result of a</u>
30	mastectomy to reestablish symmetry between the two breasts, and
31	includes reconstruction of the mastectomy site, creation of a new breast
32	mound, and creation of a new nipple areolar complex. 'Reconstructive
33	breast surgery' also includes augmentation mammoplasty, reduction
34	mammoplasty, and mastopexy of the nondiseased breast."
35	Section 3. Article 67 of Chapter 58 of the General Statutes is amended by
36	adding the following new section to read:
37	"§ 58-67-79. Coverage for reconstructive breast surgery following mastectomy.
38	(a) Every health care plan written by a health maintenance organization and in
39	force, issued, renewed, or amended on or after January 1, 1998, that is subject to this
40	Article and that provides coverage for mastectomy shall provide coverage for
41	reconstructive breast surgery resulting from a mastectomy. The coverage shall include
42	coverage for all stages and revisions of reconstructive breast surgery performed on a
43	nondiseased breast to establish symmetry when reconstructive surgery on a diseased

1	breast is performed. The same deductibles, coinsurance, and other limitations as apply to
2	similar services covered under the policy, contract, or plan shall apply to coverage for
3	reconstructive breast surgery.
4	(b) As used in this section, the following terms have the meanings indicated:
5	(1) <u>'Mastectomy' means the surgical removal of all or part of a breast as a</u>
6	result of breast cancer or breast disease.
7	(2) <u>'Reconstructive breast surgery' means surgery performed as a result of a</u>
8	mastectomy to reestablish symmetry between the two breasts, and
9	includes reconstruction of the mastectomy site, creation of a new breast
10	mound, and creation of a new nipple areolar complex. 'Reconstructive
11	breast surgery' also includes augmentation mammoplasty, reduction
12	mammoplasty, and mastopexy of the nondiseased breast."
13	Section 4. G.S. 58-50-155 reads as rewritten:
14	"§ 58-50-155. Standard and basic health care plan coverages.
15	(a) Notwithstanding G.S. 58-50-125(c), the standard health plan developed and
16	approved under G.S. 58-50-125 shall provide coverage for mammograms and pap smears
17	at least equal to the coverage required by G.S. 58-51-57.
18	(a1) Notwithstanding G.S. 58-50-125(c), the standard health plan developed and
19	approved under G.S. 58-50-125 shall provide coverage for prostate-specific antigen
20	(PSA) tests or equivalent tests for the presence of prostate cancer at least equal to the
21	coverage required by G.S. 58-51-58.
22	(a2) Notwithstanding G.S. 58-50-125(c), the standard health plan developed and
23	approved under G.S. 58-50-125 shall provide coverage for reconstructive breast surgery
24	resulting from a mastectomy at least equal to the coverage required by G.S. 58-51-61.
25	(b) Notwithstanding G.S. 58-50-125(c), in developing and approving the plans
26	under G.S. 58-50-125, the Committee and Commissioner shall give due consideration to
27	cost-effective and life-saving health care services and to cost-effective health care
28	providers. This section shall be effective after July 10, 1991."
29	Section 5. Effective January 1, 1998, G.S. 135-40.6(5) is amended by adding
30	the following new sub-subdivision to read:
31	" <u>h.</u> <u>Reconstructive Breast Surgery: Reconstructive breast surgery</u>
32	resulting from a mastectomy. The coverage shall include all
33	stages and revisions of reconstructive breast surgery performed
34	on a nondiseased breast to establish symmetry when
35	reconstructive surgery on a diseased breast is performed. As
36	used in this sub-subdivision, (i) 'mastectomy' means the surgical
37	removal of all or part of a breast as a result of breast cancer or
38	breast disease; (ii) 'reconstructive breast surgery' means surgery
39 40	performed as a result of a mastectomy to reestablish symmetry
40	between the two breasts, and includes reconstruction of the
41	mastectomy site, creation of a new breast mound, and creation of
42	a new nipple areolar complex. 'Reconstructive breast surgery'
43	also includes augmentation mammoplasty, reduction

1	mammoplasty, and mastopexy of the nondiseased breast.
2	Coverage described under this sub-subdivision shall not be
3	denied on the basis that the coverage is for cosmetic surgery."
4	Section 6. Nothing in this act shall apply to specified accident, specified
5	disease, hospital indemnity, or long-term care health insurance policies.
6	Section 7. This act is effective when it becomes law.
