March 15, 1999 A BILL TO BE ENTITLED 1 2 AN ACT TO REOUIRE HEALTH BENEFIT PLANS TO COVER NONFORMULARY 3 DRUGS AND DEVICES WHEN MEDICALLY NECESSARY. 4 The General Assembly of North Carolina enacts: 5 Section 1. Article 3 of Chapter 58 of the General Statutes is amended by 6 adding the following section to read: "§ 58-3-221. Access to nonformulary prescription drugs. 7 8 If an insurer maintains one or more closed or restrictive formularies for prescription drugs or devices, then the insurer shall do all of the following: 9 10 Develop the formulary or formularies in consultation with and with the (1) approval of a pharmacy and therapeutics committee, which shall include 11 participating providers who are licensed to prescribe prescription drugs 12 13 or devices. 14 <u>(2)</u> 15 16

Make available to participating providers and pharmacists the complete drugs or devices formulary or formularies maintained by the insurer including a list of the devices and prescription drugs on the formulary by major therapeutic category that specifies whether a particular drug or device is preferred over other drugs or devices.

Establish and maintain an expeditious process or procedure that allows 1 (3) 2 an enrollee to obtain, without penalty or additional cost-sharing beyond 3 that provided for in the health benefit plan, coverage for a specific nonformulary drug or device determined to be medically necessary and 4 5 appropriate by the participating physician without prior approval from 6 the insurer, after the participating physician notifies the insurer that: 7 Either (i) the formulary alternatives have been ineffective in the a. 8 treatment of the enrollee's disease or condition, or (ii) the 9 formulary alternatives cause or are reasonably expected by the 10 physician to cause a harmful or adverse clinical reaction in the enrollee: and 11 12 Either (i) the drug is prescribed in accordance with any b. applicable clinical protocol of the insurer for the prescribing of 13 14 the drug, or (ii) the drug has been approved as an exception to the 15 clinical protocol pursuant to the insurer's exception procedure. An insurer may not void a contract or refuse to renew a contract between the 16 (b) 17 insurer and a prescribing provider because the prescribing provider has prescribed a 18 medically necessary and appropriate nonformulary drug or device as provided in this 19 section. 20 As used in this section: (c) 21 (1) 'Health benefit plan' means an accident and health insurance policy or certificate; a nonprofit hospital or medical service corporation contract; 22 a health maintenance organization subscriber contract; a plan provided 23 24 by a multiple employer welfare arrangement; or a plan provided by another benefit arrangement, to the extent permitted by the Employee 25 Retirement Income Security Act of 1974, as amended, or by any waiver 26 of or other exception to that Act provided under federal law or 27 regulation. 'Health benefit plan' does not mean any plan implemented or 28 administered by the North Carolina Department of Health and Human 29 Services or the United States Department of Health and Human 30 Services, or any successor agency, or its representatives. 'Health benefit 31 32 plan' also does not mean any of the following kinds of insurance: Accident. 33 a. 34 Credit. <u>b.</u> 35 Disability income. <u>c.</u> 36 <u>d.</u> Long-term care or nursing home care. Medicare supplement. 37 <u>e.</u> <u>f.</u> 38 Specified disease. 39 <u>g.</u> Dental or vision. Coverage issued as a <u>supplement to liability insurance</u>. 40 h.

13	on the person or persons covered by the health benefit plan.
