A BILL TO BE ENTITLED

1
2 AN ACT TO PROVIDE THAT ONE MEMBER OF THE PIEDMONT TRIAD
3 AIRPORT AUTHORITY SHALL BE A RESIDENT OF GUILFORD COUNTY
4 LIVING WITHIN THREE MILES OF THE AIRPORT.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** Section 1 of Chapter 594 of the 1985 Session Laws reads as
7 rewritten:

8 "Section 1. Chapter 1078, Session Laws of 1979 (Second Session, 1980), as
9 amended, which reenacted, ratified, validated, and confirmed Chapter 98, Public-Local
10 Laws of 1941, as amended by Chapter 601, Session Laws of 1943; Chapter 137, Session
11 Laws of 1945; Chapter 1198, Session Laws of 1957; and Chapter 793, Session Laws of
12 1969, is amended:

13 (a) By rewriting the first sentence of Section 3(b) to read:

14 "(b) The Airport Authority shall consist of seven members of whom two shall be
15 resident voters of the City of High Point, two shall be resident voters of the City of
16 Greensboro, one shall be a resident voter of the City of Winston-Salem, one shall be
17 from Guilford County at large, and one shall be from Forsyth County at large. One of
18 the two members who must be resident voters of the City of High Point shall be
19 appointed by the City Council of the City of High Point and the other shall be appointed
20 by the Guilford County Board of Commissioners. One of the two members who must be
21 resident voters of the City of Greensboro shall be appointed by the City Council of the
22 City of Greensboro and the other shall be appointed by the Guilford County Board of
23 Commissioners. The member who must be a resident voter of the City of
24 Winston-Salem shall be appointed by the Board of Aldermen of the City of
25 Winston-Salem. The member who is from Guilford County at large shall be a resident
26 of Guilford County living within three miles of the boundary of the airport and shall be
27 appointed by the Guilford County Board of Commissioners after a public hearing on the

1 appointment is held and the member who is from Forsyth County at large shall be
2 appointed by the Forsyth County Board of Commissioners."

3 (b) By adding two sentences after the fifth sentence of Section 3(b) to read:

4 "The first member to be appointed by the Board of Aldermen of the City of
5 Winston-Salem shall be appointed for a term ending April 20, 1986, thereafter, the term
6 of the member appointed by the Board of Aldermen of the City of Winston-Salem shall
7 be for three years. The first member to be appointed by the Forsyth County Board of
8 Commissioners shall be appointed for a term ending April 20, 1987, thereafter, the term
9 of the member appointed by the Forsyth County Board of Commissioners shall be for
10 three years."

11 (c) The seventh sentence of Section 3(b) is amended by adding immediately after
12 the words "City Council" the words, "Board of Aldermen".

13 **SECTION 2.** The changes in the appointment procedures of the Guilford
14 County member made by Section 1 of this act apply to the next appointment of the
15 Guilford County member made by the Guilford County Board of Commissioners.

16 **SECTION 3.** This act is effective when it becomes law.
