SENATE BILL 336

A BILL TO BE ENTITLED

1 AN ACT TO MAKE IT UNLAWFUL TO FRAUDULENTLY OR
2 UNNECESSARILY OBTAIN AMBULANCE SERVICES IN CABARRUS
3 COUNTY.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 14-111.2 reads as rewritten:

7 "**§ 14-111.2. Obtaining ambulance services without intending to pay therefor –**
8 **certain named counties.**

9 Any person who with intent to defraud shall obtain ambulance services without
10 intending at the time of obtaining such services to pay, if financially able, any
11 reasonable charges therefor shall be guilty of a Class 2 misdemeanor. A determination
12 by the court that the recipient of such services has willfully failed to pay for the services
13 rendered for a period of 90 days after request for payment, and that the recipient is
14 financially able to do so, shall raise a presumption that the recipient at the time of
15 obtaining the services intended to defraud the provider of the services and did not intend
16 to pay for the services.

17 The section shall apply to Anson, Ashe, Beaufort, Cabarrus, Caldwell, Camden,
18 Caswell, Catawba, Chatham, Cherokee, Clay, Cleveland, Cumberland, Davie, Duplin,
19 Durham, Forsyth, Gaston, Graham, Guilford, Haywood, Henderson, Hoke, Hyde,
20 Iredell, Macon, Mecklenburg, Montgomery, Orange, Pasquotank, Person, Polk,
21 Randolph, Robeson, Rockingham, Scotland, Stanly, Surry, Transylvania, Union, Vance,
22 Washington, Wilkes and Yadkin Counties only."

23 **SECTION 2.** G.S. 14-111.3 reads as rewritten:

24 "**§ 14-111.3. Making unneeded ambulance request in certain counties.**

25 It shall be unlawful for any person or persons to willfully obtain or attempt to obtain
26 ambulance service that is not needed, or to make a false request or report that an
27 ambulance is needed. Every person convicted of violating this section shall be guilty of
28 a Class 3 misdemeanor.

1 This section shall apply only to the Counties of Ashe, Buncombe, Cabarrus,
2 Camden, Cherokee, Clay, Cleveland, Davie, Duplin, Durham, Graham, Greene,
3 Haywood, Hoke, Macon, Madison, Polk, Robeson, Washington, Wilkes and Yadkin."

4 **SECTION 3.** This act applies only to Cabarrus County.

5 **SECTION 4.** This act becomes effective December 1, 2001, and applies to
6 offenses committed on or after that date.
