A BILL TO BE ENTITLED

AN ACT AUTHORIZING THE TOWN OF KERNERSVILLE TO CONVEY
CERTAIN PROPERTY AT A PRIVATE SALE.

The General Assembly of North Carolina enacts:

SECTION 1. Notwithstanding Article 12 of Chapter 160A of the General Statutes, the Town of Kernersville may convey by private negotiation and sale, with or without monetary consideration, any or all of its right, title, and interest in the following described property to the Mount Gur Cemetery Association, Inc., under the terms and conditions that the Town Board of Aldermen deem appropriate:

Tract 1

Being all of that certain 1.102 acre tract of land lying in Kernersville Township, Forsyth County, North Carolina; and bounded by natural boundaries and/or lands owned by and/or in possession of persons, as follows: on the north by Reeves, Inc., on the east by Mount Gur Cemetery Association, Inc., on the south and west by Auto Spring Co., Inc., and on the west by T & A Automotive Enterprise, Inc.; said tract being particularly described by courses (according to the North Carolina Grid System) and distances according to a survey and plats prepared by the Town of Kernersville Public Works Department, dated January 12, 1984, and dated January 27, 1984, and other sources cited herein, as follows:

Commencing at North Carolina Geodetic Station and horizontal control monument "GUR"; said monument having N.C. grid coordinates of North 867,781.850 (feet) and East 1,682,156.642 (feet) as per the North American Datum of 1983; thence the following call taken from recorded plat cited as The Veterans Garden Section 2 as recorded in Plat Book 38 at Page 160 of the Forsyth County Registry; thence North 13

1 Degrees, 47 Minutes, 11 Seconds West a distance of 91.51 feet to a control corner,
2 found existing iron pipe, the northeasterly corner of T & A Automotive Enterprise, Inc.
3 (see Deed Book 1731 Page 3304 of said Registry; see also tax lot 66D of Tax Block
4 5412 of Forsyth County Tax Maps), in the southerly line of Reeves, Inc. (see Deed
5 Book 1756 Page 2445 of said Registry; see also The Garden of the Christus as recorded
6 in Plat Book 23 at Page 95 of said Registry; see also tax lot 64E of said tax block 5412),
7 and being the true point of beginning:

9 Thence with said southerly line South 89 Degrees, 29 Minutes, 20 Seconds East a
10 distance of 156.15 feet to a found existing iron pipe; thence crossing tax lot 65B of said
11 tax block 5412 (see deeds to Mount Gur Cemetery Association, Inc., as follows: Deed
12 Book 49 Page 446, Deed Book 152 Page 45, and Deed Book 273 Page 179, all of said
13 Forsyth County Registry) South 3 Degrees, 44 Minutes, 20 Seconds West a distance of
14 333.16 feet to a found existing iron pipe, the northeasterly corner of Auto Spring Co.,
15 Inc. (see Deed Book 2003 Page 1594 of said Registry; see also tax lot 310 of said tax
16 block 5412); thence with said Auto Spring Co., Inc., the following two (2) calls: (1)
17 thence North 84 Degrees, 31 Minutes, 20 Seconds West a distance of 138.0 feet to a
18 found existing iron pipe; (2) thence North 0 Degrees, 31 Minutes, 40 Seconds East,
19 crossing a found existing iron pipe, the southeasterly corner of said T&A Automotive
20 Enterprise, Inc., at 96.28 feet, and continuing with the westerly line of said T&A
21 Automotive Enterprise, Inc., another 224.40 feet, for a total distance of 320.68 feet to
22 the true point of BEGINNING said control corner and found existing iron pipe.

24 The above described 1.102 acre tract is generally known and designated as being a
25 westerly portion of tax lot 65B of Forsyth County Tax Maps as presently constituted,
26 and is sometimes referred to as the Pauper's Plot Cemetery.

30 Being all of that 0.47 acre tract of land lying in Kernersville Township, Forsyth County,
31 North Carolina; and bounded by natural boundaries and/or lands owned by and/or in
32 possession of persons as follows: on the west and north by Mount Gur Cemetery
33 Association, Inc., on the east by Grove Street, and on the south by West Bodenhamer
34 Street; said tract being particularly described by courses (according to a survey and plat
35 prepared by the Town of Kernersville Public Works Department, dated April 23, 1985,
36 to which reference is hereby made, as follows:

38 Commencing at North Carolina Geodetic Station "Grove 2", said station having North
39 Carolina Grid System coordinates of North 866,695.32 and East 1,682,524.61; thence
40 North 58 deg. 37 min. 41 sec. West a distance of 178.10' to a 1" outside diameter set
41 new iron pipe, flush, at the back of a sidewalk in the northerly margin of West
42 Bodenhamer, being the true point of beginning:

1 Thence a new line across the lands of Mount Gur Cemetery Association, Inc. (see Deed
2 Book 1023 Page 661 of the Forsyth County Registry) North 06 deg. 22 min. 20 sec.
3 East a distance of 326.83' to a 1" outside diameter set new iron pipe, flush, in the
4 southerly line of other lands of said Mount Gur Cemetery Association (see Deed Book
5 49 Page 446, Deed Book 152 Page 45, and Deed Book 273 Page 273 Page 179, all of
6 said Registry); thence with said southerly line South 61 deg. 23 min. 30 sec. East a
7 distance of 70.98' to 7/8" outside diameter found existing iron pipe, 9" high, the
8 northwesterly terminus of Grove Street; thence with the westerly line of said Grove
9 Street South 07 deg. 17 min. 31 sec. West a distance of 306.60' to the beginning of a
10 curve concave northwesterly and having a radius of 18', said beginning of curve being
11 the northeasterly corner of that easement from Mount Gur Cemetery Association, Inc.,
12 to the Town of Kernersville (see Deed Book 1287 Page 889 of said Registry); thence
13 with the northerly line of said easement the following two (2) calls: (1) thence along
14 said curve through a central angle of 119 deg. 13 min. 56 sec. (the long chord of said
15 curve bears south 67 deg. 00 min. 22 sec. West a distance of 31.06') to a point in a line
16 tangent within the northerly margin of said West Bodenhamer Street; (2) thence
17 generally following said northerly margin of West Bodenhamer Street north 54 deg. 20
18 min. 29 sec. West a distance of 38.67'; thence a new line crossing the lands of said
19 Mount Gur Cemetery Association, Inc., North 06 deg. 22 min. 20 sec. East a distance of
20 2.91' to the true point of BEGINNING said 1" outside diameter set new iron pipe, flush,
21 at the back of said sidewalk. Being that property as recorded in the Forsyth County
22 Registry Deed Book 1492, at Page 9.

33 control monument having N.C. Grid System coordinates of North 866,768,433 (feet)
34 and East 1,682,602,398 (feet) as per the North American Datum of 1983; thence North
35 67 Degrees, 23 Minutes, 35 Seconds West, 76.00 feet, to a point in the northeasterly
36 margin of, and within the right-of-way of, West Bodenhamer Street, at the cusp of a
37 curve, and being the true point of Beginning:

40 and distance of North 21 Degrees, 50 Minutes, 00 Seconds West, 17.56 feet, to a point

42 Forsyth County Registry); thence with said westerly line North 7 Degrees, 22 Minutes,
43 10 Seconds East, 341.07 feet, to a 7/8" outside diameter found existing iron pipe, flush,
44 set over a 5/8" outside diameter found existing solid iron, 14: subsurface, corner to Mt.

1 Gur Cemetery Association, Inc. (see Deed Book 49 Page 446 of said Registry; see Deed
2 Book 152 Page 45 of said Registry; see Deed Book 273 Page 179 of said Registry; see
3 also tax lot 65B of tax block 5412 of Forsyth County Tax Maps as presently
4 constituted); thence with said Mt. Gur Cemetery Association, Inc., South 89 Degrees,
5 36 Minutes, 45 Seconds West, 20.45 feet, to a 7/8" set new iron pipe, flush, the
6 northeasterly corner of now or formerly the Town of Kernersville (see Deed Book 1492
7 Page 9 of said Registry); thence with the easterly line of said now or formerly The
8 Town of Kernersville South 7 Degrees, 18 Minutes, 15 Seconds West, 306.71 feet, to a
9 7/8" outside diameter set new iron pipe, flush, at the beginning of a curve; thence 37.44
10 feet along said curve, to the right, of radius 18.00 feet, a chord bearing and distance of
11 South 67 Degrees, 00 Minutes, 35 Seconds West, 31.05 feet, to a point in said
12 northeasterly margin of, and within the right-of-way of, said West Bodenhamer Street;
13 thence within said right-of-way South 53 Degrees, 09 Minutes, 35 Seconds East, 63.48
14 feet, to the true point of Beginning.

26 control monument having N.C. Grid System coordinates of North 866,768,433 (feet)
27 and East 1,682,602,398 (feet) as per the North American Datum of 1983; thence North
28 67 Degrees, 23 Minutes, 35 Seconds West, 76.00 feet, to a point in the northeasterly
29 margin of, and within the right-of-way of, West Bodenhamer Street, at the cusp of a
30 curve, and being the true point of Beginning:

32 Thence 18.34 feet along said curve, to the right, of radius 18.00 feet, a chord bearing
33 and distance of North 21 Degrees, 50 Minutes, 00 Seconds West, 17.56 feet, to a point
34 in the westerly line of the Town of Kernersville (see Deed Book 1356 Page 1390 of the
35 Forsyth County Registry); thence with said westerly line North 7 Degrees, 22 Minutes,
36 10 Seconds East, 50.24 feet; thence a new line crossing said Grove Street South 54
37 Degrees, 15 Minutes, 00 Seconds West, 27.28 feet, to a 7/8" outside diameter set new
38 iron pipe, flush, in the easterly line of now or formerly the Town of Kernersville (see
39 Deed Book 1495 Page 9 of said Registry) at the beginning of a curve; thence 37.44 feet
40 along said curve, to the right, of a radius 18.00 feet a chord bearing and distance of
41 South 67 Degrees, 00 Minutes, 35 Seconds West, 31.05 feet, to a point in said
42 northeasterly margin of, and within the right-of-way of, said West Bodenhamer Street;
43 thence within said of right-of-way South 53 Degrees, 09 Minutes, 35 Seconds East,
44 63.48 feet, to the true point of Beginning.
