A BILL TO BE ENTITLED

1 AN ACT TO APPROPRIATE FUNDS FOR COURT PERSONNEL TO SERVE THE
2 TWENTY-SIXTH JUDICIAL DISTRICT.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** There is appropriated from the General Fund to the Judicial
6 Department the sum of thirty-two thousand five hundred fifty-eight dollars (\$32,558)
7 for the 2001-2002 fiscal year and the sum of forty-three thousand five hundred fifty-one
8 dollars (\$43,551) for the 2002-2003 fiscal year to continue funding of a criminal case
9 management coordinator position in District 26.

10 **SECTION 2.** There is appropriated from the General Fund to the Judicial
11 Department the sum of thirty-two thousand five hundred fifty-eight dollars (\$32,558)
12 for the 2001-2002 fiscal year and the sum of forty-three thousand five hundred fifty-one
13 dollars (\$43,551) for the 2002-2003 fiscal year to continue funding of a special judicial
14 assistant position in District 26.

15 **SECTION 3.** There is appropriated from the General Fund to the Judicial
16 Department the sum of forty-two thousand five hundred thirty-eight dollars (\$42,538)
17 for the 2001-2002 fiscal year and the sum of fifty-four thousand nine hundred fifteen
18 dollars (\$54,915) for the 2002-2003 fiscal year to establish a permanent coordinator
19 position for the SelfServe Center, which provides legal assistance to persons who do not
20 have the financial resources to hire legal counsel or choose to represent themselves,
21 primarily in family law matters.

22 **SECTION 4.** There is appropriated from the General Fund to the Judicial
23 Department the sum of twenty-one thousand two hundred ten dollars (\$21,210) for the
24 2001-2002 fiscal year and the sum of sixteen thousand five hundred dollars (\$16,500)
25 for the 2002-2003 fiscal year to establish an additional part-time jury coordinator
26 position in District 26.

27 **SECTION 5.** There is appropriated from the General Fund to the Judicial
28 Department the sum of thirty-two thousand eight hundred ninety-four dollars (\$32,894)

1 for the 2001-2002 fiscal year and the sum of twenty-eight thousand two hundred twelve
2 dollars (\$28,212) for the 2002-2003 fiscal year to establish an additional part-time fine
3 collection coordinator position in District 26.

4 **SECTION 6.** There is appropriated from the General Fund to the Judicial
5 Department the sum of fifty-four thousand twenty-nine dollars (\$54,029) for the
6 2001-2002 fiscal year and the sum of forty-nine thousand five hundred fifty dollars
7 (\$49,550) for the 2002-2003 fiscal year to establish a foreign language
8 interpreter/coordinator position in District 26.

9 **SECTION 7.** This act becomes effective July 1, 2001.
