3	(2) Prepares a memorandum setting forth the local board's reasons for
4	releasing the records or permitting the inspection of the files. This
5	memorandum shall be retained in the files of the superintendent and
6	shall be a public record.
7	(c) As used in this section, a volunteer is a person who provides services to a
8	local board of education without expectation of compensation and with the
9	understanding that the local board of education is under no obligation to continue
10	accepting those services or to compensate the volunteer for them.
11	(d) This section shall not be construed to require a local school administrative
12	unit to maintain records on volunteers, former volunteers, or persons applying to be
13	volunteers, except where there is evidence of volunteer misconduct."
14	<b>SECTION 2.</b> This act is effective when it becomes law.
