A BILL TO BE ENTITLED

1 AN ACT TO AUTHORIZE GASTON COUNTY TO LEVY A TEMPORARY HALF
2 CENT LOCAL SALES TAX FOR ECONOMIC DEVELOPMENT AND
3 TOURISM PROJECTS, IF APPROVED BY THE VOTERS OF THE COUNTY.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** Levy. – If the majority of those voting in a special election
7 held pursuant to this act vote for the levy of the taxes, the board of commissioners of
8 Gaston County may, by resolution, levy one-half percent (1/2%) local sales and use
9 taxes in addition to any other State and local sales and use taxes levied pursuant to law.

10 **SECTION 2.** Vote. – The board of commissioners of Gaston County may
11 direct the county board of elections to conduct a special election on the question of
12 whether to levy local one-half percent (1/2%) sales and use taxes in the county as
13 provided in this Article. The election must be held on November 2, 2004, and must be
14 held in accordance with the procedures of G.S. 163-287.

15 **SECTION 3.** Ballot Question. – The question to be presented on a ballot for
16 a special election concerning the levy of the taxes authorized by this act must be in the
17 following form:

18 FOR AGAINST

19 One half percent (1/2%) temporary local sales and use taxes, in addition to
20 the current local sales and use taxes, to be used only for economic development projects
21 and tourism projects."

22 **SECTION 4.** Administration. – Except as provided in this act, the adoption,
23 levy, collection, administration, and repeal of the additional taxes authorized by this act
24 must be in accordance with Article 39 of Chapter 105 of the General Statutes. A tax
25 levied under this act does not apply to the sales price of food that is exempt from tax
26 pursuant to G.S. 105-164.13B.

1 A tax levied under this act does not apply to construction materials purchased
 2 to fulfill a lump-sum or unit price contract entered into or awarded before the effective
 3 date of the levy or entered into or awarded pursuant to a bid made before the effective
 4 date of the levy when the construction materials would otherwise be subject to this tax.

5 **SECTION 5.** Distribution. – The Secretary of Revenue must monthly
 6 distribute to Gaston County the net proceeds of the tax levied under this act. Gaston
 7 County must monthly distribute the following percentages of the net proceeds among
 8 the following municipalities. Gaston County must retain the balance of the net proceeds.

25 **SECTION 6.** Use. – A unit of local government may spend the proceeds of
 26 the tax levied under this act only for economic development projects, tourism projects,
 27 or both.

28 **SECTION 7.** Expiration. – A tax levied under this act expires eight years
 29 after the effective date of its levy. Gaston County's authorization to levy a tax under this
 30 act expires eight years after the effective date of the first tax the county levies under this
 31 act, even if the tax has not remained in effect for the entire eight-year period. Gaston
 32 County cannot extend the temporary tax unless authorized to do so by an act of the
 33 General Assembly subject to another referendum.

34 The expiration of a tax pursuant to this act does not affect the rights or
 35 liabilities of the county, a taxpayer, or another person arising under the expired tax; nor
 36 does it affect the right to any refund or credit of a tax that would otherwise have been
 37 available under the expired tax before its expiration.

38 If the Secretary receives a valid request for a refund of a tax levied under this
 39 act after the tax has expired and the net proceeds have been distributed, the Secretary
 40 must draw the refund from Gaston County's share of the net proceeds of the tax it levies
 41 under Article 39 of this Chapter.

SECTION 8. This act is effective when it becomes law.
