A BILL TO BE ENTITLED

AN ACT TO DELAY THE EFFECTIVE DATE OF THE INTERPRETER AND
TRANSLITERATOR LICENSURE ACT.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 90D-5(b) reads as rewritten:

"(b) Composition and Terms. – The Board shall consist of nine members who shall serve staggered terms. The initial Board members shall be selected on or before ~~January 1, 2003,~~ July 1, 2003, as follows:

- (1) A member of the North Carolina Association of the Deaf (NCAD) who is deaf and familiar with the interpreting process. This member shall be appointed by the Governor and serve for a term of two years.
- (2) An interpreter who is a member of the North Carolina Registry of Interpreters for the Deaf, Inc., (NCRID) with five years experience in a community setting and who is licensed to practice as an interpreter or transliterator under this Chapter. This member shall be appointed by the Governor and serve for a term of three years.
- (3) An employee of the North Carolina Department of Health and Human Services. This member shall be appointed by the Governor, upon recommendation of the Secretary of the Department, and serve a term of three years.
- (4) An interpreter or transliterator for deaf-blind individuals who is licensed to practice as an interpreter or transliterator under this Chapter or a deaf-blind individual who is a member of the North Carolina Deaf-Blind Association and who has knowledge of the interpreting process. This member shall be appointed by the General Assembly, upon recommendation of the President Pro Tempore of the Senate, and serve for a term of three years.

- 1 (5) A cued speech or oral transliterator licensed to practice as an
2 interpreter or transliterator under this Chapter. This member shall be
3 appointed by the General Assembly, upon recommendation of the
4 President Pro Tempore of the Senate, and serve for a term of two
5 years.
- 6 (6) A member of Self Help for Hard of Hearing (SHHH) with knowledge
7 of the interpreting process and deafness. This member shall be
8 appointed by the General Assembly, upon recommendation of the
9 President Pro Tempore of the Senate, and serve for a term of three
10 years.
- 11 (7) An interpreter who is a member of the North Carolina Registry of
12 Interpreters for the Deaf, Inc., (NCRID) with five years experience in
13 an educational setting in grades K-12 and who is licensed to practice
14 as an interpreter or transliterator under this Chapter. This member shall
15 be appointed by the General Assembly, upon recommendation of the
16 Speaker of the House of Representatives, and serve for a term of two
17 years.
- 18 (8) A faculty member of an Interpreter Training Program (ITP), an
19 Interpreter Preparation Program (IPP), or a qualified or professional
20 certified instructor of the American Sign Language Teachers
21 Association (ASLTA). This member shall be appointed by the General
22 Assembly, upon recommendation of the Speaker of the House of
23 Representatives, and serve for a term of two years.
- 24 (9) A public member. This member shall be appointed by the General
25 Assembly, upon recommendation of the Speaker of the House of
26 Representatives, and serve a term of two years. For purposes of this
27 section, a public member shall not be licensed under this Chapter or
28 have an immediate family member who is deaf or hard-of-hearing.

29 Upon the expiration of the terms of the initial Board members, each member shall be
30 appointed for a term of three years and shall serve until a successor is appointed and
31 qualified. No member may serve more than two consecutive full terms."

32 **SECTION 2.** Section 7 of S.L. 2002-182 reads as rewritten:

33 "**SECTION 7.** A person practicing interpreter or transliterator services on the
34 effective date of this act who submits the following evidence to the Board and pays the
35 required fee ~~within 18 months of the effective date of this act,~~ on or before December
36 31, 2004, shall be licensed without having to satisfy the requirements of subdivision
37 (a)(3) of G.S. 90D-7 as enacted in Section 1 of this act:

- 38 (1) Evidence that the person meets the qualifications in subdivisions (a)(1)
39 and (a)(2) of G.S. 90D-7.
- 40 (2) Evidence that the person has been actively engaged as an interpreter or
41 transliterator in this State for at least 200 hours for each of the two
42 years immediately preceding the effective date of this act. The
43 evidence must be verified in writing by sources approved by the
44 Board.

- 1 (3) Two letters of recommendation from sources approved by the Board.
2 (4) A fee of seventy-five dollars (\$75.00) for the registration. This fee
3 shall be in lieu of the fee for a license authorized in G.S. 90D-10 of the
4 act.

5 A person who obtains a license by meeting the requirements of this section must comply
6 with the continuing education requirements set by the Board. Any practicing person
7 who does not register with the Board ~~within 18 months of the effective date of this act~~
8 on or before December 31, 2004, shall be required to complete all requirements
9 prescribed by the Board and to otherwise comply with the provisions of Chapter 90D,
10 enacted by Section 1 of this act."

11 **SECTION 3.** Section 10 of S.L. 2002-182 reads as rewritten:

12 **"SECTION 10.** G.S. 90D-5 and G.S. 90D-6, as enacted in Section 1 of this act, and
13 Sections 7, 8, 9, and 10 of this act are effective when the act becomes law. The
14 remainder of the act becomes effective ~~July 1, 2003~~ January 1, 2004."

15 **SECTION 4.** Notwithstanding G.S. 150B-21.1(a)(1), the North Carolina
16 Interpreter and Transliterator Licensing Board may adopt temporary rules to implement
17 S.L. 2002-182 until January 1, 2004.

18 **SECTION 5.** Sections 1 through 3 of this act become effective October 31,
19 2002. The remainder of this act is effective when it becomes law.
