A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DEPARTMENT OF JUSTICE TO PROVIDE CRIMINAL RECORD CHECKS TO THE RESPIRATORY CARE BOARD FOR APPLICANTS FOR LICENSURE AND TO CHARGE A FEE FOR CONDUCTING THE CHECKS.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 90-652 reads as rewritten:

"§ 90-652. Powers and duties of the Board.

The Board shall have the power and duty to:

Determine the qualifications and fitness of applicants for licensure, (1) renewal of licensure, and reciprocal licensure. The Board shall, in its discretion, investigate the background of an applicant to determine the applicant's qualifications with due regard given to the applicant's competency, honesty, truthfulness, and integrity. The Department of Justice may provide a criminal record check to the Board for a person who has applied for a license through the Board. The Board shall provide to the Department of Justice, along with the request, the fingerprints of the applicant, any additional information required by the Department of Justice, and a form signed by the applicant consenting to the check of the criminal record and to the use of the fingerprints and other identifying information required by the State or national repositories. The applicant's fingerprints shall be forwarded to the State Bureau of Investigation for a search of the State's criminal history record file, and the State Bureau of Investigation shall forward a set of the fingerprints to the Federal Bureau of Investigation for a national criminal history check. The Board shall keep all information pursuant to this subdivision privileged, in accordance with applicable State law and federal guidelines, and the information shall be confidential and shall not be a public record under Chapter 132 of the

3		Justice for expenses associated with conducting the criminal history
4		record check.
5	(2)	Establish and adopt rules necessary to conduct its business, carry out
6	. ,	its duties, and administer this Article.
7	(3)	Adopt and publish a code of ethics.
8	(4)	Deny, issue, suspend, revoke, and renew licenses in accordance with
9	,	this Article.
10	(5)	Conduct investigations, subpoena individuals and records, and do all
11	,	other things necessary and proper to discipline persons licensed under
12		this Article and to enforce this Article.
13	(6)	Employ professional, clerical, investigative, or special personnel
14		necessary to carry out the provisions of this Article and purchase or
15		rent office space, equipment, and supplies.
16	(7)	Adopt a seal by which it shall authenticate its proceedings, official
17		records, and licenses.
18	(8)	Conduct administrative hearings in accordance with Article 3A of
19		Chapter 150B of the General Statutes.
20	(9)	Establish certain reasonable fees as authorized by this Article for
21		applications for examination, licensure, provisional licensure, renewal
22		of licensure, and other services provided by the Board.
23	(10)	Submit an annual report to the North Carolina Medical Board, the
24		North Carolina Hospital Association, the North Carolina Society of
25		Respiratory Care, the Governor, and the General Assembly of all the
26		Board's official actions during the preceding year, together with any
27		recommendations and findings regarding improvements of the practice
28		of respiratory care.
29	(11)	Publish and make available upon request the licensure standards
30		prescribed under this Article and all rules adopted pursuant to this
31		Article.
32	(12)	Request and receive the assistance of State educational institutions or
33		other State agencies.
34	(13)	Establish and approve continuing education requirements for persons
35		seeking licensure under this Article."

SECTION 2. This act is effective when it becomes law.
