3 COASTAL CONSERVATION ASSOCIATION SPECIAL REGISTRATION
4 PLATE.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

7 "(b) Types. – The Division shall issue the following types of special registration
8 plates:

9 ...

10 (8a) Coastal Conservation Association. – Issuable to the registered owner
11 of a motor vehicle in accordance with G.S. 81.12. The plate may bear
12 the logo and name of the Coastal Conservation Association and shall
13 be developed by the Division in consultation with the Coastal
14 Conservation Association of North Carolina. The Division may not
15 issue the plate authorized by this subdivision unless it receives at least
16 300 applications for the plate."

17 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

18 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
19 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
20 veteran, and an ex-prisoner of war. All other special registration plates, including
21 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
22 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
23 G.S. 20-88 plus an additional fee in the following amount:

3 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

4 "(b) Distribution of Fees. – The Special Registration Plate Account and the
 5 Collegiate and Cultural Attraction Plate Account are established within the Highway
 6 Fund. The Division must credit the additional fee imposed for the special registration
 7 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 8 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 9 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 10 Trust Fund, which is established under G.S. 113-44.15, as follows:

18 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:
19 "(b39) Coastal Conservation Association. – The Division must receive 300 or more
20 applications for the Coastal Conservation Association plate before the plate may be
21 developed. The Division shall transfer quarterly the money in the Collegiate and
22 Cultural Attraction Plate Account derived from the sale of the Coastal Conservation
23 Association plates to the Division of Marine Fisheries for its conservation programs."

24 **SECTION 5.** This act is effective when it becomes law.
