A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A NORTH CAROLINA TROUT UNLIMITED SPECIAL REGISTRATION PLATE.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b) reads as rewritten:

"(b) Every license plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word "commercial", unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted".

Except as otherwise provided in this subsection, a registration plate issued by the Division for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and numerals. The background of the plate shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be approved by the Division and the State Highway Patrol for clarity and ease of identification.

In God We Trust. 1 (6) 2 (7) Stock Car Racing Theme. 3 (8) NC Trout Unlimited." 4 **SECTION 2.** G.S. 20-79.4(b) is amended by adding a new subdivision to 5 read: 6 "(b) Types. – The Division shall issue the following types of special registration 7 plates: 8 9 (46a) NC Trout Unlimited. – Issuable to the registered owner of a motor 10 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase "Back the Brookie" used by NC Trout Unlimited and an image 11 12 that depicts a North Carolina Brook Trout." **SECTION 3.** G.S. 20-79.4(b) is amended by renumbering subdivision (46a) 13 14 to read: 15 "(b) Types. – The Division shall issue the following types of special registration 16 plates: 17 18 (46a)(46i) U.S. Navy Specialty. – Issuable to a veteran of the United States 19 Navy Submariner Service. The plate shall bear the phrase "Silent 20 Service Veteran" and shall bear a representation of the Submarine 21 Service Qualification pin. The Division may not issue the plate 22 authorized by this subdivision unless it receives at least 300 23 applications for the plate." 24 **SECTION 4.** G.S. 20-79.7(a) reads as rewritten: 25 Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled 26 27 veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of 28 29 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or 30 G.S. 20-88 plus an additional fee in the following amount: 21

The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation

Trust Fund, which is established under G.S. 113-44.15, as follows: 44

SECTION 5. G.S. 20-81.12 is amended by adding a new subsection to read:

"(b31) NC Trout Unlimited. – The Division must receive 300 or more applications for a NC Trout Unlimited plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of NC Trout Unlimited plates to North Carolina Trout Unlimited for its programs."

SECTION 6. Chapter 145 of the General Statutes is amended by adding a new section to read:

"§ 145-22. State freshwater fish.

The Brook Trout is adopted as the official freshwater fish of the State of North Carolina."

SECTION 7. This act is effective when it becomes law.
