## HOUSE BILL 642

Short Title: Study/Use of Social Services Statewide. (Public) Sponsors: Representative Miller. Referred to: Science and Technology, if favorable, Appropriations Subcommittee on Health and Human Services. March 15, 2005 A BILL TO BE ENTITLED AN ACT TO ESTABLISH A COMMISSION TO STUDY THE TRACKING OF PERSONS USING SOCIAL SERVICES IN THIS STATE. The General Assembly of North Carolina enacts: **SECTION 1.(a)** Commission Established. - There is established a Legislative Study Commission on the Use of Social Services. SECTION 1.(b) Membership. – The Commission shall consist of eight members as follows: Four members of the House of Representatives appointed by the (1)Speaker of the House of Representatives. Four members of the Senate appointed by the President Pro Tempore (2)of the Senate. **SECTION 1.(c)** Duties of the Commission. – The Commission shall study the tracking of persons using social services in this State at the city, county, and State level, such as those programs created under G.S. 108A-25. In conducting the study, the Commission shall: (1)Review how persons using social services are currently tracked. Consider the feasibility of improving IT systems to better track (2)persons using social services in this State. (3) Consider the cost of establishing and maintaining an improved IT tracking system. All city, county, and State departments and agencies shall cooperate with the Commission and, upon request, furnish to the Commission and its staff any information in their possession or available to them. **SECTION 1.(d)** Vacancies. – A vacancy shall be filled by the officer who made the original appointment.

27 **SECTION 1.(e)** Cochairs. – The Speaker of the House of Representatives 28 and the President Pro Tempore of the Senate shall designate cochairs of the

Commission from among their respective appointees. The Commission shall meet upon 1 2 the call of the cochairs. A quorum of the Commission shall be four members. 3 **SECTION 1.(f)** Expenses of Members. – Members of the Commission shall 4 receive per diem, subsistence, and travel allowances in accordance with G.S. 120-3.1, 5 138-5, or 138-6, as appropriate. 6 **SECTION 1.(g)** Staff. – The Legislative Services Commission, through the 7 Legislative Services Officer, shall assign professional staff to assist the Commission in 8 its work. The House of Representatives' and the Senate's Supervisors of Clerks shall assign clerical staff to the Commission, and the expenses related to the clerical 9 10 employees shall be borne by the Commission. SECTION 1.(h) Consultants. – The Commission may employ consultants to 11 12 assist with the study as provided in G.S. 120-32.02. Before expending any funds for a 13 consultant, the Commission shall report to the Joint Legislative Commission on 14 Governmental Operations on the consultant selected, the work products to be provided 15 by the consultant, and the cost of the contract, including an itemization of the cost 16 components. 17 **SECTION 1.(i)** Meetings During Legislative Session. – The Commission 18 may meet during a regular or extra session of the General Assembly, subject to approval 19 of the Speaker of the House of Representatives and the President Pro Tempore of the 20 Senate. 21 SECTION 1.(j) Meeting Location. - Subject to the approval of the 22 Legislative Services Commission, the Commission may meet in the State Legislative 23 Building or the Legislative Office Building. 24 **SECTION 1.(k)** Report. – The Commission shall submit a final report of its 25 findings and recommendations to the 2005 General Assembly no later than April 1, 2006. Upon the filing of its final report, the Commission shall terminate. 26 27 Funds. - Of the funds appropriated to the General SECTION 1.(I) Assembly, the Legislative Services Commission shall allocate funds to implement the 28 29 provisions of this section. **SECTION 2.** This act is effective when it becomes law. 30
