| | ECTION 1. Chapter 144 of the General Statutes is amended by adding a |

This section shall apply to owners of property who display the flag of the United 1 2 States on their property and does not apply to common areas, easements, rights-of-way, 3 or other areas owned by others. 4 **SECTION 2.** Chapter 144 of the General Statutes is amended by adding a 5 new section to read: 6 "§ 144-7.1. Display of the American flag; public restrictions. A unit of local government shall not prohibit the flag of the United States 7 8 from being flown or displayed if the flag is flown or displayed: 9 (1) In accordance with the patriotic customs set forth in 4 U.S.C.§§ 5-10. 10 as amended, governing the display and use of the flag of the United States, and 11 12 (2) Upon private or public property with the consent of either the owner of the property or of any person having lawful control of the property. 13 14 Notwithstanding subsection (a) of this section, for the purpose of protecting 15 the public health, safety, and welfare, reasonable restrictions on flag size, number of flags, location, and height of flagpoles are not prohibited provided that such restrictions 16 17 shall not discriminate against the flag in any manner." 18 **SECTION 3.** The title of Chapter 144 of the General Statutes reads as 19 rewritten: 20 "State Flag, American Flag, Motto-Motto, And Colors." **SECTION 4.** This act becomes effective October 1, 2005, but it applies to 21 the construction of instruments or ordinances adopted or registered prior to its effective 22
