1 A BILL TO BE ENTITLED

Short Title: Enrollment Funding in Cont. Budget.

AN ACT TO INCLUDE ENROLLMENT FUNDING FOR THE UNIVERSITY OF NORTH CAROLINA IN THE CONTINUATION BUDGET.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 116-11(9) reads as rewritten:

The Board of Governors shall develop, prepare and present to 6 "(9) 7 the Governor, the Advisory Budget Commission and the General Assembly a single, unified recommended budget for all 8 of public senior higher education. The recommendations shall 9 10 consist of requests in three general categories: (i) funds for the 11 continuing operation of each constituent institution, including increases in enrollments, increases in need-based financial aid, 12 and increases to accommodate internal shifts and categories of 13 14 persons served, (ii) funds for salary increases for employees exempt from the State Personnel Act and (iii) funds requested 15 16 without reference to constituent institutions, itemized as to 17 priority and covering such areas as new programs and activities, expansions of programs and activities, increases in enrollments, 18 increases to accommodate internal shifts and categories of 19 20 persons served, capital improvements, improvements in levels of operation and increases to remedy deficiencies, as well as 21 22 other areas. The function of the Advisory Budget Commission under this section applies only if the Director of the Budget 23 consults with the Commission in preparation of the budget. 24 Funds for the continuing operation of each constituent 25 b.

b. Funds for the continuing operation of each constituent institution shall be appropriated directly to the institution. Funds for salary increases for employees exempt from the State Personnel Act shall be appropriated to the Board in a lump sum for allocation to the institutions. Funds for the third category in

paragraph a of this subdivision shall be appropriated to the 1 2 Board in a lump sum for allocation to the institutions. The 3 Board shall make allocations among the institutions in accordance with the Board's schedule of priorities and any 4 5 specifications in the Current Operations Appropriations Act. 6 When both the Board and the Director of the Budget deem it to 7 be in the best interest of the State, funds in the third category 8 may be allocated, in whole or in part, for other items within the 9 list of priorities or for items not included in the list. Provided, 10 nothing herein shall be construed to allow the General Assembly, except as to capital improvements, to refer to 11 12 particular constituent institutions in any specifications as to priorities in the third category. Prior to taking any action under 13 14 this paragraph, the Director of the Budget may consult with the 15 Advisory Budget Commission. 16 The Director of the Budget may, on recommendation of the c. 17 Board, authorize transfer of appropriated funds from one 18 institution to another to provide adjustments for over or under enrollment or may make any other adjustments among 19 20 institutions that would provide for the orderly and efficient 21 operation of the institutions. Prior to taking any action under this paragraph, the Director of the Budget may consult with the 22 23 Advisory Budget Commission." 24 Repealed by Session Laws 1987, c. 795, s. 27." d. **SECTION 2.** This act becomes effective July 1, 2005.
