2 AN ACT ENCOURAGING THE PUBLIC SCHOOLS, THE COMMUNITY
3 COLLEGE SYSTEM, AND THE UNIVERSITY OF NORTH CAROLINA TO
4 OFFER AMERICAN SIGN LANGUAGE FOR CREDIT AS A MODERN
5 FOREIGN LANGUAGE.

6 Whereas, American Sign Language is a fully developed, autonomous, natural
7 language with a unique grammar, syntax, vocabulary, and cultural heritage; and

8 Whereas, the gestures, visual components, and structures of American Sign
9 Language are neither derived from English nor a simplified version of English; and

10 Whereas, American Sign Language is the predominant language most
11 commonly used by the deaf community in the United States; and

12 Whereas, there is increasing acceptance of American Sign Language as a
13 foreign language taught in the public schools in the United States; and

14 Whereas, 33 states currently have legislation recognizing American Sign
15 Language as a foreign language; and

16 Whereas, there is an increased acceptance of American Sign Language as a
17 foreign language among foreign language faculty at colleges and universities; Now,
18 therefore,

19 The General Assembly of North Carolina enacts:

20 **SECTION 1.(a)** Chapter 115C of the General Statutes is amended by adding
21 a new section to read:

22 **"§ 115C-81.3. Instruction in American Sign Language.**

23 **(a)** The State Board of Education shall encourage schools to offer American Sign
24 Language classes in high schools as a modern foreign language.

25 **(b)** The State Board of Education shall adopt and implement standards for the
26 certification of teachers of American Sign Language and shall set standards for teacher

1 preparation programs that prepare students for certification as American Sign Language
2 teachers."

3 **SECTION 1.(b)** The State Board of Education shall report to the Joint
4 Legislative Education Oversight Committee by October 1, 2007, on the implementation
5 of this section.

6 **SECTION 2.(a)** Chapter 115D-5 of the General Statutes is amended by
7 adding a new subsection to read:

8 "(r) The State Board of Community Colleges shall develop curriculum and
9 continuing education standards for courses of instruction in American Sign Language
10 and shall encourage community colleges to offer courses in American Sign Language as
11 a modern foreign language."

12 **SECTION 2.(b)** The State Board of Community Colleges shall report to the
13 Joint Legislative Education Oversight Committee by October 1, 2007, on the
14 implementation of this section.

15 **SECTION 3.(a)** G.S. 116-11 is amended by adding a new subdivision to
16 read:

17 **"§ 116-11. Powers and duties generally.**

18 The powers and duties of the Board of Governors shall include the following:

19 . . .

20 (4b) The Board of Governors shall encourage the constituent institutions to
21 offer courses in American Sign Language as a modern foreign
22 language."

23 **SECTION 3.(b)** The Board of Governors of The University of North
24 Carolina shall report to the Joint Legislative Education Oversight Committee by
25 October 1, 2007, on the implementation of this section.

26 **SECTION 4.** This act is effective when it becomes law.
