AN ACT TO APPROPRIATE FUNDS FOR TWO ADDITIONAL ASSISTANT DISTRICT ATTORNEYS AND TWO ADDITIONAL VICTIM WITNESS LEGAL ASSISTANTS FOR THE 13<sup>TH</sup> PROSECUTORIAL DISTRICT.

The General Assembly of North Carolina enacts:

**SECTION 1.** G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:
