(Public) Sponsors: Referred to: February 23, 2009 1 A BILL TO BE ENTITLED 2 AN ACT TO MAKE A TECHNICAL CORRECTION BY DELETING FROM A 1981 LAW 3 RELATING TO FILLING VACANCIES IN COUNTY BOARDS OF EDUCATION 4 ELECTED ON A PARTISAN BASIS COUNTY BOARDS OF EDUCATION THAT IN 5 FACT ARE NOT ELECTED ON A PARTISAN BASIS. 6 The General Assembly of North Carolina enacts: 7 SECTION 1. G.S. 115C-37.1 reads as rewritten: 8 "§ 115C-37.1. Vacancies in offices of county boards elected on partisan basis in certain 9 counties. 10 All vacancies in the membership of county boards of education which are elected by (a) 11 public or local act on a partisan basis shall be filled by appointment of the person, board, or 12 commission specified in the act, except that if the act specifies that appointment shall be made 13 by a party executive committee, then the appointment shall be made instead by the remaining 14 members of the board. 15 (b) If the vacating member was elected as the nominee of a political party, then the 16 person, board, or commission required to fill the vacancy shall consult with the county 17 executive committee of that party and appoint the person recommended by that party executive 18 committee, if the party executive committee makes a recommendation within 30 days of the 19 occurrence of the vacancy. 20 Whenever only the qualified voters of less than the entire county were eligible to (c) 21 vote for the member whose seat is vacant (either because the county administrative unit was 22 less than countywide or only residents of certain areas of the administrative unit could vote in 23 the general election for a district seat), the appointing authority must accept the 24 recommendation only if the county executive committee restricted voting to committee 25 members who represent precincts all or part of which were within the territory of the vacating school board member. 26 27 "(d) This section shall apply only in the following counties: Alamance, Alleghany, Avery, Beaufort, Brunswick, Buncombe, Burke, Cabarrus, Caldwell, Carteret, Cherokee, Clay, 28 29 Cleveland, Davidson, Davie, Forsyth, Graham, Guilford, Haywood, Henderson, Jackson, 30 Madison, McDowell, Mecklenburg, Moore, New Hanover, Polk, Randolph, Rockingham, Rutherford, Stanly, Stokes, Transylvania, Vance, Wake, Washington, and Yancey. and 31 32 Washington." SECTION 2. Effective December 1, 2010, G.S. 115C-37.1(d), as rewritten by 33 34 Section 1 of this act, reads as rewritten: 35 This section shall apply only in the following counties: Alleghany, Brunswick, "(d) 36 Forsyth, Graham, New Hanover, Vance, and Washington." **SECTION 3.** This act is effective when it becomes law. 37
