1 A HOUSE RESOLUTION RECOGNIZING DIABETES ALERT DAY IN NORTH
2 CAROLINA.

3 Whereas, diabetes is a chronic condition in which the level of glucose in the blood is
4 too high; and

5 Whereas, according to the Centers for Disease Control and Prevention, diabetes
6 affects 25.8 million people in the United States; and

7 Whereas, seven million people in the United States are unaware that they have
8 diabetes; and

9 Whereas, in 2008, the North Carolina Diabetes Prevention and Control Branch
10 estimated that over 1.1 million people in the State were pre-diabetic, diabetic, or undiagnosed
11 as pre-diabetic or diabetic; and

12 Whereas, in North Carolina, one in five adults, aged 65 and over, has diabetes or is
13 at high risk of developing diabetes; and

14 Whereas, in 2009, the North Carolina Diabetes Prevention and Control Branch
15 reported that diabetes was the seventh leading cause of death for North Carolinians; and

16 Whereas, a person with diabetes may develop severe health problems and
17 complications, including kidney disease, blindness, heart disease, stroke, amputation, and
18 nervous system disease or neuropathy; and

19 Whereas, one type of diabetic neuropathy, peripheral neuropathy causes severe and
20 intense pain that sufferers frequently describe as tingling, shooting, burning, or "pins and
21 needles"; and

22 Whereas, sixty-four percent of diabetic nerve pain sufferers report that their pain
23 interferes with the daily activities that matter to them, and eighty percent of diabetic nerve pain
24 patients report problems with mobility; and

25 Whereas, diabetic nerve pain can make it difficult to stay physically active and
26 exercise, a critical component of diabetes management, which may contribute to worsening
27 glycemic control and make sufferers more likely to develop additional health problems; and

28 Whereas, in 2010, diabetes cost the State over \$10.2 billion and, if current trends
29 continue, diabetes may cost the State over \$12.7 billion by 2015; Now, therefore,
30 Be it resolved by the House of Representatives:

31 **SECTION 1.** The House of Representatives joins the nation in recognizing March
32 22, 2011, as Diabetes Alert Day and encourages the citizens of this State to have their blood
33 sugar checked and to have their health care providers assess their plan to treat or avoid
34 diabetes.

35 **SECTION 2.** This resolution is effective upon adoption.
