11		<u>(1)</u>	Communications equipment Mobile communications systems, desktop
12			communications systems, base and repeater communications systems,
13			gateway devices, audio switch units, radio routers, microwave radios,
14			microwave antennae, Ethernet switches, wireless access points, or equivalent
15			products and attachments.
16		<u>(2)</u>	Construction equipment Excavators, wheel excavators, track loaders,
17			compact track loaders, wheel loaders, skid steer loaders, backhoe loaders,
18			crawler dozers, crawler loaders, wheel dozers, motor graders, utility cranes,
19			compactors, and appropriate attachments, or equivalent products and
20			attachments.
21		<u>(3)</u>	Forestry equipment. – Feller bunchers, knuckleboom loaders, forestry swing
22			machines, harvesters, and appropriate attachments, or equivalent products

24		<u>(4)</u>	Ground maintenance equipment. – Hand-held equipment, walk-behind
25			products, lawn tractors, lawn and garden tractors, commercial walk-behind

30		<u>(5)</u>	Multiple award schedule contract. – A contract that allows multiple vendors
31			to be awarded a State contract for goods or services by providing their total

Multiple Award Schedule Contracts Required. - The acquisition of ground (c) maintenance equipment, construction equipment, communications equipment, and forestry equipment shall be conducted using multiple award schedule contracts, except as provided in this section. Not later than August 31, 2011, the Department of Administration shall issue requests for proposals for multiple award schedule contracts for all ground maintenance equipment product categories, construction equipment product categories, communications equipment product categories, and forestry equipment product categories. Contracts awarded under this subsection shall be for a term of not less than three years with annual product and pricing update periods.

multiple vendors to compete and be awarded a contract based upon the value of their products

or services and result in competitive pricing, transparency, administrative savings, expedited

Limitation. – Any contract awarded under subsection (c) of this section shall be in (d) addition to any existing term contracts for ground maintenance equipment, construction equipment, communications equipment, and forestry equipment. Nothing in this section shall limit the ability of the Department of Administration to issue additional term contracts for the specific purchase of equipment otherwise available through a multiple award schedule contract. The Department of Crime Control and Public Safety shall not be required to purchase from contracts awarded under subsection (c) of this section for communications equipment."

SECTION 2. This act is effective when it becomes law.
