1 A JOINT RESOLUTION HONORING THE LIFE AND MEMORY OF ROBERT C. "BOB"  
2 CARPENTER, FORMER MEMBER OF THE GENERAL ASSEMBLY.

3 Whereas, Robert C. "Bob" Carpenter was born on June 18, 1924, in Macon County  
4 to Edgar Jackson Carpenter and Eula Dean Carpenter; and

5 Whereas, Bob Carpenter grew up in Macon County and graduated from Franklin  
6 High School in 1942; and

7 Whereas, Bob Carpenter earned a degree from the University of Virginia's School of  
8 Consumer Banking; and

9 Whereas, Bob Carpenter served as an Aviation Cadet in the United States Navy  
10 during World War II; and

11 Whereas, Bob Carpenter was a bank executive with the Bank of Franklin and the  
12 Bank of Asheville and was Vice President of First Union Bank, managing five branches; and

13 Whereas, Bob Carpenter represented the citizens of Senatorial District 50 with  
14 honor and distinction, providing outstanding leadership as a member of the Senate in the North  
15 Carolina General Assembly for eight terms between 1988 and 2004; and

16 Whereas, Bob Carpenter served on numerous boards, including the Macon County  
17 Board of County Commissioners; Macon County Economic Development Commission; Board  
18 of Southwestern Community College; Franklin First Union Board of Directors, as chair; and  
19 the North Carolina Association of Community College Trustees, as president; and

20 Whereas, Bob Carpenter rendered invaluable service to his community as a member  
21 of many civic, political, and youth organizations, including the Knights of Columbus,  
22 American Legion, S.A.R.S., and Rotary Club of Franklin; and

23 Whereas, Bob Carpenter was a faithful member of the Saint Francis Catholic  
24 Church in Franklin; and

25 Whereas, Bob Carpenter will be fondly remembered for his service and integrity, his  
26 devotion to his family, and his unwavering spirit in defending his beliefs; and

27 Whereas, Bob Carpenter died on August 6, 2011, at the age of 87; and

28 Whereas, Bob Carpenter is survived by his wife, T. Helen Edwards Bryant  
29 Carpenter; five children: Robert D. Carpenter, Dale R. Carpenter, Thomas Carpenter, Edgar G.  
30 Carpenter, and Christine M. Carpenter; brother, Kenneth Carpenter; and three stepdaughters:  
31 Deborah Bryant, Susan Zolo, and Rebecca Prince; Now, therefore,

32 Be it resolved by the Senate, the House of Representatives concurring:

33 **SECTION 1.** The General Assembly honors the life and memory of Robert C.  
34 "Bob" Carpenter and expresses its appreciation for his accomplishments and for the great  
35 service he gave to the State of North Carolina and the citizens of Cherokee, Clay, Graham,  
36 Haywood, Jackson, Macon, Swain, and Transylvania Counties.
