1 A BILL TO BE ENTITLED
2 AN ACT TO AUTHORIZE THE CONTINUED ISSUANCE OF SPECIAL LICENSE
3 PLATES WITH UNIQUE PLATE BACKGROUND DESIGNS, AS RECOMMENDED
4 BY THE JOINT LEGISLATIVE TRANSPORTATION OVERSIGHT COMMITTEE.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-63(b) reads as rewritten:

7 "(b) Every license plate must display the registration number assigned to the vehicle for
8 which it is issued, the name of the State of North Carolina, which may be abbreviated, and the
9 year number for which it is issued or the date of expiration. A plate issued for a commercial
10 vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word
11 "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the
12 commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for
13 vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted,"
14 unless the plate is a special registration plate authorized in G.S. 20-79.4.

15 ~~A-Except as otherwise provided in this section, a registration plate issued by the Division~~
16 ~~for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less~~
17 ~~shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight"~~
18 ~~printed at the top of the plate above all other letters and numerals. The background of the plate~~
19 ~~shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying~~
20 ~~slightly upward and to the right.~~

21 (b1) The following special registration plates do not have to be a "First in Flight" plate as
22 provided in subsection (b) of this section. The design of the plates that are not "First in Flight"
23 plates must be approved by the Division and the State Highway Patrol for clarity and ease of
24 identification. ~~When the Division registers a vehicle or renews the registration of a vehicle on~~
25 ~~or after July 1, 2015, the Division must send the owner a replacement special license plate in a~~
26 ~~standardized format in accordance with subsection (b) of this section and G.S. 20-79.4(a3).~~
