1 A BILL TO BE ENTITLED 2 AN ACT TO MAKE THE LARCENY OF VENUS FLYTRAPS IN NEW HANOVER 3 COUNTY A FELONY OFFENSE. 4 The General Assembly of North Carolina enacts: 5 **SECTION 1.** Any person who takes and carries away, or aids in taking or carrying 6 away, any Venus flytrap (Dionaea muscipula) plant or the seed of any Venus flytrap plant 7 growing upon the lands of another person with the intent to steal the Venus flytrap plant or seed 8 is guilty of a Class H felony. 9 SECTION 2. G.S. 14-129 reads as rewritten: 10 "§ 14-129. Taking, etc., of certain wild plants from land of another. 11 No person, firm or corporation shall dig up, pull up or take from the land of another or from 12 any public domain, the whole or any part of any Venus flytrap (Dionaea muscipula), trailing 13 arbutus, Aaron's Rod (Thermopsis caroliniana), Bird-foot Violet (Viola pedata), Bloodroot 14 (Sanguinaria canadensis), Blue Dogbane (Amsonia tabernaemontana), Cardinal-flower 15 (Lobelia cardinalis), Columbine (Aquilegia canadensis), Dutchman's Breeches (Dicentra cucullaria), Maidenhair Fern (Adiantum pedatum), Walking Fern (Camptosorus rhizophyllus), 16 17 Gentians (Gentiana), Ground Cedar, Running Cedar, Hepatica (Hepatica americana and 18 acutiloba), Jack-in-the-Pulpit (Arisaema triphyllum), Lily (Lilium), Lupine (Lupinus), 19 Monkshood (Aconitum uncinatum and reclinatum), May Apple (Podophyllum peltatum), 20 Orchids (all species), Pitcher Plant (Sarracenia), Shooting Star (Dodecatheon meadia), Oconee 21 Bells (Shortia galacifolia), Solomon's (Polygonatum), Seal Trailing Christmas 22 (Greens-Lycopodium), Trillium (Trillium), Virginia Bluebells (Mertensia virginica), and 23 Fringe Tree (Chionanthus virginicus), American holly, white pine, red cedar, hemlock or other coniferous trees, or any flowering dogwood, any mountain laurel, any rhododendron, or any 24 25 ground pine, or any Christmas greens, or any Judas tree, or any leucothea, or any azalea, 26 without having in his possession a permit to dig up, pull up or take such plants, signed by the 27 owner of such land, or by his duly authorized agent. Any Unless the conduct is covered under 28 some other provision of law providing greater punishment, any person convicted of violating 29 the provisions of this section shall be guilty of a Class 3 misdemeanor only punished by a fine 30 of not less than ten dollars (\$10.00) nor more than fifty dollars (\$50.00) for each offense. The provisions of this section shall not apply to the Counties of Cabarrus, Carteret, Catawba, 31 32 Cherokee, Chowan, Cumberland, Currituck, Dare, Duplin, Edgecombe, Franklin, Gaston, 33 Granville, Hertford, McDowell, Pamlico, Pender, Person, Richmond, Rockingham, Rowan and 34 Swain." 35 **SECTION 3.** This act applies only to New Hanover County.



1 **SECTION 4.** This act becomes effective December 1, 2014, and applies to 2 offenses committed on or after that date.
