1 A BILL TO BE ENTITLED  
2 AN ACT ESTABLISHING THE JOINT LEGISLATIVE OVERSIGHT COMMITTEE ON  
3 GENERAL GOVERNMENT.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Chapter 120 of the General Statutes is amended by adding a new  
6 Article to read:

7 "Article 34.

8 "Joint Legislative Oversight Committee on General Government.

9 **"§ 120-295. Creation and membership of Joint Legislative Oversight Committee on**  
10 **General Government.**

11 (a) The Joint Legislative Oversight Committee on General Government is established.  
12 The Committee consists of 12 members as follows:

13 (1) Six members of the Senate appointed by the President Pro Tempore of the  
14 Senate.

15 (2) Six members of the House of Representatives appointed by the Speaker of  
16 the House of Representatives.

17 (b) Terms on the Committee are for two years and begin on the convening of the  
18 General Assembly in each odd-numbered year. Members may complete a term of service on  
19 the Committee even if they do not seek reelection or are not reelected to the General Assembly,  
20 but resignation or removal from service in the General Assembly constitutes resignation or  
21 removal from service on the Committee.

22 (c) A member continues to serve until a successor is appointed. A vacancy shall be  
23 filled within 30 days by the officer who made the original appointment.

24 **"§ 120-296. Purpose and powers of Committee.**

25 (a) The Joint Legislative Oversight Committee on General Government shall examine  
26 on a continuing basis the services provided by the departments and agencies set out in this  
27 subsection, in order to make ongoing recommendations to the General Assembly on ways to  
28 improve the effectiveness, efficiency, and quality of State government services. The Committee  
29 has the following powers and duties:

30 (1) Study the programs, organization, operations, and policies of the following  
31 agencies:

32 a. Department of Administration.

33 b. Department of State Auditor.

34 c. Department of Cultural Resources.

35 d. Governor's Office.

36 e. Housing Finance Agency.

16                   (2)      Review compliance of budget actions directed by the General Assembly.  
17                   (3)      Monitor expenditures, deviations, and changes made by the agencies set out  
18                   in subdivision (a)(1) of this section to the certified budget.  
19                   (4)      Review policy changes as directed by law.  
20                   (5)      Receive presentations of reports from agencies directed in the law, including  
21                   audits, studies, and other reports.  
22                   (6)      Review any issues that arise during the interim period between sessions of  
23                   the General Assembly and provide a venue for any of these issues to be  
24                   heard in a public setting.  
25                   (7)      Monitor the quality of services provided by general government agencies to  
26                   other agencies and the public.  
27                   (8)      Identify opportunities for general government agencies to coordinate and  
28                   collaborate to eliminate duplicative functions.  
29                   (9)      Have presentations and reports on any other matters that the Committee  
30                   considers necessary to fulfill its mandate.  
31                   (b)      The Committee may make reports to the General Assembly. A report to the General  
32                   Assembly may contain legislation needed to implement a recommendation of the Committee.  
33                   **§ 120-297. Organization of Committee.**  
34                   (a)      The President Pro Tempore of the Senate and the Speaker of the House of  
35                   Representatives shall each designate a cochair of the Joint Legislative Oversight Committee on  
36                   General Government. The Committee shall meet upon the joint call of the cochairs.  
37                   (b)      A quorum of the Committee is five members. No action may be taken except by a  
38                   majority vote at a meeting at which a quorum is present. While in the discharge of its official  
39                   duties, the Committee has the powers of a joint committee under G.S. 120-19 and  
40                   G.S. 120-19.1 through G.S. 120-19.4.  
41                   (c)      Members of the Committee receive subsistence and travel expenses as provided in  
42                   G.S. 120-3.1. The Committee may contract for consultants or hire employees in accordance  
43                   with G.S. 120-32.02. The Legislative Services Commission, through the Legislative Services  
44                   Officer, shall assign professional staff to assist the Committee in its work. Upon the direction  
45                   of the Legislative Services Commission, the Supervisors of Clerks of the Senate and of the  
46                   House of Representatives shall assign clerical staff to the Committee. The expenses for clerical  
47                   employees shall be borne by the Committee.  
48                   (d)      The Committee cochairs may establish subcommittees for the purpose of examining  
49                   issues relating to services provided by particular divisions within the State's general  
50                   government departments.  
51                   **§ 120-298. Reports to Committee.**

1 Whenever a department or agency set out in subdivision (a)(1) of G.S. 120-296 is required  
2 by law to report to the General Assembly or to any of its permanent committees or  
3 subcommittees on matters affecting the services the department or agency provides, the  
4 department or agency shall transmit a copy of the report to the cochairs of the Joint Legislative  
5 Oversight Committee on General Government."

6 **SECTION 2.** This act is effective when it becomes law.
