Short Title: Hunting & Fishing/Active Duty Military. (Public)

Sponsors: Senator Brown (Primary Sponsor).

1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE THAT MEMBERS OF THE ARMED FORCES WHO ARE
3 SERVING ON ACTIVE MILITARY DUTY IN THE ARMED FORCES OF THE
4 UNITED STATES OUTSIDE THE STATE OF NORTH CAROLINA SHALL BE
5 CONSIDERED RESIDENTS FOR PURPOSES OF OBTAINING CERTAIN HUNTING,
6 FISHING, TRAPPING, AND SPECIAL ACTIVITY LICENSES.

7 The General Assembly of North Carolina enacts:

8 SECTION 1. G.S. 113-130 reads as rewritten:

9 "§ 113-130. Definitions relating to activities of public.

10 The following definitions and their cognates apply to activities of the public in regard to
11 marine and estuarine and wildlife resources:

12 ...
13 (4) Resident. – In the case of:

- 14 ...
15 e. Military Personnel and Their Dependents. – A member of the Armed
16 Forces of the United States stationed at a military facility in North
17 Carolina, the member's spouse, and any dependent under 18 years of
18 age residing with the member are deemed residents of the State, of
19 the county in which they live, and also, if different, of any county in
20 which the military facility is located. A member of the Armed Forces
21 of the United States on active duty outside the State of North
22 Carolina shall be deemed an individual resident of the State for
23 purposes of all the following licenses:
- 24 1. Coastal Recreational Fishing Licenses issued pursuant to
25 G.S. 113-174.2(c)(1) and (c)(4).
 - 26 2. Combination Hunting and Inland Fishing Licenses issued
27 pursuant to G.S. 113-270.1C(b)(1).
 - 28 3. Sportsman Licenses issued pursuant to G.S. 113-270.1D(a).
 - 29 4. Hunting Licenses issued pursuant to G.S. 113-270.2(c)(1) and
30 (c)(5).
 - 31 5. Special Activity Licenses issued pursuant to
32 G.S. 113-270.3(b)(1).
 - 33 6. Trapping Licenses issued pursuant to G.S. 113-270.5(b)(1).
 - 34 7. Hook-and-Line Licenses issued pursuant to
35 G.S. 113-271(d)(1), (d)(2), and (d)(6)a.
